NOTE 1 - PLAN DESCRIPTION

The following description of Pioneer Metal Finishing, LLC Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a qualified defined contribution plan covering substantially all eligible full-time employees of PMFC Holding, LLC and Subsidiaries (the "Company") who are aged 18 or older, provided the employee is a nonunion employee. Part-time employees who are aged 18 or older and obtain 1,000 hours of service are now eligible to participate in the Plan. Eligible employees enter the Plan immediately upon fulfillment of the eligibility requirements.

The Plan is administered at the direction of the Company. The investment committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions

Each year, participants may contribute to the Plan up to 100% of annual compensation, as defined in the plan document, on a pre-tax basis or after-tax basis, as designated by the employee. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto enrollment and escalation provision where all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or make an alternate deferral election. Automatically enrolled participants have their deferral rate set to 3% of eligible compensation subject to annual increases of 1% until reaching 6% unless otherwise changed by the participant.

The Company may also make discretionary contributions to the Plan. The Plan allows employees to receive a 100% match on the first 2% and 50% on the next 4% of employee contributions. The Plan also allows for a discretionary profit-sharing match contribution to be made. No profit-sharing match was made during 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution; the Company's discretionary matching contribution; and allocations of (a) the Company's discretionary profit-sharing contribution, (b) plan earnings or losses, and (c) forfeitures of terminated participants' nonvested accounts, if applicable. Participant accounts are reduced by withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future Company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, there was \$39,898 and \$15,292 of forfeited non-vested accounts, respectively. During 2024, \$70,949 of forfeitures were used to fund Company contributions and \$13,214 of forfeitures were used to fund administrative expenses for the year then ended, December 31, 2024.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. A participant can only have one loan currently outstanding from the Plan. Note terms range from one to five years or up to ten years for the purchase of a primary residence. The notes are secured by the balance in the participant's account or other security if the loan is for the purchase of a primary residence. The notes bear a fixed rate of interest determined by the plan administrator based on prevailing market conditions, which ranged from 3.25% to 8.50% for the years ended December 31, 2024 and 2023. Principal and interest are paid through payroll deductions.

Benefit Payments

Plan benefits are available at normal retirement (age 65), disability retirement, death, or termination of employment. Participants may elect to receive benefit payments in the form of a lump-sum distribution or in installments. Distributions from the voluntary contribution portion of a participant's account are also allowed in the event of a financial hardship if certain conditions are met. The Plan also allows for in-service distributions upon attaining age 59½.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value.

The collective trust fund is valued at net asset value per share ("NAV"), as provided by the trustee, and is used as a practical expedient to fair value. The NAV is based upon the fair value of the underlying investments comprising the trust, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Other investments are valued based on quoted market prices reported in active markets. See Note 8 for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or

assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Note receivable and distribution fees are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net realized and unrealized gains on investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

NOTE 3 - TERMINATION

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100% vested in their account balances.

NOTE 4 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan assets are in investment funds managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC or their affiliates. Empower Annuity Insurance Company of America and Empower Trust Company, LLC are the custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. The Plan paid administrative fees to its service providers, net of forfeitures, which totaled \$115,096 for the year ended December 31, 2024, and is included in the statement of changes in net assets available for benefits.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in

the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 6 - CERTIFIED INFORMATION

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian has certified that the following data included in the financial statements and supplementary schedule are complete and accurate:

- Investments at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary schedule.

NOTE 7 - TAX STATUS

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service ("IRS") on November 14, 2022, indicating that the Plan, as designed, is qualified for federal income tax- exempt status. The Plan has since been amended, however, the Plan Administrator believes that the Plan is qualified and that the related trust is tax-exempt as of the financial statement dates.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability nor disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - FAIR VALUE MEASUREMENTS

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

- Level 1 - Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.
- Level 2 - Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3 - Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
