NOTE 1 - DESCRIPTION OF PLAN

The following description of the Sims Crane & Equipment Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Sims Crane & Equipment Company and its participating subsidiaries, affiliates and locations (collectively, the "Company"), who have completed 60 days of service and are age 21 or older. Union employees and certain part-time employees are excluded from participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

During 2024, the Plan sponsor implemented changes to participating employers. On September 30, 2024, Sims Equipment, LLC ("SEQ"), a former affiliate, merged with Sims Crane & Equipment Co. and was subsequently dissolved. In connection with the merger, the Plan was amended to remove SEQ as a participating employer. In addition, effective December 31, 2024, the Plan was amended to remove Sims HD, LLC as a participating employer.

Contributions: Each year, participants may contribute up to the maximum amount allowed by law, as defined in the Plan and subject to certain limitations. The Plan allows employees with immediate entry into the Plan for salary deferral contributions once requirements are met. Participants age 50 or older are permitted to defer "catch-up" contributions, which are not to exceed a \$7,500 limit for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans and are permitted to make Roth deferral contributions. The Company contributes a safe harbor matching contribution equal to 100% of the first 3% of deferred compensation plus 50% of the next 2% of deferred compensation. The Company may, at its discretion, make additional employer matching contributions and profit-sharing contributions to the Plan. There were no discretionary employer matching contributions or profit-sharing contributions for the 2024 Plan year.

Participant Accounts: Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contributions, and (b) Plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are immediately vested in their contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the discretionary employer match contributions and profit-sharing contributions, plus earnings thereon, is based on years of continuous service at the rate of 20% per year beginning with the second year of service upon which participants are fully vested after six years of service.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts under \$5,000 may automatically be distributed to participants. Participants (or their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a single lump sum, substantially equal installments over a period of time not more than the participants' or beneficiaries' assumed life expectancy, or partial withdrawals. Upon meeting certain criteria specified in the Plan document, a participant may elect to receive in-service withdrawals. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan.

Excess Contributions: Refunds of excess contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and a reduction in contributions in the Plan year in which the excess contributions were made to the Plan.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions. The term of the loan must not exceed five years, except for loans used for the purchase of a primary residence. The Plan administrator may permit a longer repayment term if the loan is for the purchase of a principal residence.

Forfeitures: Participant forfeitures of discretionary employer matching contributions and profit-sharing contributions may be used to (i) reduce future employer matching and profit sharing contributions, (ii) pay administrative expenses of the Plan, or (iii) be allocated as additional employer matching contribution, as determined by the Plan Administrator in a nondiscriminatory manner.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and service provider fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, and credit. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) (the Trustee of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Sub-Accounts of Separate Accounts: The fair values of purchase units held in sub-accounts of John Hancock Life Insurance Company (U.S.A.) Separate Accounts B, C & F are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. The John Hancock Life Insurance Company (U.S.A.) Separate Accounts B, C & F are comprised of numerous sub-accounts that invest solely in shares of an underlying mutual fund, collective trust or ETF which is generally identified in the name of the sub-account and include a variety of domestic equity funds, foreign equity funds, bond funds, blended funds and money market funds. These funds are either managed by an affiliate of John Hancock Life Insurance Company (U.S.A.) or by an external independent third party. Participants direct their investments to certain underlying “sub-accounts” of the John Hancock Life Insurance Company (U.S.A.) Separate Accounts B, C & F available to them under the Plan. Each sub-account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund’s net asset value per unit.

Guaranteed Investment Contracts (Not Fully Benefit-Responsive): The Plan holds guaranteed investment contracts that are not fully benefit-responsive due to certain liquidity restriction provisions of the contracts and, accordingly, measured at fair value. Fair value is estimated on an annual basis for financial statement reporting purposes only, as participant transactions are typically executed at contract value. The fair value of the Plan’s investment in the John Hancock Life Insurance Company (U.S.A.) investment contracts has been determined to approximate contract value based upon the frequency of the re-setting of contractual interest rates to market rates, participant transactions being executed at contract value and the credit quality of the issuer (Level 3 inputs). In addition, management has determined that no adjustment from contract value is required for credit quality considerations. Contract value represents contributions made to the contracts, plus earnings, less participant withdrawals and administrative expenses. The terms of the guaranteed investment contracts and those of other investment contracts held by employee benefit plans generally prohibit the sale or transfer of the contract by the Plan. During the year ended December 31, 2024, there were purchases and sales of \$3,389 and \$2,488, respectively, of these Level 3 investments held by the Plan. There were no transfers into or out of these Level 3 investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan invests in guaranteed accounts managed by John Hancock Life Insurance Company (U.S.A.) and certain sub-accounts of the John Hancock Life Insurance Company (U.S.A.) Separate Accounts B, C & F. John Hancock Life Insurance Company (U.S.A.) is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to John Hancock Life Insurance Company (U.S.A.), qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 - TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype document adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued.
