Note 1 – Description of the Plan

The following brief description of the Hillebrand Gori USA, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

A. *General*

The Plan is a defined contribution plan qualifying under Section 401(k) of the Internal Revenue Code (“IRC”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was established for the purpose of providing eligible employees of Hillebrand Gori USA, LLC (the “Employer”) and their beneficiaries’ funds for retirement. The Plan’s sponsor until December 31, 2022 was JF Hillebrand USA, Inc. and the Plan’s name was the JF Hillebrand USA, Inc. 401(k) Plan. Effective December 31, 2022, Giorgio Gori USA, Inc. was merged with and into JF Hillebrand USA, Inc. with the latter changing name and form to Hillebrand Gori USA LLC. The Plan name was changed on January 1, 2023 to the Hillebrand Gori USA, LLC 401(k) Plan.

The 401(k) plan for Giorgio Gori USA, Inc., a related entity to the Plan sponsor, was terminated December 31, 2022. At that time, the legal entity merger with the Plan sponsor above made those former Giorgio Gori USA, Inc. employees eligible to participate in and rollover balances to the Hillebrand Gori USA, LLC 401(k) Plan on January 1, 2023.

B. *Eligibility*

Prior to April 1, 2019, employees were eligible to contribute into the Plan immediately upon attaining 21 years of age and the completion of one year of service with the Employer. After April 1, 2019, there is no minimum service requirement to enter the Plan. Participants may enter the Plan on the first day of the month following completion of the eligibility criteria.

C. *Participant Contributions*

Participants in the Plan may annually contribute through payroll deductions an amount limited to annual amounts as determined by the Internal Revenue Service and may contribute amounts representing distributions from other qualified plans. Any participant, age 50 or over, may make an additional “catch-up” contribution as determined by the Internal Revenue Service. Employees are automatically enrolled in the Plan at a deferral rate of 3%, unless they opt out or change the deferral percentage. An automatic increase shall not apply. A participant may suspend contributions at any time or may increase or decrease their level of participation on the first day of each month of the Plan year.

D. *Employer Contributions*

The Employer makes safe harbor matching contributions annually equal to 100% of elective deferral contributions that are not over 3% of pay, plus 50% of elective deferral contributions which are over 3% but are not over 5% of pay. In addition, discretionary contributions may be made for each Plan year in an amount determined by the Employer. The qualified non-elective Employer contribution is allocated to non-highly compensated employees in the ratio that each participant’s compensation bears to the total compensation of all eligible participants. The Employer may also contribute a discretionary contribution for each Plan year in an amount determined annually by the Employer and shall be allocated as of the last day of the Plan year. The Employer discretionary contributions are reduced by withdrawals, losses on investments, expenses of the Plan, and any forfeitures. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Note 1 – Description of the Plan (continued)

E. *Participant Accounts*

Individual accounts are established for each participant. The Plan offers a variety of registered investment companies, including a stable value core account, and mutual funds. Each participant's account is credited with the participant's pre-tax contributions, the Employer contributions, and the proportionate share of dividends, interest and investment gains since the preceding valuation date.

F. *Vesting*

Employees are always 100% vested in any employee deferral and safe harbor match contribution. A participant is 20 percent vested after two years of credited service and continues to vest in increments of 20 percent until 100 percent vested after six years of credited service.

A participant's "vested percentage" is based on vesting years of service. A participant earns and accumulates a year of vesting for each 12 months of continuous service in which he or she is credited with 1,000 hours of service within the Plan year. Any unvested portion of a participant's account shall be forfeited upon termination. A participant is considered 100% vested upon termination of service due to death or disability.

G. *Payment of Benefits*

Prior to the retirement age of 59-1/2 or normal retirement age, which is 65, distributions and withdrawals are not permitted from the Plan, except in the instances of death, disability, hardship, or termination of employment. A participant may choose to have their benefit distributed upon retirement at age 55. If a participant works past the normal retirement date, payment of benefits can be deferred. On termination of service due to death, disability, or retirement, a participant or his or her estate is entitled to 100% of such benefits. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or fixed payment installments for a fixed period. Hardship distributions relating to medical, tuition, and funeral expenses of a primary beneficiary and limited to the amount of the participant's elective deferral contributions are permitted by the Plan.

H. *Notes Receivable from Participants*

The Plan allows for loans to be extended to participants for financial hardship or financial needs. All loans are considered a direct investment of the participant, and payments of principal and interest are credited to the participant's account. The minimum a participant may borrow is \$1,000, and the maximum, including the outstanding balance of existing Plan loans, is 50% of their vested account balance, not to exceed \$50,000. All loans shall bear a reasonable rate of interest (as defined in the Plan agreement). As of December 31, 2024, the loans bear interest between 4.25%-9.5% with maturities between 2025-2029. Principal and interest are paid ratably through payroll deductions. Loans are to be repaid within a five year period, unless the loan proceeds are used to acquire a principal residence, in which case the loan repayment may be extended to ten years. A participant is permitted to have one loan outstanding at any time.

I. **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$2, respectively. These accounts will be used to pay plan administrative expenses. During 2024, plan administrative expenses were reduced by \$2, from forfeited nonvested accounts, in accordance with plan provisions.

Note 2 – Summary of Significant Accounting Policies

A. **Basis of Accounting**

The Financial statements of the Plan are prepared on the accrual basis of accounting.

B. **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

C. **Investment Valuation and Income Recognition**

Investments are reported at fair value except for guaranteed interest accounts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements are discussed in Note 4.

Investment contracts are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Accordingly, the statements of net assets available for benefits present the fair value of the investment contracts. The statement of net assets available for benefits is prepared on a contract value basis, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends, if applicable, are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

E. **Payment of Benefits**

Benefits are recorded when paid.

F. *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. As of December 31, 2024 and 2023, the Plan had \$203,885 and \$182,583, respectively, of outstanding loans.

G. *Subsequent Events*

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be used.

H. *Reclassifications*

Certain prior-year amounts have been reclassified to conform to the current-year presentation. These reclassifications had no effect on the Plan's net assets available for benefits or changes in net assets available for benefits.

Note 4 – Fair Value of Plan Assets

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in inactive markets
 - inputs other than quoted prices that are observable for the asset or liability
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Note 4 – Fair Value of Plan Assets (continued)

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques are designed to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Shares held in mutual funds are valued based on the market price of the shares held by the Plan at year end, which are based on the share prices quoted by the fund, representing the fair value of the underlying investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Investment Contract with Insurance Company

The Plan holds a fully benefit-responsive investment contract (insurance company/general account or Transamerica Stable Fund Account) with Transamerica Life Insurance Company (“Transamerica”), listed in the Statements of Net Assets Available for Benefits as Investments at contract value. Transamerica maintains the contributions in a general account. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contract. The contract values are determined daily based on the fair values of the underlying investments, including separate accounts under group annuity contracts and all mutual funds under NAV custodian agreements. Contract values represent contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Contract value is considered the fair value of the investment for financial reporting purposes because it represents the amount payable on demand at the reporting date. The group annuity contract held by the Plan meets the five conditions to be considered fully benefit-responsive. A Plan merger or termination would limit the Plan from transacting at contract value. Although participants generally may withdraw assets from the Stable Value Option without restrictions, plan-level transactions, such as the complete or partial discontinuance of the contract, may be subject to a hold period of up to 270 days, or in certain circumstances, up to 12 months, to allow for the orderly liquidation of assets within TLIC’s general account. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 6 – Party-In-Interest Transactions

The Plan has an investment in a stable value core account managed by the custodian of the Plan. Fees incurred by the Plan for the investment management, recordkeeping, and audit services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These transactions qualify as party-in-interest transactions. Loans to participants represent exempt party-in-interest transactions. The Plan sponsor pays directly any other fees related to the plan's operations.

Note 7 - Termination of the Plan

Although the Company has not expressed any intention to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan.

Note 8 – Tax Status

The Plan adopted a prototype non-standardized profit sharing 401(k) plan. By letter dated June 30, 2020, the Internal Revenue Service (“IRS”) has determined that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving this opinion letter. However, the Plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. In addition, there are no tax related interest or penalties for the periods presented in these financial statements.

Note 9 – Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
