We have performed audits of the accompanying financial statements of Masami Foods, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). NOTE 1 - DESCRIPTION OF THE PLAN

Masami Foods, Inc. 401(k) Profit Sharing Plan (the "Plan"), established on April 1, 1994, is a defined contribution plan that covers all eligible employees, as defined in the Plan, of Masami Foods, Inc. (the "Company"). The Company established the Plan to provide a pre-tax savings plan for employees under Section 401(k) of the Internal Revenue Code (IRC). A Company employee is eligible to participate in the Plan on the earliest quarterly entry date on which he or she has attained age 21 and one year of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participants may elect to defer from 1% to 15% of pre-tax annual compensation, as defined in the Plan, up to the maximum allowed by the IRC. The Company contributes 100% of the first 3% of compensation deferred by each participant. The Company may also make a discretionary contribution to the accounts of all participants. The Company did not make any discretionary contributions for the years ended December 31, 2024 and 2023.

Benefits are paid as a lump-sum upon termination of service, death, disability, or retirement.

A participant has the exclusive authority to direct the investment of his/her account among the investment funds available.

Participants should refer to the Plan document for a more complete description of the Plan's provisions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Pooled separate accounts are valued at net asset value per share. Such investments are not required to be recognized in the fair value hierarchy. Shares may be redeemed at any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

D. Administrative Expenses

To the extent administrative expenses are not paid by the Company, they may be paid out of the assets of the Plan.

NOTE 3 - INCOME TAX STATUS

The Plan has adopted the Lincoln Retirement Services Company 401(k) Non-Standardized Prototype, which received an opinion letter from the Internal Revenue Service stating that the Plan is in compliance with applicable sections of the IRC. Additionally, the plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts and net assets would be distributed based upon the participants' account balances at that time.

NOTE 5 - VESTING

- A. Participants' contributions, rollovers and related earnings are 100% vested at all times.
- B. Company contributions and earnings are vested as follows:

- C. Company contributions and earnings shall also become 100% vested upon:
 - (1) death;
 - (2) disability; or
 - (3) attainment of normal retirement age.

NOTE 6 - FORFEITURES

Any portion of a participant's account which is not vested shall be forfeited upon distribution of the vested portion. Forfeitures shall be used to reduce the Company's contributions. Forfeitures totaled \$1,872 at December 31, 2024. Investments as of December 31, 2024 and 2023 include \$12,518 and \$10,096, respectively, of forfeited funds available for future use.

NOTE 7 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 7 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE (Continued)

Information regarding investments held at December 31, 2024 and 2023, and investment income for the years then ended that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Lincoln Life Insurance Company ("LNLIC"), the trustee of the Plan.

NOTE 8 - NOTE RECEIVABLE FROM PARTICIPANTS

Loans are available to participants under the Plan. Loans must be at least \$1,000 and shall not exceed the lesser of 50% of the participant's vested account balance or \$50,000. Loans are to be repaid over a maximum of five years, unless used to purchase the participant's residence. Loans bear interest of one percent over the prime rate of interest charged by banks, as published in the Wall Street Journal as of the last day of the preceding calendar quarter. Only one loan shall be permitted to be outstanding at any one time.

NOTE 9 - GUARANTEED INTEREST ACCOUNTS

The Plan maintains a fully benefit-responsive group annuity contract with LNLIC through the Fixed Income Option ("Guaranteed Interest Accounts"). Contributions to the Guaranteed Interest Accounts are maintained in an insurance company general account and credited for interest and charged for participant withdrawals and administrative expenses. LNLIC is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The Guaranteed Interest Accounts meets fully benefit-responsive investment contract criteria and are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan.

The crediting rate is based on a formula established by LNLIC but may not be less than 1% percent. The crediting rate is reviewed on a monthly basis for resetting. The average credited rate for 2024 and 2023 were 2.77% and 2.54%, respectively.

The Plan's ability to receive amounts due is dependent on LNLIC's ability to meet its financial obligations. There are no reserves against contract value for credit loss. Certain events might limit the ability of the Plan to transact at contract value, including premature termination of Plan's investments in the Guaranteed Interest Accounts. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

NOTE 10 - PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by LNLIC. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 11 - RISKS AND UNCERTAINTIES

Plan investments are exposed to various risks such as interest rate, market fluctuations, and credit risk. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.
