## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Tall Brown Dog Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Tall Brown Dog Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Tall Brown Dog Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tall Brown Dog Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. ### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Tall Brown Dog Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### ***General***

The Tall Brown Dog Retirement Plan is a defined contribution plan that covers substantially all employees of Tall Brown Dog (the “Company”) who have completed 30 days of service. Union employees, nonresident aliens, highly compensated employees, and leased employees are not eligible to participate. The Plan is subject to the provisions of ERISA. Information about the plan agreement, participant investment alternatives and the vesting and benefit provisions is contained in the pamphlet Summary Plan Description. Copies of this pamphlet are available from the Personnel Office of the plan sponsor.

#### ***Contributions***

Contributions to the 401(k) Plan are elective for participants of the Plan and are in the form of pre-tax or Roth salary deferrals. The contributions range from one to one hundred percent of compensation, not to exceed current IRS imposed limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollovers to the plan from other qualified plans. The plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are automatically invested in a designated target fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and money market funds as investment options for participants. The Company provides a 50% matching contribution on the first 6 percent of eligible compensation that a participant contributes to the Plan up to \$500 per year. Participant and employer matching contributions are 100% vested at all times. Discretionary nonelective employer contributions are vested over 5 years of service. There have been no nonelective employer contributions to the Plan.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings (losses), and charged with an allocation of any administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

A participant's 401(k) account balance, made up of employee qualifying contributions, employer contributions and related investment earnings, vests immediately.

### ***Payment of Benefits***

Funds may be withdrawn from a participant's account upon the occurrence of one of the following: hardship, attainment of age 59-1/2, attainment of age for required minimum distribution, QDRO, death, total disability, or termination of employment. Upon termination of service, a participant may elect to either receive distribution of a lump-sum amount equal to the value of the participant's account, or to transfer the value of the participant's account into another qualified retirement plan.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at 1% above the prime rate, as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

### ***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions, if not already 100% vested.

### ***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Plan's sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's accounts. Investment related expenses are included in net appreciation in fair value of investments on the statements of changes in net assets available for benefits.

## NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and

changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Valuation of Investments** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants is reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

**Payment of Benefits** - Benefits are recorded when paid.

### NOTE 3 - INVESTMENTS

All information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and activity related to the notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company and Fidelity Personal Trust Company, FSB, qualified institutions.

Fidelity Management Trust Company held the investments and certified activity as of December 31, 2024 and 2023, and for the period December 15, 2023 through December 31, 2024. Fidelity Personal Trust Company, FSB certified activity for the period January 1, 2023 through December 14, 2023. To facilitate the transfer of assets from Fidelity Personal Trust Company, FSB to Fidelity

Management Trust Company, account balances were liquidated to interest bearing cash on December 14, 2023. On January 5, 2024, the Plan used the interest bearing cash to purchase assets which were automatically transferred into participant's accounts in accordance with the participant's investment options.

### NOTE 4 - INCOME TAX STATUS

The Internal Revenue Service has reviewed and approved the Non-Standardized Pre-Approved Profit Sharing Plan with CODA (upon which this plan is based) in a letter dated June 30, 2020. The Plan has been amended since receiving the letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

#### *Level 1 Fair Value Measurements*

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### *Level 2 Fair Value Measurements*

Inputs to the valuation methodology includes quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

#### *Level 3 Fair Value Measurements*

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are presented as level 1 in the fair value measurements table.

*Money market funds:* Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings, etc. The money market funds can be redeemed on a daily basis and there are no unfunded commitments. The money market funds are presented as level 2 in the fair value measurement table.

*Interest bearing cash:* Valued at cost which is fair value and is presented as level 1 in the fair value measurement table.

### NOTE 6 - RELATED PARTY TRANSACTIONS

Fidelity Workplace Services served as the Plan's record keeper for the year ended December 31, 2024. Fees paid to Fidelity Workplace Services amounted to \$12,263 for the year ended December 31, 2024. Fees paid by the Plan to Calder Investment Advisors for advisory services amounted to \$5,057 for the year ended December 31, 2024. Fees paid to Fidelity Workplace Services and Calder Investment Advisors are included in administrative expenses on the statement of changes in net assets available for benefits. Pathway Benefit Services, Inc. provided administrative services to the Plan for the year ended December 31, 2023. Fees paid by the Plan to Pathway Benefit Services, Inc. amounted to \$3,390 for the year ended December 31, 2023, which is included in administrative expenses on the statements of changes in net assets available for benefits. Other recordkeeping, custodial, and advisory fees incurred during the year ended December 31, 2023, are included in net appreciation in fair value of investments on the statements of changes in net assets available for benefits. The related transactions, noted above, qualify as exempt party-in-interest transactions.

### NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 8 - SUBSEQUENT EVENTS

Management of the Plan has evaluated subsequent events through the date of the independent auditors' report, October 15, 2025, which was the date the financial statements were available to be issued.
