Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters – Supplement Schedules Required by ERISA

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of Plan

The following description of Orion Group 401 (k) Plan (the Plan) provides only general information. Participants should refer to the Plan document agreement for a more complete description of the Plan's provisions.

Effective January 1, 2023, G.E. Mechanical, LLC 401(k) Plan was merged into the Plan with total net assets transferred in the amount of \$1,283,506.

During 2024, Marick, Inc., BME Services, LLC, Champion Industrial Contractors, Inc., Alpine Mechanical, Owens Companies, Inc., Impact Service Group, LTD, BERCO, Redblue, Bertke Electric, Aireko Services & Installation, LLC, The Tustin Group, Atlantis Services, Action Plumbing, Inc., and LA Hydrojet were merged into the Plan with total net assets transferred in the amount to \$57,337,710.

During 2024, the Plan was amended and restated with each merger described above. Each merger resulted in a Black Out period as the net assets were transferred into the Plan, which occurred at various times between January 4, 2024, and October 25, 2024. During this period, funds could not be applied to the employee-selected funds with the Trustee or withdrawn from the Plan until the Trustee had time to accurately complete the conversion. During this period, employee contributions continued to be made through payroll deductions and the contributions were deposited and held in the interest-bearing cash conversion account until the completion of the Black Out period. At the end of the Black Out period, these funds were transferred to the new Plan and invested in funds as requested by each participant.

General

The Plan is a defined contribution plan covering all employees of Orion Group Management, Inc. (the Company), who have attained the age of 21 and are not covered under a collective bargaining agreement. The Plan may make discretionary matching and profit sharing contributions for eligible employees who have attained the age of 21, with 3 months of service. Effective March 1, 2023, the Plan was amended to allow employees who have attained the age of 18 to participate in the Plan. For employee deferrals and employer contributions, the employee's entry date into the Plan is the first day of each month of the Plan year. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA) and the Internal Revenue Code (the Code). During 2024, the Plan was amended to include all eligible employees of Advanced Climate Solutions, LLC, Advanced Mechanical Services of Florida, Air Comfort Corporation, Applied Controls, LLC, Commercial Coolants, Inc. dba Design Air Systems, Jackson Mechanical Services, Inc., Texas Chiller Systems, USA Mechanical & Energy Services, LLC Retirement Plan, G.E. Mechanical, LLC, Calvert Controls, Marick, Inc., BME Services, LLC, Champion Industrial Contractors, Inc., Alpine Mechanical, Owens Companies, Inc., Impact Service Group, LTD, BERCO, Redblue, Bertke Electric, Aireko Services & Installation, LLC, The Tustin Group, Atlantis Services, Action Plumbing, Inc., and LA Hydrojet which are collectively referred to as the "Group."

Contributions

Each year, participants may contribute up to 92% of eligible compensation, as defined by the Plan up to the maximum amount permitted by the Internal Revenue Service (IRS) each calendar year, which is \$23,000 for the calendar year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 in 2024. Contributions under the Plan, along with Employer contributions under any other Employer-sponsored defined contribution plans, may not exceed the limits set by federal law of \$66,000. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also make rollover contributions which represent distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain IRS limitations.

Employer Contributions

For each eligible employee, the Company is required to make safe harbor matching contributions in an amount equal to 100% of the first 3% of their eligible compensation, and 50% of the next 2% of their eligible compensation. The Plan also allows the Company to make discretionary additional employer matching sharing contributions. For the Plan year ended December 31, 2024, no such contributions were made.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investments options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary nonelective contribution portion of their accounts, plus earnings thereon, is based on years of continuous service based on 33% each year of service beginning after one year and are 100% vested after three years of service.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant, or their beneficiary in the case of death, may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in the form of installment payments. A participant who dies while employed becomes fully vested in employer contributions.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023, and there were no defaults of repayment of participant notes receivable.

If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and benefits paid are recorded.

The minimum loan is \$1,000 and the maximum amount is the lesser of one-half of the vested account balance or \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior 12-month period. All loans from plans maintained by the Employer or a Related Employer are considered for purposes of determining the maximum amount of the loan.

All loans must bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate shall remain fixed throughout the duration of the loan. As of December 31, 2024, the interest rates on the outstanding notes receivable from participants ranged from 3.25% to 10.50%.

Forfeited Accounts

Forfeitures are created when a participant terminates his or her employment prior to attainment of full vesting. Such amounts can be used by the trustees to pay for the Plan's administrative expenses or to reduce future employer contributions, as defined in the Plan document. There was no forfeiture account balance as of December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of Plan income and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan are paid by either the Plan or the Company, as provided in the Plan document.

Note 3. Certification of Plan Trustees

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, (Fidelity), a qualified institution, has certified the following investment and notes receivable from participants information included in the accompanying financial statements and ERISA-required supplement schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by FMR LLC. This prototype plan document has been filed with the appropriate agency and has obtained a favorable opinion letter dated June 30, 2020 from the IRS stating that plan constitutes a qualified plan under section 401 of the Code and that the related trust was tax-exempt as of the financial statement date. The Plan has been amended since issuance of the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company (Fidelity). Fidelity is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Company generally pays other Plan expenses. For the year ended December 31, 2024, the amount paid to Fidelity for record-keeping was \$75,070 and amounts paid to investment advisors was \$90,996, which is included in administrative expenses on the statement of changes in net assets available for benefits.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event that the Plan and the related trust terminate, all accounts will be valued as of the termination date, participants will become 100% vested in their accounts, and the account balances will be distributed in full to participants.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits

Note 8. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value measurement of the assets or liabilities

If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan had no Level 2 or Level 3 investments at December 31, 2024 and 2023.

Note 10. Delinquent Contributions

The Company did not remit to the Plan's Trustee certain participant contributions within the time period prescribed by the Department of Labor regulations. Delays in remitting the contributions to the Trustee were due to administrative errors. During the year ended December 31, 2024, there were late employee contributions and loan repayments of \$752,701, of which \$724,455 was remitted to the Plan in 2024 and \$28,245 was remitted to the Plan in 2025. During the year ended December 31, 2023, there were late employee contributions and loan repayments of \$504,286, of which \$479,666 was remitted to the Plan in 2023 and \$24,620 was remitted to the Plan in 2024. During the year ended December 31, 2022 there were late employee contributions of \$176,819 remitted into the plan in 2023. During the year ended December 31, 2021 there were late contributions of \$87,384 remitted into the Plan in 2022. The Company has determined that the amounts to compensate for lost earnings resulting from the late payments for the years ended 2021-2023 are de minimis and they have contributed to the Plan lost earnings as an unallocated amount. The Company intends to make a similar contribution for 2024 and to file the required forms with the IRS and the Department of Labor in 2025. The Company believes the Plan continues to be qualified and tax exempt.
