The Board of Directors

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan of Agency on Aging of South Central Connecticut, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 403(b) Thrift Plan of Agency on Aging of South Central Connecticut, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTE 1 - DESCRIPTION OF PLAN

The following description of the 403(b) Thrift Plan of Agency on Aging of South Central Connecticut, Inc. (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The 403(b) Thrift Plan of Agency on Aging of South Central Connecticut, Inc. is a defined contribution plan of Agency on Aging of South Central Connecticut, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All employees of the Company, except for certain ineligible classes of employees (non-resident aliens and those eligible to make contributions to another plan of the Company) are eligible to make contributions on the first day of each pay period coinciding with or immediately following their date of hire. There is no minimum age or service requirement to make salary deferral contributions. Participants who have completed six months of eligible service are eligible for employer contributions.

Contributions

Each year, participants may contribute the maximum amount allowed under the Internal Revenue Code (IRC) of pre-tax and Roth reduction contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions).

All contributions to participant accounts are directed by the participants into the investments of their choice.

The Plan requires the employer to make matching contributions on the participants' behalf at the lesser of 100% of their salary reduction contributions or 2.5% of the participants' compensation received during the Plan year.

Participant Accounts

Each participant's account is credited with the participant's contributions, their rollover contributions from other plans and the Company's contributions as well as investment earnings (losses) within the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested immediately in all employee elective deferral contributions, their rollover contributions and all employer matching contributions, plus actual earnings thereon.

Plan Loans

Participants may request Plan loans based on the vested value of their individual accounts attributable to contributions invested in contract and custodial accounts issued by the Plan's designated provider, Mutual of America Life Insurance Company (Mutual of America). Mutual of America provides loans directly from Mutual of America funds and are not distributed from the participants' vested balances. The participants' vested balance is used to collateralize the participant loan and the funds are transferred, within the Plan assets, to the general account.

Participants may receive loans at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The interest rate on all outstanding loans at December 31, 2024 was 5.85%. Principal and interest are paid directly to Mutual of America in equal periodic payments through salary reduction. The amount of Plan assets used to collateralize the loans by Mutual of America was \$52,880 and \$41,642 at December 31, 2024 and 2023, respectively.

Plan Loans, continued

A loan will be considered in default if any scheduled repayment remains unpaid as of the end of the “cure period,” which ends on the last day of the calendar quarter following the calendar quarter in which the required repayments were due. After default occurs, if a distribution to the participant is permissible under the Plan, the vested amount of the participant’s account balance will be reduced or offset by the outstanding principal and interest of the defaulted loan. If a distribution to the participant is not allowed, the entire outstanding balance of the loan will be treated as a deemed distribution. A deemed distribution is treated as a distribution to the participant only for certain tax purposes and is not a distribution of the account. Interest continues to accrue on any defaulted loan which results in a deemed distribution, to the date of repayment. At December 31, 2024 and 2023, the Plan had no loans in default.

Hardship Withdrawals

In the event of financial hardship, as defined under the Plan and under current Internal Revenue Service regulations, participants are permitted to receive hardship withdrawals of their own elective deferrals and vested employer contributions.

Payment of Benefits

On separation of service due to death, disability, termination or retirement, a participant may receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. In the event of a participant’s death before termination of employment and before distribution of benefits has begun, a participant will become 100% vested and the amount of the participant’s account balance will be payable in a single lump-sum to the participant’s beneficiary or beneficiaries.

Participants may withdraw their vested account balances once they reach age 59½. Other distribution methods under the Plan are available to beneficiaries depending on vested account balances.

Forfeited Accounts

As all contributions were immediately and fully vested, there were no forfeited non-vested account balances in the Plan.

Investment Options

Upon enrollment in the Plan, participants may direct contributions into various pooled separate funds and an insurance company general account through Mutual of America Life Insurance Company.

Evaluation of Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value as reported by Mutual of America Life Insurance Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and Mutual of America. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's earnings and (losses) on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Expenses incurred for the administration of the Plan are the responsibility of the Plan. If incurred directly by the Plan, these expenses are included in administrative expenses on the statement of changes in net assets available for benefits. Other investment related expenses are included in net appreciation in fair value of investments.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Insurance company general account: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. The insurance company general account consists of the guaranteed interest account in the tables below.

Pooled separate accounts: The values of the pooled separate accounts are based on the fair values of the underlying investments. Net asset value is used as a practical expedient to estimate fair value. The total amount of the pooled separate accounts is included in the tables below as investments measured at net asset value.

NOTE 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of pooled separate funds managed by Mutual of America Life Insurance Company. As described in Note 1, under Plan loans, Mutual of America provides plan loans to participants, which are secured by contracts and custodial accounts issued by this provider. Mutual of America is the custodian, recordkeeper and investment manager for the Plan and receives fees from the plan sponsor and participants of the Plan and thus, qualifies as a related party and party-in-interest.

Notes receivable from participants totaled \$52,880 and \$41,642 at December 31, 2024 and 2023, respectively and interest income on notes receivable from participants totaled \$2,203 for the year ended December 31, 2024.

All of these related party and party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7 - TAX STATUS

Management believes the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Plan management has adopted Mutual of America Life Insurance Company's prototype plan, which has been approved by the Internal Revenue Service under their determination letter dated March 2, 2020. Effective March 3, 2020, the Plan had been amended for the provisions of the Bipartisan Budget Act of 2018, however all other terms of the Plan remain the same as under the Plan's previous Plan document, which Mutual of America had not applied for and received a Plan determination letter for.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

Investments of the Plan are held under an unallocated group annuity contract with Mutual of America Life Insurance Company.

Mutual of America invests the contributions in the group annuity contract in the general account, which is the fixed income portion, and pooled separate accounts, which are the variable portion in which participants may direct their contributions within various funds. The contract is included in the financial statements at fair value. The contract is included in the financial statements at fair value because management believes that it is not fully benefit-responsive. Guarantees are supported by the general account of Mutual of America. The minimum guaranteed credit rate is determined in accordance with the National Association of Insurance Commissioners (NAIC). The minimum guaranteed credited interest rate will not be less than 1% or more than 3%. At the beginning of each calendar year, Mutual of America determines the crediting interest rate by using NAIC's minimum rate formula.

NOTE 9 – RISKS AND UNCERTAINTIES

Investments and Market Conditions

The Plan participants invest in various investment options offered by the Plan. Investment options offered in the Plan are subject to various risks, such as interest rate, market value and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics, international conflicts or financial institution collapses. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 – CONCENTRATIONS OF CREDIT RISK

The Plan's financial instruments that are exposed to concentration of credit risk are investments. The Plan holds its investments in pooled separate accounts and a general account through its investment custodian, Mutual of America Life Insurance Company. The Plan has not experienced any losses, other than those losses through investment activity, and management believes its investments are not subject to significant credit risk.
