Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Topy America 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

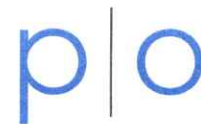

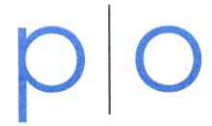

1. DESCRIPTION OF THE PLAN:

The following description of Topy America, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Reference should be made to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is sponsored by Topy America, Inc. The Plan is a defined contribution plan covering all full-time employees of Topy America, Inc. and Topy Precision Manufacturing, Inc. (collectively known as "the Company") who have met certain service and age requirements. The purpose of the Plan is to allow eligible employees to save for retirement on a tax-advantaged basis, thereby promoting future retirement security. The assets of the Plan are not commingled with Company assets. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute to the Plan a specific percentage or dollar amount of pretax annual compensation as a salary deferral, as defined by the Plan, up to the annual maximum limit established by the Internal Revenue Service. For 2024, the dollar amount is \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company will match 50% of each participant's elective deferrals up to 6% of that participant's annual compensation. Participants direct the investment of their contributions into various investment options offered by the Plan.

Each participant's account is credited with the participant's contributions, the Company's matching and discretionary contributions and an allocation of the Plan's earnings or losses. Plan earnings and losses are allocated to each participant's account based on the participant's account balance in the proportion to the total balances of all participants in the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company discretionary contributions and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF THE PLAN (Continued):

Vesting

Participants are immediately vested in their voluntary and rollover contributions, plus their actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on vesting years of service in accordance with the following schedule:

<u>Year of Service</u>	<u>Percent Vested</u>
Less than 3	0%
3 or more	100%

In the event of death, disability, or termination of the Plan, participants become fully vested in their account balance.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participants' Loans Receivable Fund. Loans must be repaid within five years, unless the loan is used to acquire a principal residence, in which case the loan may be repaid over 15 years. The loans are secured by the balance in the participant's principal account and bear a reasonable rate of interest. The Plan requires that repayments on loan obligation be made by payroll deductions. Loans in default are treated like distributions and may be subject to income and penalty taxes.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. For participants who were not fully vested in Company contributions, the non-vested portion of their employer accounts are segregated in a separate account until the participants have a period of break in service of five years or they receive a distribution of the vested portion of their accounts, if earlier. If the former participants are not re-employed by Company or an affiliated company before they have a period of break in service of five years or receive such a distribution, the non-vested portion of their employer accounts, so segregated, shall be forfeited. Any amounts forfeited shall be applied to reduce employer contributions. In-service distributions from a participant's vested account are available to participants over the age of 59½. For termination of services for other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution.

Forfeitures

Forfeitures are the nonvested amounts left in the Plan by terminating participants. Forfeitures may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. Forfeitures remaining after offset are held in a fund and used to offset future contributions. The plan administrator directs whether plan expenses are paid before either contributions are offset or forfeitures are re-allocated. During the year ended December 31, 2024, forfeitures amounted to \$54,959. At December 31, 2024 and 2023, unallocated plan assets resulting from nonvested accounts totaled \$335,959 and \$281,000, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. Upon termination of the Plan, participants become 100 percent vested in their account balances and assets will be distributed as described in the Plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Significant accounting practices and policies followed in the preparation of the accompanying financial statements are as follows:

Method of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reported period. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued):

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan has invested a portion of its assets in the Galliard Stable Return Fund J. The value of this investment is based on the underlying unit value reported by Galliard Stable Return Fund J. The Galliard Stable Return Fund J does not invest directly in fully benefit-responsive contracts, and therefore is not required to include in its financial statements the disclosure requirements for stable investment funds. See Note 4 for more information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Net Appreciation (Depreciation) in the Fair Value of Investments

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from the participants are charged directly to the participant's account and are included in the administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

3. CERTIFICATION OF FINANCIAL INFORMATION:

The following financial data included in the accompanying financial statements and supplemental schedule as of and for the years ended December 31, 2024 and 2023 has been certified as complete and accurate by Fidelity Management Trust Company, the trustee of plan assets, and has not been audited by the independent auditors for the Plan: investments at fair value, net appreciation in fair value of investments, investment income, notes receivable from participants, interest on notes receivable from participants, and the schedule of assets (held at end of year).

4. FAIR VALUE MEASUREMENTS:

Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) 820, *Fair Value Measurements and Disclosure*, ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. FAIR VALUE MEASUREMENTS (continued):

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Investments in Common/Collective Trusts: The estimated fair value of the common/collective trust funds is net asset value, exclusive of the adjustment to contract value. The use of net asset value as fair value is deemed appropriate as the collective trust funds do not have finite lives, unfunded commitments relating to these types of investments, or significant restrictions on redemptions.

Investments in Registered Investment Companies: Valued at the daily closing price as reported by the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. TAX STATUS:

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated July 3, 2002, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

6. CONCENTRATIONS:

Three investments each have an account balance over 10% of the total net assets available for benefits.

7. PARTY-IN-INTEREST TRANSACTIONS:

Parties in interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others.

All plan investments at December 31, 2024, as well as cash and cash equivalents, are maintained by the trustee, Fidelity Management Trust Company. Accordingly, these investments qualify as party-in-interest investments. Additionally, the plan's third party administrator and plan auditor would also qualify as party-in-interests.

Participants in the Plan are permitted to borrow funds from their vested balance as described in Note 1. These investments qualify as party-in-interest investments. Notes receivable from participants were \$407,439 and \$445,305 at December 31, 2024 and 2023, respectively.
