Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Dyno Nobel Inc. and Subsidiaries Tax Favored Retirement Savings and Investment Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Dyno Nobel Inc. and Subsidiaries Tax Favored Retirement Savings and Investment Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s information.

General—The Plan is a defined contribution plan covering substantially all employees of Dyno Nobel Inc. and subsidiary companies (the “Company”) who have attained 18 years of age and whose employment is not governed by a collective bargaining agreement. The Board of Directors of the Company has appointed the Pension Benefits Administrative Committee to control and manage the operation and administration of the Plan. Empower Annuity Insurance Company, formerly known as Prudential Retirement Insurance and Annuity Company serve as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions—Contributions to the Plan may include (i) salary reduction contributions authorized by participants, (ii) matching contributions made by the Company, (iii) discretionary nonelective contributions made by the Company, and (iv) participant rollovers from another plan.

Participants may elect to contribute a percentage of before-tax or after-tax salary to the Plan each year, subject to the limitations as defined in the plan document. Before-tax contributions are excluded from the participant’s taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan. The Plan includes an auto-enrollment provision for those participating employers who elect this option, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions; these additional contributions are eligible for a Company matching contribution.

Plan participants receive a safe harbor matching contribution equal to 100% of their pre-tax deferrals that do not exceed 3% of compensation, plus 50% of pre-tax deferrals that do not exceed 5% of compensation. In addition, all eligible Dyno Nobel Inc. employees receive nonelective lump-sum contributions between 1% and 5% of eligible compensation based on years of service. Effective January 1, 2020, the plan was amended to extend these contributions to participants in the Company’s wholly-owned subsidiaries. Nonelective lump-sum contributions are credited during the following plan year to the account of each active participant as of December 31, regardless of whether each participant is still actively employed on the date of contribution. These contribution receivables were \$3,370,976 and \$3,132,103 as of December 31, 2024 and 2023, respectively.

Participants may rollover amounts from other qualified defined benefit or defined contribution plans subject to certain plan and Internal Revenue Code (IRC) limitations.

Participant Accounts—Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contributions and related matching and nonelective contributions and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments—Participants may direct the investment of their contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. The Plan offers investments in pooled separate accounts, mutual funds, and a guaranteed income fund.

Vesting—Participants are vested immediately in their contributions and Company matching contributions, plus actual earnings thereon. Vesting in the nonelective lump-sum and profit-sharing contribution is based on years of continuous service. A participant is vested 25% after one year of service, 50% after two years of service, 75% after three years of service, and 100% after four years of service.

Notes Receivable from Participants—Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of one-half of the vested account balance or \$50,000. Only one outstanding loan is permitted at any time, and when a loan is paid off, a participant cannot apply for another loan until 30 days after the date at which the loan is repaid in full. The loans are secured by an assignment of a participant's vested interest in the Plan and bears interest at a rate commensurate with local prevailing rates at the time funds are borrowed, as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions or as a lump sum for the outstanding loan balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. As of December 31, 2024, participant loans have maturities from 2025 through 2034 at interest rates ranging from 3.25% to 8.5%.

Payment of Benefits—On termination of service with the Company (including termination of service due to death, disability, or retirement), a participant may generally elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In service withdrawals of all or a portion of a participant's account are available when a participant reaches age 59 1/2.

Forfeited Accounts—When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account as defined by the Plan, represents a forfeiture. The plan document permits the use of forfeitures to reduce plan administrative expenses for the plan year. However, if a participant is reemployed and fulfills certain requirements as defined in the plan document, the account will be reinstated. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$523,770 and \$370,798, respectively. During the year ended December 31, 2024, administrative expenses and employer contributions were reduced by \$564,957 from forfeited nonvested accounts.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition—The Plan's investments are stated at fair value, except for the guaranteed income fund discussed in Note 5, which is reported at contract value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount Plan participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the plan document.

Administrative Expenses—Administrative expenses of the Plan are paid by the Company as provided in the plan document. All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid as of December 31, 2024 and 2023.

Transfers—In addition to the Plan, the Company sponsors another 401(k) plan for employees covered by a collective bargaining agreement. If employees change their participation in a collective bargaining program during the year, their account balances are transferred into the corresponding plan. This resulted in \$304,070 net transfers from the Plan for the year ended December 31, 2024.

Contributions—Employee contributions are recorded when withheld and employer matching contributions are recorded when earned.

Excess Contributions Payable—The Plan is required to return contributions received during the Plan year in excess of the IRC limits.

Subsequent Events—Subsequent events were evaluated through October 14, 2025, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE TRUSTEE

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Empower Annuity Insurance Company, the trustee of the Plan, and furnished to the plan administrator. The plan administrator has obtained certifications from the trustee that such information is complete and accurate.

4. FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies

used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts—The net asset value is used as a practical expedient to estimate fair value for these accounts. The net asset value is based on the fair value of the underlying investments held by each separate account. The pooled separate accounts are comprised of both bond funds and equity funds. The bond funds seek preservation of capital by investing in diversified portfolios of fixed income securities to achieve performance results that are similar to certain bond indices, while offering the potential for incrementally higher returns. The equity funds invest in domestic and international large, mid and small cap stocks. Each pooled separate account provides for redemptions by the Plan at reported net asset values per share, with no advance notice requirement. All of the accounts can be redeemed daily, and they have no redemption restrictions. The Plan has no unfunded commitments to these pooled separate accounts.

5. FULLY BENEFIT-RESPONSIVE GUARANTEED INCOME FUND

The Plan has a guaranteed income fund investment with Empower Annuity Insurance Company, trustee of the Plan. Under the group annuity insurance product that supports this product, participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balance at contract value within reasonable timeframes. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The contract is effected directly between the Plan (or trustee) and the issuer. The repayment of principal and interest credited to

participants is a financial obligation of the issuer. Given these provisions, this contract is considered to be fully benefit responsive. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.
- Premature termination of the contracts.
- Plan termination or merger.
- Changes to the Plan's prohibition on competing investment options.
- Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines.
- A breach of material obligation under the contract.
- A material misrepresentation.
- A material amendment to the agreements without the consent of the issuer.

The Plan believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The contract value of this investment was \$56,347,918 and \$53,768,962 as of December 31, 2024 and 2023, respectively.

6. RELATED-PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are units of pooled separate accounts and a guaranteed income fund managed by Empower Annuity Insurance Company, the trustee as defined by the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid for investment management services were included as a reduction of the return earned on each fund. The Plan also issues loans to participants, which are secured by the vested balances in the participants' accounts.

7. NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, the Company remitted certain participant contributions totaling \$525,812 and \$141,088, respectively to the trustee in a time frame later than that required by Department of Labor (DOL) Regulation 2510.3 102. The participant accounts were credited with the amount of investment income that would have been earned had the participant contribution been remitted on a timely basis.

8. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

9. FEDERAL INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated November 3, 2015, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. The Plan has been amended since receiving the determination letter. However, the Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
