Note 1 - Description of Plan

The following description of the Advance Services, Inc. Group Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan documents for a complete description of the Plan's provisions.

General

The Plan provides health, prescription drug, dental, vision, long-term and short-term disability, and life, critical illness, and accidental death and dismemberment insurance benefits covering eligible employees of Advance Services, Inc. and Advance Services Professional, Inc. (collectively, the Employer) as defined by Plan documents.

Benefits and Eligibility

The Plan provides benefits for the Employer's eligible employees and their covered spouses and dependents. Employees are generally eligible to participate in the Plan following 60 days of employment. Certain employees must be full time employees working 30 hours or more per week to be eligible for Plan participation. The trust funds health and prescription drug benefits. Dental, vision, long-term and short-term disability, life, critical illness, accident, and accidental death and dismemberment benefits are provided through insurance contracts. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over \$110,000, as well as its aggregate exposure for all claims). Individual losses for paid claims for covered health care expenses in excess of the agreed-upon amounts will be paid by the insurance company.

Self-Insured Benefits

All other Plan benefits for medical and pharmacy are self-insured. The claims are processed by third-party administrators under administrative services only (ASO) arrangements. The administrators pay claims directly to or on behalf of participants and are then reimbursed by the Plan's voluntary employee's beneficiary association (VEBA) trust, the 401(h) account or the general assets of the Sponsor. Despite the use of third-party administrators, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) that periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

The Plan has flexible spending account (FSA) arrangements for health care and dependent care reimbursements that are funded solely by active employee contributions. The FSAs allow eligible participants to be reimbursed tax free for qualified health care and dependent care expenses subject to annual limitations established under the Plan. The employer is not permitted to refund any part of the FSA balances to the employee; the accounts cannot be used for anything other than qualified health care and dependent care expenses; remaining amounts are not portable upon termination once the employee leaves the employer; and, any unused amount is forfeited back to the Plan sponsor. Residual FSA amounts unused at the end of the year can be carried over for two and one-half months into the next year to allow qualified expenses incurred during that period to be reimbursed from the account. Any residual FSA amounts remaining after the two and one-half month extension are immediately forfeited.

Contributions

The Plan provides for employer contributions and participant contributions. Participants, in addition to deductible and coinsurance, contribute a specified amount each month based on applicable monthly premiums for their respective benefit elections, and the Employer voluntarily contributes the remaining estimated amount necessary to fund Plan obligations on a pay-as-you-go basis. Contributions are based on estimated Plan obligations determined by the Employer's review of the Plan's historical information.

Plan Funding

Plan assets are held in the Advance Services, Inc. Employee Benefit Trust (Trust), a voluntary employee's beneficiary association (VEBA) established on July 1, 1990. Plan disbursements are restricted to payment of premiums, administrative expenses, and Plan benefits.

Insured Benefits

The Plan fully insures dental, vision, long-term and short-term disability, life, critical illness, accident, and accidental death and dismemberment benefits through insurance contracts.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to modify the benefits provided to employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Employer or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 2 - Summary of Significant Accounting Policies**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Expenses

Administrative expenses incurred in the administration of the Plan that are paid by the Plan include claims administration fees paid to third-party claims administrators pursuant to administrative services arrangements. These expenses are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Expenses that are paid by the Employer, if any, are excluded from these financial statements.

Benefit Obligations

Plan obligations at December 31, 2024 and 2023, for health claims incurred by participants but not reported at that date are estimated based on an analysis of claims paid subsequent to the Plan year end. Such estimated amounts are included in the accompanying statements of Plan's benefit obligations in the amounts currently payable.

Stop-Loss

Premiums paid for stop-loss insurance are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Stop-loss refunds of \$127,625 due as of the financial statement date have been reported as a receivable in the statements of net assets available for benefits, with the offset being netted against claim paid. Stop-loss refunds totaling \$127,625 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Refunds

Refunds due from the Plan's claims administrators and PBM are recorded when earned. Pharmacy rebates of \$93,049 due as of the financial statement date have been reported as a receivable in the statements of net assets available for benefits, with the offset being netted against claim paid. Pharmacy rebates totaling \$108,499 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

Flexible Spending Accounts

Employee contributions totaling \$122,271 were received during the plan year for health care and dependent care reimbursement spending accounts and are reflected in participant contributions in the accompanying statement of changes in net assets. Claims submitted under the health care and dependent care reimbursement accounts before year end or during the subsequent extension period totaled \$124,526 and are included in claims paid in the statement of changes in net assets available for benefits. The net forfeited amount of approximately \$1,400 was used by the Sponsor to offset Sponsor contributions and was utilized for the payment of Plan administrative fees.

Payments for Benefits

Premiums paid by either the Sponsor or the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the claims administrators. Amounts due to the claims administrators that have yet to be reimbursed by the Plan, if any, are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits. These payments, if any, are recorded as claims paid in the accompanying statement of changes in net assets available for benefits. Premiums paid by the Trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Receivables and Allowance for Credit Losses

The Plan has tracked historical loss information for its receivables and determined that all receivables are fully collectible and no allowance for credit losses is needed.

Management believes that the historical loss information it has compiled is a reasonable base on which to determine expected credit losses for receivables held at December 31, 2024 and 2023, because the composition of the receivables at those dates is consistent with that used in developing the historical credit expectations (i.e. the similar risk characteristics of its receivables). Additionally, management has determined that the current and reasonable and supportable forecasted economic conditions are consistent with the economic conditions included in the historical information. As a result, the historical loss rates have not been adjusted for differences in current conditions or forecasted changes. Accordingly, the allowance for credit losses at December 31, 2024 and 2023, is \$-0-.

Subsequent Events

The Plan Sponsor has evaluated subsequent events through October 15, 2025, the date which the financial statements were available to be issued.

Note 3 - Tax Status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated May 20, 1993, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2023 for unrelated business taxable income.

The Plan Sponsor believes that the Trust is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 - Related Party and Party-in-interest Transactions

The Employer provides the Plan certain accounting and administrative services for which no fees are charged. Additionally, as described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

Note 5 - Risks and Uncertainties

The estimated liability for claims incurred but not reported is based on historical trend information, which is subject to change. Due to uncertainties inherent in the estimation process, it is at least reasonably possible that changes in this estimate in the near term would be material to the financial statements.

Note 6 - Plan Amendments

Effective, January 1, 2024, the Plan was restated. No significant changes to the Plan's provisions were made upon restatement.

Note 7 - Concentration of Credit Risk

The Plan's financial instruments that are exposed to concentrations of credit risk consist primarily of cash deposits. The Plan believes it places its cash with high quality credit institutions. At times, these balances may exceed the Federal Deposit Insurance Corporation (FDIC) insurance limit. Accounts are guaranteed by the FDIC up to \$250,000 per depositor, per insured bank, for each account ownership category. At December 31, 2024 and 2023, the Plan had cash deposits of approximately \$109,600 and \$172,000, respectively, in excess of FDIC insured limits.
