INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed the audits of the financial statements of the Fabletics, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters we identified during the audit.

Notes to Financial Statements

1. Description of the Plan

The Fabletics, Inc. 401(k) Plan (the Plan) was established by Fabletics, Inc. (the Company and Employer) effective, August 1, 2014, to provide employees with a means to fund their retirement on a tax-deferred basis. The Plan provides retirement benefits to eligible employees of the Company and its related entities, as well as unrelated employers Lavender Lingerie, Savage X Retail, LLC, and Yitty LLC (collectively, the Employers). As a result of participating unrelated entities, the Plan is designated as a multiple employer plan.

The following description of the Plan, as amended and restated, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan under the provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by Company employees and an investment committee. Fidelity Management Trust Company (Fidelity) is the Plan's trustee and record keeper. Fidelity holds, invests and reinvests Plan assets in the interest and at the direction of the participants and their beneficiaries. The Company has engaged Creative Planning Retirement Services as an investment advisor, which assists the Plan committee in selecting investment options offered under the Plan and monitoring investment performance.

Eligible Participants:

Employees, as defined by the Plan agreement, aged 21 or older, are eligible to participate in the Plan on the first day of the month following completion of one month of service.

Contributions:

Participants are permitted to make voluntary pre-tax and Roth post-tax salary deferral contributions of up to 100% of eligible compensation, as defined by the Plan agreement. Participants who have reached the age of 50 are eligible to make an additional catch-up contribution under the Code. In addition, participants may contribute amounts representing distributions from other tax-qualified plans (rollovers), subject to Code regulations.

1. Description of the Plan (continued)

Contributions: (continued)

The Employers may make discretionary matching and nonelective contributions, as determined by their Boards of Directors. The Employers made discretionary matching contributions of \$2,345,017 to the Plan in 2024, representing up to 50% of each eligible participant contribution, not to exceed 6% of the participant eligible compensation, up to a maximum of \$3,900 per participant. For matching contributions made, the Plan requires an annual true-up so the aggregate matching contributions made during any given Plan year reflects an amount equal to the matching contributions had they been computed based on participant's year-to-date eligible compensation contributed to the Plan. As of December 31, 2024, the Plan recorded a true-up matching contribution receivable of \$97,296.

In 2019, the Company utilized forfeitures to allocate a 2018 discretionary matching contribution of \$116,186 to Plan participants. However, after remitting the matching contribution, the Company identified certain errors in the calculation and expects to remit an additional \$33,000 to the Plan upon correction, which was recorded as Employer contributions receivable as of December 31, 2023. This was funded in 2024.

Additionally, in 2019, the Company determined it had improperly excluded terminated employees from receiving discretionary Employer matching contributions in 2014, 2015 and 2016. As a result, the Company is reperforming the discretionary matching contribution for the affected Plan years and participants and expects to remit a \$40,000 qualified nonelective contribution related to these Plan years, which was recorded as Employer contributions receivable as of December 31, 2024 and 2023.

The Employers did not make any discretionary nonelective contributions to the Plan in 2024.

Contributions are subject to certain limitations under the Code.

Participant Accounts:

Participant accounts are credited with participant contributions and rollovers, discretionary Company matching contributions, and an allocation of Plan earnings or losses. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

Notes to Financial Statements

1. Description of the Plan (continued)

Vesting:

Participants are immediately fully (100%) vested in their contributions and Employer discretionary matching contributions plus actual earnings (less any losses) thereon. Vesting in Employer nonelective contributions, plus allocated earnings (less any losses) thereon, is based on years of continuous service. Participants become 20% vested in Employer nonelective contributions after two years of service and are fully vested (100%) after six years. Participants also become fully vested upon death, permanent disability, or normal retirement age. Participants transferring from other employee benefit plans retain their years of service and related accumulated vesting while participating in those plans.

Payment of Benefits:

On termination of service, participants may elect to leave their account balances in the Plan or receive benefits. Benefits are paid in a lump-sum cash distribution equal to the value of the participant account balance. Upon termination, the Plan may immediately elect to distribute participant account balances without participant consent if the balance is \$7,000 or less. For distributions between \$1,000 and \$7,000, the account balances will be rolled into individual retirement accounts on behalf of the participants. Distributions for account balances less than \$1,000 will be in the form of a check. The Plan agreement also allows for certain in-service and hardship withdrawals of benefits to participants who are current employees. Benefits are recorded when paid.

Notes Receivable from Participants:

Participants may borrow up to one-half of their account balance, for a minimum of \$1,000 and a maximum of \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which terms of up to 10 years are permitted. A participant may only have one note outstanding at a time. Participant notes are evidenced by a written note, secured by the balance in the participant's account, and bear a rate of interest determined by the Plan administrator based on prevailing interest rates charged by lenders under similar circumstances. The interest rates on the notes outstanding as of December 31, 2024 ranged from 4.25% to 9.5%. Repayment of principal and interest is generally made through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Liability for Corrective Distributions:

The liability for corrective distributions represents contributions made by certain participants that must be refunded in order for the Plan to be in compliance with applicable non-discrimination tests. The December 31, 2024 liability of \$788,122 was refunded in 2025. The December 31, 2023 liability of \$889,478 was refunded in 2024.

Administrative Expenses:

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the financial statements. Certain administrative expenses are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

Risks and Uncertainties:

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan prepares its financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments:

The Plan's investments consist of mutual funds, a money market fund and a common/collective trust. These investments are accounted for as follows:

Mutual Funds and Money Market Fund: These funds are valued at the net asset value (NAV) of shares held by the Plan at year end, as quoted in active markets.

Common/Collective Trust (CCT): The Franklin Small Cap Value GG Trust CIT is a CCT that invests primarily in small-cap equity securities. Units held in the CCT are valued using the NAV practical expedient of the trust, as determined by Franklin Templeton Trust Company (the issuer). The NAV practical expedient is based on the fair value of the underlying investments held by the trust, less its liabilities, divided by the number of units outstanding. The NAV of the CCT is calculated based on the compilation of primarily observable market information. The Plan has no unfunded commitments with the CCT, and investments are redeemable daily.

The NAV practical expedient would not be used if it is determined to be probable the Plan will sell the investment for an amount different from the reported NAV. If a full redemption of the CCT is initiated, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidated will be carried out in an orderly business manner.

2. Summary of Significant Accounting Policies (continued)

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with investing in those financial instruments.

The three-level hierarchy for fair value measurement is defined as follows:

- **Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- **Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- **Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The Plan's mutual funds and money market fund are recorded at fair value and classified within Level I of the fair value hierarchy as of December 31, 2024 and 2023. The CCT, valued at the NAV practical expedient, is excluded from the fair value hierarchy under GAAP.

Income Recognition:

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold, or held during the year.

3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net income on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Party-In-Interest Transactions

Certain Plan investments include investment options managed by Fidelity. As Fidelity is the Plan trustee, purchases and sales of these investments by the Plan qualify as party-in-interest transactions. Note receivable transactions with participants also qualify as party-in interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

5. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

6. Nonexempt Prohibited Transactions

In 2024 and 2023, the Company did not remit participant contributions and loan repayments totaling \$37,404 and \$686,715, respectively, on a timely basis, as required by the DOL. The Company remitted lost earnings to the Plan in 2024 to correct the 2023 delinquent remittances.

The DOL considers delinquent contributions to be nonexempt prohibited transactions with the Plan sponsor that can jeopardize the Plan's tax-exempt status.

7. Subsequent Events

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.
