### **Opinion**

### NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

#### NOTE 1 - DESCRIPTION OF THE PLAN

The Midwest Teamsters Member 401(k) Plan (the "Plan") was established on March 1, 1998. The Plan is a multiemployer defined contribution retirement plan with 401(k) features. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

##### **A. Participation**

To be eligible to participate in the Plan, an individual must be a Teamster union member who works for an employer under the provisions of a collective bargaining or participation agreement. Participants who have attained 18 years of age are entitled to participate in the Plan as of the first weekly pay period of the next full calendar month following 90 days of employment in a covered position.

##### **B. Contributions**

Employer contributions are made to the Plan in accordance with the collective bargaining and participation agreements. Participants may also contribute to the Plan through tax-deferred salary deductions of eligible compensation, as defined in the Plan, up to the statutory maximum as determined by the Internal Revenue Code. Rollover and catch-up contributions are permitted.

##### **C. Participant Accounts**

Each participant's account is credited with employer contributions, Plan earnings or losses, any participant contributions, rollovers and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Investments of the Plan are participant directed.

##### **D. Vesting**

Participants are immediately 100% vested in employer contributions and any elective deferrals, plus actual earnings thereon.

##### **E. Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may receive the value of his or her account. In addition, a participant may request a distribution which shall be granted upon a determination of financial hardship.

Normal retirement age is 57.

##### **F. Administration and Recordkeeping**

The Plan is administered by Wilson-McShane Corporation for \$2,800 per month through December 2023, increasing to \$3,000 per month in January 2024.

**F. Administration and Recordkeeping (Continued)**

Milliman is responsible for recordkeeping duties for \$13.50 per account, per quarter in 2024 and 2023.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**C. Employer Payroll Compliance Program**

Remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

**D. Investment Valuation and Income Recognition**

Investments held by an employee benefit plan are required to be reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made under a contract, plus earnings, less participant withdrawals and administrative expenses.

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments consist of mutual funds valued based on quoted prices in an active market. Level 2 investments consist of cash and cash equivalents valued at amortized cost which approximates fair value.

The Plan maintains a fully benefit-responsive group annuity contract with Prudential through a Stable Value Fund. Contributions to the Stable Value Fund are maintained in an insurance company general account and credited for interest and charged for participant withdrawals and administrative expenses. Prudential is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The Stable Value Fund meets fully benefit-responsive investment contract criteria and is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan.

The Plan's ability to receive amounts due is dependent on Prudential's ability to meet its financial obligations. There are no reserves against contract value for credit loss. Certain events might limit the ability of the Plan to transact at contract value including premature termination of Plan investments in the Stable Value Fund. The Plan does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

Purchases and sales of securities are recorded on the trade date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**E. Tax-Exempt Status**

No provision for federal income tax is made. The Plan received its latest notice of tax-exempt status on August 10, 2017. The Plan administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

**E. Tax-Exempt Status (Continued)**

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**F. Reclassification**

Certain December 31, 2023 account balances have been reclassified to conform to the current year presentation.

**NOTE 3 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Board of Trustees has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 4 - RISKS AND UNCERTAINTIES**

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risk. Some estimated values may differ from values that would have been used had a ready market existed for the investment. Due to the level of risk associated with investments and the level of uncertainty with respect to the changes in the value of investments, it is reasonably possible that changes in risk in the near term would materially affect the amounts reported in the financial statements.

**NOTE 5 - DELINQUENT PARTICIPANT CONTRIBUTIONS**

During 2024 and 2023, certain participating employers were late in remitting participant contributions to the Plan. According to Prohibited Transaction Exemption (PTE) 76-1, neither the failure of a participating employer to contribute to the Plan when the contribution is due, nor the failure of the Plan to collect such a delinquent contribution constitutes a prohibited transaction under code section 4975 if the Plan is making a systematic, reasonable, and diligent effort to collect delinquent contributions. The Plan has written procedures for the collection of delinquent contributions and assesses liquidating damages and interest in accordance with PTE 76-1. As such, the late participant contributions are not reported as a prohibited transaction. The total amount of known late participant contributions were \$22,113 and \$20,747 for the 2024 and 2023 Plan years, respectively.

**NOTE 6 - PLAN AMENDMENTS**

In May 2023, the Plan was amended to change the hardship withdrawal and required minimum distribution rules.

In July 2024, the Plan was amended to allow active participants to take a distribution of their account after they reach age 59½ and to allow participants to take a distribution of their account as a partial lump sum at any distribution event.

**NOTE 7 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 26, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events which required recognition or additional disclosures in these financial statements.
