## Independent Auditors' Report

To the Participants and Trustees of  
Mechanical Services & Design Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Mechanical Services & Design Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Mechanical Services & Design Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Mechanical Services & Design Inc., (the Company and Plan Sponsor) and covers substantially all eligible employees of the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Under the terms of the Plan, covered employees are eligible to become participants on the first day of the month following or coincident with completion of 30 days of service and upon reaching age 18.

Contributions

- (a) *Participant's voluntary salary reductions.* Participants may elect to contribute up to 100% of their annual compensation, as defined by the Plan, subject to IRS limitations. Pre-tax elective deferrals and after-tax Roth contributions are available. The Plan has an automatic deferral feature (5% default rate) with an opt-out provision for all newly eligible employees and participants without an existing affirmative election. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan also provides for catch-up contributions for participants age 50 or older.
- (b) *Safe harbor employer matching contributions.* The Plan is a safe harbor plan. Under the safe harbor provisions, the Plan Sponsor provides a matching contribution in an amount equal to 100% of the first 3% of eligible compensation contributed by the participant plus 50% of the next 2% not to exceed 5% of the participant's annual compensation. The Plan Sponsor authorized a safe harbor matching contribution of \$579,338 and \$435,214 for the years ended December 31, 2024 and 2023, respectively.

Contributions (Continued)

- (c) *Discretionary employer matching contributions.* The Plan Sponsor may make discretionary matching contributions. To qualify for the matching contribution, a participant must have completed at least 1,000 hours of service (or equivalent as defined by the Plan) and be employed on the last day of the Plan year. Employees who become retired, disabled, or deceased during the Plan year are also eligible to receive the contribution. This amount will be allocated in an amount designated by the Plan Sponsor to each eligible participant. There was no additional discretionary employer matching contribution authorized for the years ended December 31, 2024 or December 31, 2023.
  
- (d) *Discretionary profit sharing contribution.* The Plan Sponsor may make a discretionary profit sharing contribution. This amount will be allocated in an amount designated by the Plan Sponsor to each eligible participant. To qualify for the discretionary profit sharing contribution, a participant must have completed at least 1,000 hours of service (or equivalent as defined by the Plan) and be employed on the last day of the Plan Year. Employees who become retired, disabled, or deceased during the Plan Year are also eligible to receive the contribution. The Plan Sponsor authorized a profit sharing contribution of \$195,602 and \$701,339 for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited or charged with the above contributions, rollover contributions, Plan earnings thereon, and an allocation of Plan expenses.

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a fully benefit-responsive investment contract as investment options for participants.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1.0%. Principal and interest are paid ratably through payroll deductions.

Vesting

Participant vesting is based on service years. A year of service is defined as at least 1,000 hours worked (or equivalent as defined by the Plan). Participant's contributions and safe harbor matching contributions plus actual earnings are 100% vested immediately. Participants also become fully vested upon death, disability, or termination of the Plan. The discretionary employer contributions vest according to the following schedule:

Years of Service	Non-Forfeitable Percentage
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$17,049 and \$9,574, respectively. These accounts are used to reduce future employer contributions or to pay Plan expenses. The employer contribution receivable at December 31, 2024 and 2023, was reduced by the forfeiture balance of \$17,049 and \$9,470, respectively.

Payment of Benefits

Upon termination of service due to any reason other than death, a participant may elect to receive either (1) a lump sum amount equal to the value of the participant's vested interest in his or her account or (2) in substantially equal annual or more frequent installments over a period not to exceed the joint life expectancy of the participant or the participant's beneficiary.

For termination due to death, distributions are made in accordance with the Plan, which generally allow (1) distributions of the entire account balance to be completed by December 31 of the calendar year containing the fifth anniversary of the participant's death or (2) distributions over the life of or over a period no greater than the life expectancy of the participant's beneficiary. The participant's beneficiary may elect to receive either a lump sum or installment payments.

Payment of Benefits (Continued)

All involuntary distributions greater than \$1,000 and less than \$5,000 are paid as a direct rollover to an individual retirement plan. If a participant has terminated employment, he or she must begin receiving benefits no later than April 1 of the calendar year following the year in which he or she reaches age 73. Additionally, the Plan allows in-service distributions after a participant has reached age 59½ up to their fully vested account balance. Participants may also receive distributions from their fully vested accounts for qualified financial hardships.

Amendments

Effective January 1, 2024, the Plan was amended and restated to change the service requirement to enter the Plan from two months to 30 days.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The Plan prepares its financial statements using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in interest and dividends. Net appreciation (depreciation) of fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments and the Plan Administrator deemed the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses of the Plan

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the Plan are allocated to the participants' accounts and are included in administrative expenses. Certain withdrawal expenses are paid for by the affected participant. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**NOTE C - CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in the fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the Custodian of the Plan, as of December 31, 2023 and for the year then ended, and the period January 1, 2024 through June 30, 2024, and Transamerica Trust Company, the Custodian of the Plan, as of December 31, 2024, and for the period July 1, 2024 through December 31, 2024.

**NOTE D - FAIR VALUE MEASUREMENTS**

FASB ASC 820-10, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below.

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE D - FAIR VALUE MEASUREMENTS (Continued)**

The asset's or liability's fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price reported on the active market on which the individual securities are traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a fully benefit-responsive investment contract with Transamerica Financial Life Insurance Company Inc. (the Trustee). The Transamerica Stable Value Option is not a separate account investment choice; it is an investment in Transamerica's general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by the Trustee, a measurement that approximates fair value. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,519,239 and \$1,443,985, respectively. This investment seeks to protect against any loss of principal while providing returns in excess of money market funds and one-year U.S. Treasury bills. The investment has a portfolio investment rate design in which all deposits are credited with the same interest rate, credited on a daily basis, and set with no maturity. The effective credited interest rate is set on a semi-annual basis and announced at least 45 days in advance of the date the new rate becomes effective. The guaranteed rate of interest shall not change during the six month period for which it is effective. Contract charges may reduce this return. The average yield and crediting interest rate of the stable value fund was 1.58% and 1.18% for the years ended December 31, 2024 and 2023, respectively.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendment to the Plan Document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs or a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

**NOTE F - PARTY-IN-INTEREST TRANSACTIONS**

Certain administrative services are provided by the Plan Sponsor at no cost to the Plan, and certain administrative costs incurred by the Plan are paid by the Plan Sponsor.

The Plan's administrative expenses result from services rendered by parties-in-interest.

Certain Plan investments are managed by affiliates of Transamerica Trust Company. Transamerica Trust Company is the Plan Custodian; therefore, these transactions qualify as party-in-interest transactions.

**NOTE G - INCOME TAX STATUS**

The Company has adopted the CCH Incorporated Non-Standardized Pre-Approved Profit Sharing Plan with CODA which has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the restated prototype plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended and restated since receiving the determination letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in accordance with the IRC. Therefore, no income taxes have been provided for in the financial statements.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become one hundred percent (100%) vested in their accounts.

**NOTE I - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE J - NONEXEMPT TRANSACTIONS**

During 2024, the Company inadvertently failed to deposit \$43,443 of participant deferral contributions to the Plan within the required time period described in 29 CFR 2510.3-102, as stated by the United States Department of Labor regulations. Plan management is in the process of calculating and remitting lost earnings associated with the late deposits and evaluating whether to correct the matter through the Department of Labor's Voluntary Fiduciary Correction Program (VFCP) or through self correction.

**NOTE K - SUBSEQUENT EVENTS**

Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
