INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Libertas Copper, LLC Pension Plan for Hourly Rate Employees of the Eminence, Kentucky Plant, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Libertas Copper, LLC Pension Plan for Hourly Rate Employees of the Eminence, Kentucky Plant and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. NOTES TO FINANCIAL STATEMENTS

NOTE 1—DESCRIPTION OF PLAN

The following description of the Libertas Copper, LLC Pension Plan for Hourly Rate Employees of the Eminence, Kentucky Plant (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined benefit pension plan covering substantially all hourly employees of Libertas Copper, LLC Eminence, Kentucky Plant. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Libertas Copper, LLC (the Company) acquired the assets and certain liabilities of Hussey Copper, Ltd. on December 15, 2011. The sponsor of the Plan was changed to Libertas Copper, LLC in 2011. The Plan's provisions continued without changes in the Plan.

Effective March 23, 2012, an agreement with the United Steelworkers AFL-CIO was reached. This agreement states that effective forty-five (45) days after ratification, years of service and multiplier will be frozen. Service will no longer accrue after this date for pension purposes.

Amendments – The Plan was amended in 2011, as follows:

Section 4.2 (“Years of Service”) of the Plan is hereby amended by adding the following new subsection (e) to the end thereof:

(e) For service performed in Covered Employment on or after January 11, 2011, each Employee shall be credited with a Year of Service only for purposes of determining whether the Employee satisfies the Years of Service requirement for eligibility for early Retirement Income or disability Retirement Income pursuant to Section 5.3, 5.4, 5.5, or 5.6. Solely for purposes of this Section 4.2(e), the term Employee shall be given the same meaning assigned to such term in Section 2.10 and shall further include any Employee in Bargaining Unit One. Any Active Participant who is a Bargaining Unit Two Employee who was first hired by the Company prior to December 22, 2008 shall be credited with a Year of Service, or a fractional Year of Service, as provided under this Section 4.2 without regard to this Section 4.2(e).

Section 4.3 (“Years of Credited Service”) of the Plan is hereby amended by adding the following new subsection (e) to the end thereof:

(e) For service performed in Covered Employment on or after January 11, 2011, only those Active Participants who are Bargaining Unit Two Employees who were first hired by the Company prior to December 22, 2008 shall be credited with a Year of Credited Service or a fractional Year of Credited Service.

Section 5.7 (“Eligibility for Deferred Vested Retirement Income”) of the Plan is hereby amended by adding the following new provisions to the end thereof:

Any person who is an Active Participant in Bargaining Unit One as of January 10, 2011, and who is not otherwise vested, and does not later become vested, in his Retirement Income shall be vested in his Retirement Income to the extent the Plan, as of January 10, 2011, is funded on a termination basis.

Funding Policy – The Plan's funding policy is for the Company to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. During 2024 and 2023, the Company made contributions of \$142,566 and \$104,584, respectively. The Company's contributions for 2024 and 2023 exceeded the minimum funding requirements of ERISA.

Plan Termination – Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. Before the Company can terminate the Plan, the Administrator shall give the Pension Benefit Guaranty Corporation (PBGC) notice of the proposed termination of an Employer's participation at least ten (10) days before the effective date of the termination. The PBGC shall have ninety (90) days (or such longer period as agreed to between the Administrator and the PBGC or as ordered by a court) in which to decide whether the assets of the Plan are sufficient to discharge, when due, all obligations of the Plan with respect to basic benefits. During this time, the Administrator and the Trustee shall not pay out any amounts under the termination procedure unless a notice of sufficiency is received. If the PBGC finds the assets are sufficient and permits the Employer to terminate the Plan, the Employer shall direct the Administrator and the Trustee to allocate the Plan assets in accord with the order for such allocation in ERISA Section 4044 (or any successor section or statute thereto). Termination of the Plan may also be instituted by the PBGC under certain conditions specified in ERISA Section 4042. In such a case, the Corporation may establish its own procedures for termination or may apply to the Federal courts for appointment of a trustee to terminate the Plan. In any case, upon termination or partial termination of the Plan, all accrued benefits, to the extent then funded, become fully vested.

Plan Provisions – The following are the significant provisions of the Plan.

Normal Retirement Eligibility:	Upon the attainment of the later of age 65 and 5 years of participation
Normal Retirement Benefit:	Monthly payments of \$24.50 multiplied by years of service
30-Year Retirement Eligibility:	Upon completion of 30 or more years of service
30-Year Retirement Benefit:	Same as normal retirement
70/80 Retirement Eligibility:	In the event of plant closing, completion of at least 15 years of service and (a) attainment of age 55 and combined age and years of service are equal to 70 or more, or (b) whose combined age and years of service are equal to 80 or more, and whose service is terminated as the result of a permanent shutdown or layoff or physical disability
70/80 Retirement Benefit:	Same as normal retirement
Early Retirement Eligibility:	Upon the attainment of age 60 and completion of 15 years of service
Early Retirement Benefit:	Same as normal retirement, reduced by half of 1% for each month the Early Retirement Date precedes age 65.
Disability Retirement Eligibility:	Upon total and permanent disablement after completion of 15 years of service
Disability Retirement Benefit:	Same as normal retirement
Deferred Vested Pension Eligibility:	Upon termination of employment after completion of 5 years of service and attainment of age 65

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the General Investment Fund (Note 5) which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's sponsor determines the Plan's valuation policies utilizing information provided by its investment advisers, custodians, and insurance company. See Note 5 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year. Net appreciation or depreciation in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Income Taxes

The IRS has determined and informed the Company by letter dated December 18, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 3—ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS, ASSUMPTIONS, AND COST METHODS

Accumulated plan benefits are those future periodic payments, including lump distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the plan are based on a controlled dollar amount multiplied by years of service.

The actuarial present value of accumulated plan benefits is determined by an actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2025 and 2024. Had the valuations been performed as of December 31, there would be no material difference.

NOTE 4—INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The custodian of the Plan has certified that certain information disclosed in the accompanying financial statements and supplemental schedules is complete and accurate as of and for the years ended December 31, 2024 and 2023 in accordance with DOL Regulation 2520.103-5. Such information includes the composition, cost and current value of all investments held as of December 31, 2024 and 2023, the contract value of the investment contract with the insurance company, and the interest, dividends, and net appreciation in fair value of investments for the years then ended.

NOTE 5—FAIR VALUE MEASUREMENTS (UNAUDITED)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted Prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at net asset value (NAV), the values of the pooled separate accounts are expressed in units as determined by valuing the underlying assets owned by the fund, minus its liabilities, and then dividing the value of the entire account by the total number of units in the plan account. There are no unfunded commitments, and the redemption frequency is daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6—INVESTMENT CONTRACT WITH INSURANCE COMPANY (UNAUDITED)

The Plan holds an investment contract (group annuity contract) with Principal Financial Group, Inc. (the “General Investment Fund”). The General Investment Fund represents a fully benefit-responsive investment contract. It is stated at contract value on the Statements of Net Assets Available for Benefits. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Principal seeks to preserve the principal investment and earnings but cannot guarantee that they will be able to do so. The General Investment Fund has certain restrictions that may impact the ability to collect the full contract value. Market value adjustments and surrender charges could limit the ability of the Plan to initiate and complete a transaction at contract value. A market value adjustment is a feature of the contract that protects Principal and its clients against sudden movements in the bond markets and offsets losses if assets are sold at a loss.

Principal reserves the right to terminate the contract if there is a breach of contract, if the Plan fails to meet the applicable requirements of the Code, or if the account has not met certain growth benchmarks as defined by Principal. The Plan's management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable.

The methodology used to calculate the interest crediting rate for the General Investment Fund is discretionary to Principal. The crediting rate is set to be at least as high as the guaranteed minimum interest rate for a given contract. The crediting interest rates for the General Investment Fund are determined based on the performance of Principal's general account and may be changed semi-annually. Participants are allocated interest on the investment contracts based on the average rate earned.

NOTE 7—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others.

Certain funds of the Plan are invested in pooled separate accounts and investment contracts. Principal Financial Group, Inc. is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan paid administrative fees (including investment expenses) of \$109,846 and \$101,647 during the years ended December 31, 2024 and 2023, respectively, to the custodian, which qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8—RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported, based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 9—SUBSEQUENT EVENTS

Management has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements as of the date of the independent auditor's report, which is the date the financial statements were available to be issued. There were no subsequent events requiring adjustments to the financial statements or disclosures, as stated herein.
