**Note 1. Description of Plan**

The following description of the ELG Haniel Metals Corp. and Subsidiaries Tax Deferred Savings Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**A. General**

The Plan is a defined contribution plan covering all full-time employees of ELG Haniel Metals Corp. and Subsidiaries (“Company”) who are age twenty-one or older, except those whose employment is governed by the terms of a collective bargaining agreement. An eligible employee shall become a participant effective as of the first day of the month (or if sooner, the first day of the Plan year) coinciding with or next following the date on which such employee meets the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**B. Contributions**

Each year, participants may voluntarily contribute up to 100% of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a collective investment fund as investment options for participants. The Company may contribute a discretionary matching contribution equal to a percentage that will be determined each year by the Company. Additional amounts may be contributed at the option of the Company's board of directors. No additional amounts were contributed as of December 31, 2024 and 2023.

**C. Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contributions, (b) Plan earnings (losses), (c) charged with an allocation of administrative expenses paid by the Plan and (d) charged for the administration of notes receivable from participants which are charged directly to the related participant's accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**D. Vesting**

Participants are immediately vested in their contributions, and any rollover amounts, plus actual earnings thereon. Vesting in the Company's matching and employer contribution portion of their accounts plus actual earnings thereon is 100% on the effective date of participation.

**E. Investment Options**

Upon enrollment in the Plan, a participant may direct employee contributions of any whole percent in any of the investment options offered by the Plan. Participants may change their investment options daily.

**F. Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The note transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. The note terms range from 1-5 years or up to 25 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 8.50%, which are commensurate with prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions.

**G. Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Any distribution to a participant who has a total vested balance that exceeds \$1,000 shall require the participant's written consent.

**H. Forfeited Accounts**

At December 31, 2024 and 2023, the forfeited nonvested account totaled \$0.11 and \$0.11, respectively. This account will be used to reduce additional employer contribution in the future.

**Note 2. Summary of Significant Accounting Policies**

**A. Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**B. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**D. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**E. Payment of Benefits**

Benefits are recorded when paid.

**F. Expenses**

Certain expenses of maintaining the Plan are paid by the Company and therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees paid by the Plan for the investment management services amounted to \$70,541 for the year ended December 31, 2024. Fees for the administration of notes receivable from participants are charged directly to the participant's account.

**Note 3. Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 consists of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

*Level 1 Fair Value Measurements* – The fair values of mutual funds are based on quoted market prices of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

*Level 2 Fair Value Measurements* – The fair values of collective investment funds generally follow written procedures for establishing the unit value on a periodic basis. The fair values are based on other significant observable inputs (including quoted prices for similar securities, interest rates, prepayment speeds, credit risk, etc.) and also includes securities valued at amortized cost.

**Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in any remaining invested balances in their accounts. See Note 12 for a description of the Company's intent to merge the existing Plan into a Pooled Employer Plan (PEP) during 2025. This merger will not change the current employee's status. The Company has confirmed that the PEP plan meets the ERISA anti-cutback rules, meaning that benefits will not be reduced by the merger into the PEP. Participants were notified of the plan termination and the transition process as required by law.

**Note 6. Concentration of Credit Risk**

The Company maintains cash balances in bank accounts that, at times, may exceed federally insured limits.

**Note 7. Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated July 2, 1998, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The current Plan has been amended since receiving the determination letter (See Note 1) and the amended prototype Plan has been approved by the Internal Revenue Service on March 31, 2008. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for the years prior to 2021.

**Note 8. Investments, Information Certified by the Trustee (Unaudited)**

Information presented in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024 for cash, investments, notes receivable from participants, investment income, and interest income on notes receivable from participants was derived from information certified to be complete and accurate by Alerus Financial, N.A., the trustee, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 11. Related Party Transactions and Party-In-Interest Transactions**

Alerus Financial, N.A. is the trustee as defined by the Plan and, therefore, transactions with Alerus qualify as party-in-interest transactions. Fees paid by the Plan for administration, recordkeeping, loan processing, and servicing fees totaled \$22,721 for the year ended December 31, 2024.

The Plan receives investment advisor and investment management services from Wells Fargo. The fees paid for these services totaled \$68,972 for the year ended December 31, 2024.

The Plan issues notes receivable from participants, which are secured by the balances in the participants' accounts. These transactions are also considered to be party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note 12. Subsequent Events**

In 2025 the Plan will be merged into the Pooled Employer Plan (PEP) called the Unison Pooled Employer Plan, sponsored by The Standard. As a result of this merger, the day-to-day administrative and fiduciary responsibilities of the Plan's operations have been transferred to the Pooled Plan Provider, the Standard. The Company remains responsible for certain duties, including providing accurate participant data, timely remission of contributions, and monitoring the Plan. The transition will be completed as a plan merger, not a plan termination, and so all existing participant assets, vesting schedules, and protected benefits have been preserved. The liquidation date is scheduled for November 11, 2025 with the assets to be transferred to the PEP on November 13, 2025.

Subsequent events were evaluated through October 15, 2025, the date which the financial statements were available to be issued.
