INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of Monogram Food Solutions 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Monogram Food Solutions 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Monogram Food Solutions 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN:

The following description of the Monogram Food Solutions 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement and the summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General

The Plan is a defined contribution 401(k) retirement plan available to substantially all employees of Monogram Management Services, Inc., Monogram Food Solutions, LLC, Monogram Comfort Foods, LLC, Monogram Snacks Martinsville, LLC, Monogram Meat Snacks, LLC, Monogram Licensing, LLC, Monogram Brands, LLC, Monogram Frozen Foods, LLC, Monogram Prepared Meats, LLC, Monogram Appetizers, LLC, and Monogram Gourmet Foods, LLC (the "Company") who have completed 5 consecutive months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Plan Amendments

Effective January 1, 2023, the plan amended eligibility to no age requirement and 6 months of service with immediate entry. Effective, March 1, 2023, the plan amended eligibility to no age requirement and 5 months of service with monthly entry.

Contributions

Participants may elect to defer any amount of their eligible compensation subject to Internal Revenue Service (IRS) limitations. Participants may also make rollover contributions representing distributions from other qualified retirement plans. Participants who have attained age fifty (50) before the end of the Plan year are eligible to make catch-up contributions. The Company makes safe harbor matching contributions equal to one-hundred (100%) of the first three percent (3%) and fifty percent (50%) of the next two percent (2%) of eligible compensation a participant contributes to the Plan. The Plan also allows the Company to make discretionary profit sharing contributions. There were no discretionary profit sharing contributions made for 2024 or 2023.

Participant Investment Account Options

The Plan allows participants to direct varying portions of their contributions and account balances among a diversified selection of mutual funds, and a stable value fund offered through Lincoln Financial Group Trust Company, Inc. (Lincoln).

Participant accounts

Each participant's account is credited with the participant's deferral contributions, the Company's safe harbor matching contributions, and an allocation of the Company's discretionary profit sharing contributions, if any, plus a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested and changed with an allocation of administrative expenses.

Vesting

Participants are immediately vested in their elective deferral contributions and the Company safe harbor matching contributions, plus earnings thereon. Participants vest in the Company's discretionary profit sharing contributions plus earnings thereon based upon years of service, with 100% vesting occurring after six (6) years of credited service. In the event of death, disability, normal retirement age (65), or if the Plan is discontinued, participants become 100% vested in all account balances.

Notes receivable from participants

Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance. The minimum amount that can be borrowed is \$1,000. The loans are secured by the balance in the participant's account and bear interest at 0% + prime interest rate. Principal and interest is repaid ratably through payroll deductions.

Payment of Benefits

Upon termination of service for any reason, participants may choose to receive account distributions in the form of a lump-sum payment. Withdrawals by a participant while still employed are limited to those requested due to events of financial hardship as defined by the plan document, upon the attainment of age 59 1/2 and withdrawals of rollover contributions.

Forfeited accounts

If an employee terminates before his or her Company discretionary profit sharing contribution account has become fully vested, such portion of the account is forfeited. Forfeitures may first be used to pay plan administrative expenses. Any remaining forfeitures will be used to reduce any Company contribution.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the respective participant's account. Certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN:

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln, the custodian of the Plan, has certified that following data included in the accompanying financial statements and the supplemental schedule is completed and accurate.

- Investments at fair value
- Fully benefit-responsive investment contract at contract value
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

4. FAIR VALUES OF FINANCIAL MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are described below.

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2:

Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; inputs other than quoted market prices that are observable for the asset or liability; quoted prices for identical or similar assets and liabilities in inactive markets; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Participant loans: Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. This amount represents amortized cost, which approximates fair value. Participant loans are secured by the borrowing participants' account balances and bear interest at rates that range from 3% to 5%, with maturities of up to five years.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT:

The Plan has a fully benefit-responsive guaranteed investment contract with Lincoln National Life Insurance Company. The insurance company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value as reported to the Plan by Lincoln was \$1,936,810 and \$2,019,632 as of December 31, 2024 and 2023, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS:

Certain plan investments consist of interest in mutual funds and a stable value fund offered through Lincoln. Lincoln is the custodian for the Plan. These services, investments, and investment transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than direct payment. During 2024, the Plan made direct payments to various service providers totaling \$336,768, of which \$158,241 was paid from the forfeiture holding account and \$178,527 was paid from the expense holding account. During 2023, the Plan made direct payments to various service providers totaling \$276,401, of which \$112,309 was paid from the forfeiture holding account and \$164,092 was paid from the expense holding account. The plan sponsor pays directly any other fees related to the Plan's operations.

7. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

9. TAX STATUS:

The IRS has determined that the volume submitter profit sharing plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and has informed the custodian of such in a letter dated June 30, 2020. The plan administrator has adopted the volume submitter profit sharing plan and believes that the Plan currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax position taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

10. RISKS, UNCERTAINTIES AND CONCENTRATIONS:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

11. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through October 15, 2025, which is the financial statement issuance date.
