NOTE 1. DESCRIPTION OF PLAN

The following description of the For Any Auto 401(k) Profit Sharing Plan and Trust 2 (Plan) provides only general information. The Plan covers car dealerships owned by Sacramento Mortorcars LLC (Company) operating in Northern California. This Plan covers all employees of the sponsoring and participating employers which have common ownership. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company with limited exclusions who have attained the age of twenty-one and meet following service requirements. For elective deferrals and matching contribution, employees must complete six months of service. To receive a profit sharing contribution, employees must have 1,000 hours of service during plan year and be employed on last day of plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan does allow for rollover contributions into the Plan.

Contributions

The participants may contribute up to the maximum allowed by law as either a pretax contribution or designate their deferral as a Roth contribution or combination of the two (Elective deferral contribution). Contributions are subject to certain limitations. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Contributions are automatically invested in a retirement age-based fund until changed by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan makes a match contribution equal to twenty-five percent of the employee's deferral into the plan to a maximum of \$800 if the employee is employed on the last day of the plan year.

The Company has elected to not make profit sharing contributions for 2024 and 2023. The employer match for 2024 and 2023 was \$80,164 and \$93,338, respectively. The Company contributions are invested based on the participant's direction or default investment election if participant has not made an election.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer contributions is based on years of service. A participant vests twenty-five percent after one year of credited service and is one hundred percent vested after four years of credited service.

Investment Options

Upon enrollment in the Plan, a participant may direct the investment of their account into pooled separate accounts in any of the investment options the Plan has allowed with John Hancock Life Insurance Company under the group annuity contract. The investment options are primarily mutual funds held in sub accounts based upon: single mutual fund (regulated investment companies), target-date fund or lifestyle funds based upon risk, with target-date and lifestyle funds potentially holding multiple mutual funds in the sub account. The sub account funds are audited annually. Participants may change their investments options daily via the internet or via hardcopy election form after their initial enrollment in the plan.

Notes Receivable from Participants

Participants may borrow from their funds accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participants Notes fund. Loan terms range from 1-5 years. These loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Interest rates range from 5.25% to 10.25% on the participant loans. Principal and interest is paid ratably through biweekly payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's account or periodic payments over the participant's life expectancy. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or elect to leave it in the plan.

Forfeitures

Forfeited balances of terminated participants' accounts are used to reduce future employer's contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,251 and \$2,683, respectively, which will be offset against future employer contributions or Plan expenses. During 2024, Plan expenses paid from forfeited non-vested accounts was \$3,546.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value of which the Plan has none. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan trustees determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Expenses

Certain expenses of maintaining the plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participants account and are included in contract administrator fees and other fees. Investment related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

NOTE 4. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements* (“ASC 820”), is the framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts:

The Plan had \$8,004,926 and \$7,170,494 as of December 31, 2024 and 2023, respectively, in participation units held in pooled separate accounts through sub-accounts of an insurance company. The custodian, John Hancock Life Insurance Company, has certified the amounts held in the pooled separate accounts to be complete and accurate. The schedule of assets held at end of year presented as supplementary information is a complete list of all assets held certified by the custodian. The net asset value (NAV) is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the Plan would sell the investment in the underlying investment for an amount different from the reported net asset value. The underlying securities are mutual funds held in the John Hancock pooled separate accounts are listed on national securities exchanges and valued on the basis of year-end closing prices, less liabilities, divided by the number of shares outstanding. The NAV is an internal quoted price supplied by the insurance company sub-accounts that is not an active market price. The Plan has concluded that the net asset value as adjusted and reported by the insurance company approximates fair value of the investments. The investments are redeemable at the adjusted net asset value.

It is possible that the redemption rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in market conditions liquidity requirements and the economic environment may significantly affect the net asset value of the pooled separate accounts and consequently, the fair value of the Plan's investments.

NOTE 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested in the employer contributions.

NOTE 6. TAX STATUS

The Plan and related Trust 2 were amended effective February 15, 2023 to allow modifications of elective deferrals. The Company adopted a Volume Submitter 401(k) Profit Sharing Plan which received notice from the Internal Revenue Service on June 30, 2020, stating that the Plan was designed in accordance with applicable sections of the Internal Revenue Code. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal and California tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8. RELATED PARTY, PARTY IN INTEREST AND PROHIBITED TRANSACTIONS

The Plan assets are in pooled separate accounts held by John Hancock Life Insurance Company which is a Custodian, as defined by the Plan and, accordingly, transactions with John Hancock Life Insurance Company qualify as party-in-interest transactions according to applicable regulations. Fees incurred for the investment management services, recordkeeping and information management, shareholder servicing fees, sub-transfer agency fees, float revenue, Distribution (12b-1) fees, other insurance wrap fees and soft dollar commissions are based on percentages provided to the plan and as such John Hancock does not report a dollar amount for these fees and are indirect compensation as defined for Form 5500 reporting and satisfies reporting requirement under alternative reporting as it properly discloses the indirect compensation to the plan. John Hancock reported receiving direct and indirect compensation and is entitled to indirect compensation for recordkeeping and contract administration and fees paid to service providers, as noted in the following paragraph, for services provided to variable annuity contract. John Hancock did report receiving \$3,044 for recordkeeping and information management which is reported as contract fees.

As described in Note 2, the Plan paid \$32,395 in commissions to the investment advisor and \$11,321 to the third party administrator for plan administration and direct charges to participants for distributions and participant loans, which charges were deducted from the individual participant account. In addition, the third party administrator received \$3,972 from John Hancock for TPA compensation and allowances.

The late deposit of certain employee deferrals and loan repayments result in a prohibited transaction. For the plan year ended December 31, 2024, deposits consisting of employee deferrals and loan repayments of \$244,487, were remitted late, as disclosed in the supplemental schedule of delinquent participant contributions. The Plan has not corrected lost earnings for these late deposits as of the report date.

NOTE 9. SUBSEQUENT EVENT

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

In April 2025, the Plan Sponsor sold two car dealerships. As a result, the participating employees of the sold dealerships ceased to be covered by the Plan. The sale resulted in a reduction in the number of active participants in the Plan and a corresponding decrease in the Plan's total assets. This action constitutes a partial plan termination for the affected employer. As such, all participants of the sold dealerships became fully vested in all employer contributions.
