## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Bloom Engineering Company, Inc. Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1 – Description of the Plan:**

The following description of the Bloom Engineering Company, Inc. Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions. The Plan has been amended and restated effective August 15, 2021, to conform the Plan to new tax laws and some provisions may be retroactively effective. There has also been a collective bargaining agreement added to the Plan effective February 1, 2022, for union employees. Effective December 5, 2024, Bloom Engineering Company, Inc. (the “Company”) had terminated its sponsored defined benefit plan, Bloom Engineering Company, Inc. Restated Pension Plan for Salaried Employees. On this date a balance of \$83,795 was transferred to the Plan. The balance is designated to be used towards future benefit accruals and has been recognized as a benefit claims liability plus earnings as of December 31, 2024.

***General***

The Plan is a defined contribution plan covering substantially all employees, including both union and non-union employees, of Bloom Engineering Company, Inc. (the “Company”) who are age 18 or older and have completed 1 month of service. In order to receive an allocation of any non-elective Company contributions, the participant must have completed 6 months of service. All union employees who are age 18 or older become eligible after having completed 1 month of service, excluding union members who were hired prior to February 1, 2006. The Plan was originally effective as of January 1, 1992, and was merged with The Bloom Engineering Company, Inc. Hourly 401(k) plan on December 1, 2014. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company trustee is responsible for oversight of the Plan.

***Contributions***

Each year, participants may elect to contribute up to 75% of their eligible compensation, as defined in the Plan. Participants can contribute up to the maximum limits established by tax laws (\$23,000 for 2024 and \$22,500 for 2023). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to \$7,500 for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2 percent of eligible compensation with a 1 percent yearly increase with a maximum deferral percentage of 12 percent, and their contributions invested in a designated fund until changed by the participant.

***Contributions (Continued)***

There is an employer non-elective contribution for all union and non-union employees based on the following scale:

- Employees age 25 or younger – 2.5% of plan compensation
- Employees between 26 and 35 years of age – 5% of plan compensation
- Employees between 36 and 45 years of age – 7.5% of plan compensation
- Employees between 46 and 55 years of age – 10% of plan compensation
- Employees age 56 or older – 12.5% of plan compensation

For active union employees hired between February 1, 2006 and February 1, 2022 who are under the age of 46, the Company will provide the above contribution as a minimum and will then match the additional employee contributions up to a total of 9.25%.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and an allocation of any Company contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

***Vesting***

Participants are vested immediately in their contributions, rollover contributions, the Company's non-elective contribution, and actual earnings thereon. Vesting in the Company's employer matching contributions for union employees and actual earnings thereon is based on years of service. The vesting schedule is as follows:

***Notes Receivable to Participants***

Participants may borrow from their fund accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their non-forfeitable account balance. A participant is only permitted to have one outstanding loan at any time. The loans are secured by the balance in the participant's account and bears interest that is consistent with approved market rates. Principal and interest is paid through payroll deductions.

***Payment of Benefits***

On termination of service due to death, disability or retirement, a participant or a designated beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

***Forfeited Accounts***

At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$8,239 and \$2,215, respectively. These accounts can be used to restore participant accounts, reduce Company contributions, or pay Plan expenses.

**Note 2 – Summary of Significant Accounting Policies:**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual estimates could differ from those estimates.

***Investment Valuation and Income Recognition***

The investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

**Note 2 – Summary of Significant Accounting Policies (Continued):**

***Contributions***

Contributions from Plan participants and the matching and non-elective contributions from the Company are recorded in the year in which the participant compensation is earned.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as benefits paid to participants in accordance with the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

***Payment of Benefits***

Benefits are recorded when paid.

***Reclassification***

The Plan's policy is to reclassify amounts reported in prior year financial statements when necessary for classifications adopted during the current year.

***Consideration of Subsequent Events***

On December 30, 2024, the Company was purchased by Wabtec Corporation "Wabtec". Subsequent to the acquisition on October 8, 2025, the Company approved a motion to have the assets of the Plan transferred to a plan sponsored by Wabtec. It is anticipated that the Plan will be fully liquidated as of December 31, 2025.

For the year ended December 31, 2024 the Plan has evaluated subsequent events for potential recognition and disclosure through October 14, 2025, the date the financial statements were available to be issued.

**Note 3 – Certified Investments:**

Certified information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained and derived from information supplied to the plan administrator and certified as completed and accurate by Voya Retirement Insurance and Annuity Company, the custodian of the Plan.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 4 – Fair Value Measurements:**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2- Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a brief description of the valuation methodologies used for assets measured at fair value, except for those measured and reported using the net asset value “NAV” practical expedient. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts- The investments are tracked by participation units in sub-accounts offered by Voya Retirement Insurance and Annuity Contract (VRIAC”), with each sub-account representing a mutual fund investment option. Each sub-account holds a share of single underlying mutual fund, and the sub-accounts reinvest any mutual fund distributions received into additional shares of the underlying mutual fund. The participation units are adjusted daily to reflect investment results based on the quoted market prices of the underlying mutual funds for the sub-accounts. These investments are measured using the “NAV” practical expedient.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 – Related Party Transaction and Party-in-Interest Transactions:**

Plan investments are managed by VRIAC. VRIAC is the custodian of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the investment management services are reported on the statement of changes in net assets available for benefits as administrative expenses. These transactions qualify as party-in-interest transactions. Additionally, loans to eligible plan participants, which are secured by the participant’s account balance, are identified as party-in-interest transactions.

**Note 6 – Rollovers:**

On December 5, 2024, the Company’s defined benefit plan, “Bloom Engineering Company, Inc. Restated Pension Plan for Salaried Employees” terminated. All participants in the Bloom Engineering Company, Inc. Restated Pension Plan for Salaried Employees became 100% vested in that plan upon termination and were provided with the option to have their account balance rolled into any qualified plan (including the Plan) or IRA or receive a lump sum distribution. An aggregate amount of \$83,795 was rolled into the Plan during the year ended December 31, 2024, and was included in rollovers on the statement of changes in net assets available for benefits. The amount has been designated to pay for accrued benefits.

**Note 7 – Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their entire account balance. For additional information, see Note 2, Consideration of Subsequent Events.

**Note 8 – Fully Benefit-Responsive Investment Contract:**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with VRIAC totaling \$677,495 and \$536,705 for the years ended December 31, 2024 and 2023, respectively. VRIAC maintains the contributions in a general account, which supports all of VRIAC's insurance and annuity commitments. All payment guarantees of contractual interest and redemption of invested funds are based on the financial strength and claims-paying ability of VRIAC, who is solely responsible for all obligations under the contract. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity with provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemptions under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact and contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligations under the contract, (3) a material misrepresentation or, (4) a material amendment to the agreement without the consent of the issuer.

**Note 9 – Tax Status:**

The IRS has determined and informed the Company by a letter dated July 13, 2021, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America (U.S. GAAP) requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10 – Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
