Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of LCMHS Savings and Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of LCMHS Savings and Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. December 31, 2024

NOTE 1 DESCRIPTION OF PLAN

The following description of the LCMHS Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2000, as a cash or deferred profit-sharing plan covering eligible employees of Lamoille County Mental Health Services (the Employer) who have completed one year of service and performed 1,000 hours of service during that time and have attained age twenty-one. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants make voluntary employee salary reduction contributions. Participants may elect to contribute from 1% to 100% of their compensation into the Plan. A participant's annual contribution may not exceed IRS limits.

The Employer may make a contribution to each participant based on his or her elective deferrals, not to exceed 3% of the participant's compensation. In addition, the employer may make nonelective contributions at the discretion of the Employer.

Participant Accounts

Each participant's account is credited with the participant's allocated share of the Employer's contributions, elective deferrals, any amount of transfer and rollover contributions, and the participant's share of investment earnings and appreciation in the value of investments. Participants may direct their funds to any of the investment fund options offered. Withdrawals or distributions made to the participant, the participant share of investment losses and depreciation in the value of investments, and the participant's share of administrative fees and expenses paid out of the Plan will be deducted from each participant's account.

Vesting

Under this Plan, participants are immediately fully vested in all elective contributions and benefits and their account cannot be forfeited for any reason. Participants are vested in non-elective contributions using a graded schedule based on years of service.

Forfeitures

At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$13,023 and \$11,137, respectively. These accounts may be used to reduce subsequent administrative fees and employer contributions. Forfeitures of \$-0- were used to offset administrative fees or employer contributions in 2024 or 2023.

Hardship Withdrawals

Participants may file a written request for a hardship withdrawal of the portion of their account attributable to elective deferrals, Employer contributions and rollovers from other plans. Spousal written consent is required. Hardship withdrawals may be authorized by the employer for the following reasons: to assist in purchasing a primary place of personal residence, to assist in paying tuition expenses for the next twelve months of post-secondary education, to assist in paying certain hospital, doctor, or surgery expenses not covered by insurance, or to prevent eviction from or foreclosure on a principal residence.

Payment of Benefits

Upon termination of service, a participant may request early payment of their vested benefit by submitting a written request to the plan administrator. For account balances not greater than \$5,000, the Employer will pay any vested benefit in a single lump-sum payment as soon as is administratively feasible. If the account balance exceeds \$5,000, the participant may choose to defer the payment until April 1st of the year following the year during which the participant attained the age of 70½. The full value of a participant's account is payable at the Normal retirement age of 65 in a single lump-sum payment of the participant's entire account balance or in a single sum payment of a portion of the participant's account balance. If an employee continues to work beyond the normal retirement age, they may continue to fully participate in the Plan.

Administrative Expenses

Although administrative expenses may be paid from Plan assets, some expenses were paid by the Employer in 2024 or 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Cash and Cash Equivalents

The Plan considers all highly liquid investments with an original maturity of three months or less to be cash equivalents.

Investments and Investment Income

Investments are held and maintained by the Plan trustee, Empower Retirement, LLC, and are reported at fair value. The fair value of participant directed investment assets is measured by quoted prices in an active market.

Securities transactions are recognized on the trade date (the date the order to buy or sell is executed). Dividend income is recorded on the ex-dividend date. Interest and dividend income is recognized when received to conform with the accounting for Form 5500.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions. At December 31, 2024 and 2023, the balances were \$95,162 and \$85,888, respectively.

Allowance for Doubtful Accounts

The plan considers allowance for doubtful accounts to be amounts that would not be collectible by the plan. All participant loans are secured by vested participant balances. Therefore, there is no allowance for doubtful accounts at December 31, 2024 and 2023.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Information Certified by Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Empower Annuity Insurance Company and Empower Retirement, LLC, custodian of the Plan, certified to the Plan Administrator fair value and physical custody of investments at December 31, 2024 and 2023, respectively and investment transactions for the Plan year then ended and investments included in the Statement of Net Assets Available for Plan Benefits, interest and dividend income, net appreciation (depreciation) in the fair value of investments included in the Statement of Changes in Net Assets Available for Plan Benefits and the information contained in Note 2.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan at any time by delivering to the trustee and administrator written notice of such termination.

Income Tax Status

The Plan is a non-standardized prototype plan sponsored by Empower. The Recordkeeper has obtained an opinion letter as a volume submitter on the Plan dated March 31, 2014, stating that the form of the plan is acceptable under the Internal Revenue Code (Code). Generally, the Plan administrator and the Plan may rely on the opinion letter received by the Recordkeeper as to the form of the Plan qualifying under the Code (except as otherwise noted in the opinion letter). Additionally, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Code, and accordingly is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or derecognize an asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRC. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or de-recognition of an asset) or disclosure in the financial statements. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The federal tax returns for the years ended after December 31, 2018 remains open for potential examination by the Department of Labor. The plan administrator believes it is no longer subject to income tax examination for years prior to 2017.

NOTE 3 FAIR VALUE MEASUREMENTS

The Plan has implemented *Fair Value Measurements*. This established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy under are described below:

- Level 1- Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities:
- Level 2- Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.
- Level 3- Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The Plan investment assets at fair value as of December 31, 2024 and 2023 (\$4,865,378 and \$4,478,257, respectively) are not leveled because they are valued at NAV as a practical expedient.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the NAV of units of a mutual fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Subject to limitations in the Plan Document, participants may make withdrawals to make bona fide benefit payments in accordance with the plan provisions, to direct their own investments, to make participant loans, and to pay fees.

Empower Annuity Insurance Company receives indirect compensation for providing these services.


