Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of the RadiFi Federal Credit Union 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2023 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by the bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

NOTES TO THE FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1: DESCRIPTION OF PLAN

The following description of the RadiFi Federal Credit Union 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the RadiFi Federal Credit Union (the Credit Union), who are at least 18 years of age. The Plan maintains a minimum 60-day service requirement for employee elective deferrals and matching contributions, and one year of service for employees to become eligible to receive Credit Union profit sharing contributions. The Plan Trustees are responsible for oversight of the Plan. The Plan’s 401(k) Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan Trustees. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan utilizes a “safe harbor” design under Internal Revenue Service (“IRS”) 401(k) plan regulations in which employee pre-tax and employer matching contributions are not subject to discrimination testing. Participants may make salary deferred contributions (pre-tax) of their annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Credit Union may make discretionary profit sharing and matching contributions which are not limited to current or accumulated net profit.

Participant Accounts

Each participant’s account is increased by the participant’s contributions and allocation of (a) the Credit Union’s contributions and (b) Plan earnings, and reduced by distributions and the allocation of administrative expenses. Allocations are based on participants’ earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Credit Union’s discretionary profit sharing and matching contribution portions of their account plus actual earnings thereon is based on years of service with the Credit Union as represented in the vesting schedule below.

Notes Receivable From Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000, subject to certain limitations. Loan terms may not exceed a maximum of 5 years unless used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest ranging from 4.25% to 9.50%. Principal and interest payments are paid by payroll deductions.

Payment of Benefits

Upon retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum amount equal to his or her account, or an annuity. A lump-sum distribution is required if a participant's vested balance is \$1,000 or less, or if the beneficiary of the death benefit is not the spouse of the participant. In addition, the participant may elect to receive the lump-sum distribution directly or rollover the distribution to another qualified retirement plan or to an IRA.

Forfeited Accounts

Forfeitures attributable to Credit Union discretionary contributions are used to pay Plan expenses or are allocated to each eligible participant's account as directed by the Plan's management. As of December 31, 2024 and 2023, the Plan maintained forfeitures attributable to Credit Union discretionary contributions of approximately \$6,600 and \$1,200, respectively. New forfeitures during the year ended December 31, 2024 were approximately \$4,650, and there were \$0 used to pay plan expenses during the year.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**Basis of Accounting**

The Plan's 2024 financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make use of estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are charged to expense when they are incurred.

No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Credit Union and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 5, 2025, the date the financial statements were available to be issued.

Accounting Standards Adopted in 2024

No new accounting standards were adopted in 2024.

NOTE 3: INVESTMENTS

During 2024, the Plan’s investments (including gains and losses on investments bought and sold, as well as held during the year) increased in value by \$843,326.

NOTE 4: FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 - Inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

Level 2 - Inputs consist of observable inputs other than quoted prices for identical assets (Level 1).

Level 3 - Inputs are unobservable and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate account and insurance contracts

The pooled separate account is valued at the value of the underlying securities held by the Plan at year end. The fair value of the investment insurance contract is the contract value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The pooled separate account is a segregated investment account divided into sub-accounts which invest in numerous underlying funds. The investment objective of the Plan's sub-account corresponds to the investment objective of the underlying funds.

The investment insurance contract is a stable value option contract with unallocated funds that seeks to provide maximum return consistent with a guarantee of principal. The investment has a portfolio investment rate design in which all deposits are credited with the same interest rate, credited on a daily basis, and there is no set maturity.

NOTE 5: PLAN TERMINATION

Although management has not expressed any intent to do so, management has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all accounts.

NOTE 6: TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Credit Union by a letter dated June 30, 2020, that the Plan documents adopted by the Plan are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter; however, the Plan Administrator believes the Plan is designed and currently operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.

NOTE 7: INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodians, Transamerica Life Insurance Company (Transamerica), have supplied the Plan Administrator with a certification as to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 and the related investment activity and interest income on notes receivable from participants reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, Note 3, and the supplemental Schedule H, line 4I-Schedule of Assets (Held at End of Year) as of December 31, 2024.

The information obtained from the Plan Administrators was not audited by independent public accountants, except for comparing such information to the related information included in the financial statements and supplemental schedule, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 8: PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Transamerica. Transamerica is the custodian as defined by the Plan, and therefore, transactions in these investments qualify as party-in-interest transactions as defined by ERISA. Fees paid by the Plan for certain administrative services amounted to approximately \$20,600 for the year ended December 31, 2024.

NOTE 9: RISKS AND UNCERTAINTIES

The Plan’s investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
