## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Somerset Engineering 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Somerset Engineering 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. #### NOTE 1 - PLAN DESCRIPTION

---

The following description of the Somerset Engineering 401(k) Plan (formerly named Highland Tank Retirement Plan) (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

Prior to November 1, 2023 the Plan was a defined contribution 401(k) profit sharing plan covering substantially all full-time employees of Highland Tank and Manufacturing Company, the sponsoring employer, and certain affiliates: Highland Tank, LLC, Highland Tank of North Carolina, Inc., Highland Tank of New York, Inc., Lowe Engineering Company, Inc., Somerset Planning and Engineering Services, LLC, Bigbee Steel & Tank Company, Highland Tank of Northern Michigan, LLC and Highland Tank of Central Michigan, LLC (collectively referred to as the "Employers"). Effective November 1, 2023, Somerset Planning and Engineering, LLC dba Somerset Engineering took over sponsorship of the Highland Tank Retirement Plan and will cover only substantially all full-time employees of Somerset Planning and Engineering, LLC. The name of the Plan was also changed to Somerset Engineering 401(k) Plan. An employee becomes eligible to participate in the Plan upon completion of three months of service and attainment of age 18. The Plan excludes leased employees, non-resident aliens, and summer help (as defined) as members of the eligible class of employees for enrollment purposes. An employee may enter the Plan on January 1 or July 1 upon meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investments performance.

##### **Contributions**

Participants may direct contributions to the Plan up to 75% of their annual compensation and up to the maximum allowed under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible for catch-up contributions. Participants may also contribute amounts representing distributions from other defined benefit or defined contribution qualified plans (rollover). The Plan includes an automatic enrollment provision for whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan within 30 days of becoming eligible. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until changed by the participant. An employee has the option to cease enrollment, withdraw all contributions and forfeit all Company contributions within 30 days of becoming eligible. Effective October 31, 2023 all 401(k) and matching contributions for employees other than the employees of Somerset Planning and Engineering, LLC dba Somerset Engineering shall cease. Matching contributions are determined annually by the Employers. For non-union and Teamster employees, the Somerset Planning and Engineering, LLC dba Somerset Engineering made a discretionary matching contribution of 50% of the first 6% of compensation in 2024. The Somerset Planning and Engineering, LLC dba Somerset Engineering may make an additional discretionary matching contribution, which is allocated based on each participant's compensation, for that plan year. No additional discretionary employer contributions were made for non-union participants in 2024.

##### **Contributions - continued**

The Somerset Planning and Engineering, LLC dba Somerset Engineering may make an additional discretionary contribution, which is allocated based on each participant's compensation, for a plan year. The Somerset Planning and Engineering, LLC dba Somerset Engineering made no additional discretionary contributions in 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

##### **Allocated Insurance Contracts**

Certain benefits of the Plan are provided through insurance contracts that are allocated to specific participants. The insurer holds the related assets on behalf of those participants, and the contracts are not subject to the claims of the Plan's creditors. The Plan has no further obligation under these contracts beyond remitting required contributions to the insurance company. Accordingly, the allocated insurance contracts are excluded from the Plan's net assets available for benefits presented in the accompanying financial statements.

Included on the statement of changes in net assets available for benefits were payments to an insurance company to purchase Transamerica Annuity accounts during the year in the amount of \$650,000.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, rollover contributions (if any), employer's matching contributions, employers discretionary contributions and the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer contribution portion of their accounts plus earnings thereon is based on years of continuous service. Participants vest ratably and are 100% vested after six years of credited service.

##### **Payment of Benefits**

On termination of service due to death, disability or retirement, or if a terminated participant's account balance is \$5,000 or less, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. This can be a cash distribution or a rollover into an IRA or other qualified plan. If their account balance is more than \$5,000, the participant must elect in writing to either receive a lump-sum amount or installments, or to purchase an annuity equal to the value of his or her account. Hardship distributions are permitted from a participant's fully vested elective deferral account.

##### **Forfeiture**

A forfeiture results from the non-vested portion of the employer account of a terminating participant. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,183 and \$11,759, respectively. Forfeitures of employer contributions can be used to reduce employer contributions, reallocate as employer contributions, or pay administrative fees of the Plan. In 2024, \$18,070 of forfeitures were used to pay administrative fees.

#### NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

---

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determine the Plan's valuation policies utilizing information provided by the investment advisors. See fair value measurements at Note 3.

Purchases and sales of securities are recorded on a trade-date-basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Contributions**

Contributions from Plan participants, employer's matching and discretionary contributions from the Employers are recorded in the year in which participant contributions are withheld from compensation.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Employers. Expenses paid by the Employers are excluded from these financial statements. Investment related expenses are included in net depreciation in fair value of investments.

##### Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Effective July 1, 2025, there was a Plan amendment to allow Roth contributions. In addition, if you were employed as an eligible employee with East Hills Engineering Associates LLC on July 1, 2025 you will be immediately eligible to participate in the Plan. Loans are also now permitted by the Plan.

#### NOTE 3 - FAIR VALUE MEASUREMENTS

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices to active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market fund:* Value approximates fair value due to short-term of this investment.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish net asset value (NAV) and to transact at that price. These funds held by the Plan are deemed to be actively traded.

*Collective investment trust:* Valued at the net asset value ("NAV") of participation units held by the Plan at year end. The NAV, as provided by the trustee, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient was not used when it was determined to be probable that the fund would sell the investment for an amount different than the reported NAV. At December 31, 2023, there were no unfunded commitments and investments are redeemable on a daily basis and without restriction. The Plan did not hold this investment at December 31, 2024.

#### NOTE 5 - TRANSFER TO ANOTHER PLAN

---

As part of a change in Plan sponsorship, there were a number of plan participants whose funds were transferred to Highland Tank, LLC 401(k) Plan in the amount of \$41,058,224. The change in sponsorship resulted in a standard spinoff which does not result in a partial termination.

#### NOTE 6 - PLAN TERMINATION

---

Although they have not expressed any intent to do so, the Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants will become 100% vested in their employer contributions in the event of Plan termination.

#### NOTE 7 - TAX STATUS

---

The Employer has a Non-Standardized Pre-Approved Profit Sharing Plan sponsored by Metro Benefits, Inc. The pre-approved profit sharing plan received an opinion letter on June 30, 2020 that the pre-approved plan was in compliance with the application requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 8 - CERTIFIED INVESTMENTS**

---

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net depreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Capital Bank and Trust Company (the trustee of the Plan).

#### **NOTE 9 - RISKS AND UNCERTAINTIES**

---

The Plan invests in various investment securities that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **NOTE 10 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

---

The Plan pays fees to the asset trustee, investment advisor, third party administrator, and record keeper. American Funds Service Company (AFS) is an affiliated company of the trustee. Certain Plan investments as of December 31, 2024 and 2023 are held in American Funds. AFS handles certain administrative and reconciliation functions pertaining to plan investments in American Funds. Therefore, these transactions qualify as party-in-interest transactions.

The Plan maintains a revenue sharing account with its recordkeeper. This revenue is used to offset certain amounts owed to the recordkeeper for administrative services to the Plan. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or Employer may make a payment to the recordkeeper for administrative expenses not covered by revenue sharing.


