### **Note 1 – Description of Plan and Contributions**

The following description of the Jones Lumber Company, Inc. Profit Sharing 401(k) Plan (the “Plan”) is provided for general information purposes only. The Plan became effective January 1, 1974. Participants should refer to the most recent Plan Agreement for a more complete description of the Plan’s provisions.

**General:** The Plan is a defined contribution plan established for the benefit of all eligible employees of Jones Lumber Company, Inc, and Jones Wholesale Lumber Company, Inc. (collectively, the “Company”). The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (“IRC”) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

**Eligibility:** Employees are eligible for Employee Contributions once they have completed one year of service, which is equivalent to 1,000 hours of service, and have reached the age of 21. Plan entry dates are on the first day of the Plan year and the first day of the seventh month of the Plan year after satisfying eligibility requirements.

**Participant Contributions:** Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, up to the IRC annual maximum. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

**Employer Contributions:** The Plan allows for the Company to make discretionary matching contributions. For the year ended December 31, 2024, the Company matched 25% of the first 6% of employee deferred compensation. The Plan also allows for the Company to make a discretionary profit-sharing contribution. For the year ended December 31, 2024, the Company did not elect to make a profit-sharing contribution.

**Participant Accounts:** Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions, (b) Plan earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Note 1 – Description of Plan and Contributions (Continued)**

**Vesting:** Participants are immediately 100% vested in their contributions plus actual earnings thereon. The Company's matching contributions and discretionary profit-sharing contributions and earnings thereon will be vested in accordance with the following schedule:

2	20%
3	40%
4	60%
5	80%
6 or more	100%

A participant who is an employee on or after the date they reach normal retirement age (as defined by the Plan) will be 100% vested in employer contributions.

**Notes Receivable from Participants:** The Plan allows loans to participants with up to 50% of their vested account balance, up to a maximum of \$50,000. The minimum loan amount is \$1,000. The loans are secured by the balance in the participant account. All loans shall bear an interest rate equal to the Wall Street Journal prime rate plus 2%, which shall remain fixed throughout the duration of the loan. Principal and interest are paid ratably through payroll deductions. Each participant may have two loans outstanding at a time. For participant loans that become delinquent, the amount of the unpaid loan principal plus any accrued unpaid interest will be treated as a deemed distribution. Deemed distributions are reported as a taxable distribution and remain part of the participant's account balance until a distributable event occurs.

**Note 2 – Summary of Significant Accounting Policies**

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

See independent auditors' report.

## **Note 2 – Summary of Significant Accounting Policies (Continued)**

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividend income are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

**Payment of Benefits:** Benefits payments to participants are recorded upon distribution.

**Plan Fees and Administrative Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Forfeitures:** Participants' accounts are forfeited if the employer contribution portion has not fully vested at the date of termination. These amounts will be utilized to pay administrative expenses of the Plan or to reduce employer contributions. For the year ended December 31, 2024, \$2,800 were utilized to reduce employer contributions. For the year ended December 31, 2024, there was no forfeited amount utilized to reduce administrative expenses. The forfeiture balance was \$110 at December 31, 2024.

## **Note 3 – Exempt Party-In-Interest and Related Party Transactions**

Certain plan investment options are shares of mutual funds managed by Ascensus, LLC. Ascensus, LLC is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. The Plan issues loans to participants, which are secured by the balance in the participant's account. Such transactions are also considered related party transactions. For the year ended December 31, 2024, total principal amounts of \$173,000 of loans were issued to participants.

#### **Note 4 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants in the Plan will become fully vested in their account balance.

#### **Note 5 – Information Certified by the Trustee**

The Plan Administrator has elected the method of compliance as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the trustee of the Plan, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplementary schedule, including investments and notes receivable from participants held at December 31, 2024, and net investment gain, interest and dividends, interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, LLC.

#### **Note 6 – Fair Value Measurements**

Assets and liabilities recorded at fair value are categorized based upon the level of judgment associated with the inputs used to measure the fair value. Level inputs, as defined by ASC 820, are as follows:

Level 1 – quoted prices in active markets for identical assets or liabilities

Level 2 – other significant observable inputs for the assets or liabilities through corroboration with market data at the measurement date

Level 3 – significant unobservable inputs that reflect management's best estimate of what market participants would use to price the assets or liabilities at the measurement date

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 7 – Notes Receivable from Participants**

Notes receivable from participants bear interest at a range of 5.25% - 10.50% and are receivable in monthly installments over a period of one to thirty years. Loan balances range from \$242 to \$24,516 at December 31, 2024.

**Note 8 – Income Tax Status**

The IRS has determined, and the Plan trustee has been informed by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

**Note 9 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant’s account balances, and the amounts reported in the statements of net assets available for benefits.

**Note 10 – Subsequent Events**

The Plan has evaluated events occurring after the date of the most recent accompanying statement of net assets available for benefits through October 15, 2025, the date the financial statements were available to be issued. The Plan did not identify any material subsequent events requiring adjustment to or disclosure in the accompanying financial statements.
