We have performed audits of the financial statements of M S Benbow & Associates 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

1) Description of plan

The following description of the M S Benbow & Associates 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

a) General

The Plan is a defined contribution plan covering substantially all employees of M S Benbow & Associates (the Company or Employer) who are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants are immediately eligible for the Employer's matching contributions.

b) Contributions

Employees may elect to defer their eligible annual compensation up to the maximum deferral amount indicated by the Internal Revenue Service (IRS) (designated salary deferrals). Participants who have attained age 50, before the end of the Plan year are eligible to make catch up contributions.

The Employer may elect to make discretionary matching contributions to the Plan on the employees' behalf. The Employer's contribution was equal to 37.5% of each employee's elective contribution relating to base compensation, subject to a maximum of 8% of the employee's compensation.

c) Participant accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's salary deferral, Employer's matching contribution, and an allocation of the Plan's earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

d) Payment of benefits

On termination of employment due to death, disability, retirement or attaining age 59.5, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested balance in his or her account. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the plan. Balances under \$5,000 may be paid out at the discretion of the Company, as defined in the Plan documents.

e) Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants become vested in Employer contributions according to the following schedule:

f) Forfeitures

Any forfeitures occurring during the Plan year will be used first to reduce the Company match or profit sharing contribution and then to reduce administrative expenses. At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$-0- and \$4,250, respectively. Forfeited account balances used to reduce Company match contributions were \$22,617 and \$5,357 in 2024 and 2023, respectively.

g) Notes receivable – participant loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to 50 percent of their vested account balance or \$50,000 minus the highest outstanding loan balance in the participants' account during the last 12 months. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Interest rates ranged from 4.25% to 9.50% at December 31, 2024 and 2023.

2) Summary of accounting policies

a) Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

b) Use of estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

c) Notes receivable – participant loans

Notes receivable from participants are measured at the unpaid principal balance plus unpaid accrued interest. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statements of changes in net assets available for benefits, based on the terms of the Plan documents. No deemed distributions were recorded in 2024 or 2023.

d) Payment of benefits

Benefits are recorded when paid. There were no amounts allocated to accounts of participants who have elected to withdraw from the Plan but not yet been paid as of December 31, 2024 and 2023.

e) Plan administrative costs

The Company absorbs administrative costs of the Plan. Administrative expenses paid by the Plan arise from fees for the processing of distributions that are charged to their respected participant accounts. In addition, certain investment accounts charge assets and participant fees that are allocated among the respected participants.

f) Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2) Summary of accounting policies (continued)

g) Guaranteed investment contract

Contributions under a group annuity contract can be allocated to guaranteed interest accounts, which are not, by definition, an investment contract, but rather are an investment option offered under the Voya Retirement Insurance and Annuity Company contract. The group annuity contract is a non-fully benefit-responsive investment contract. The guaranteed investment accounts guarantee the return of principal plus compound interest earned over a defined term, less any applicable contract or participant-level recordkeeping charges, provided all contributions remain in the account until the end of the guaranteed period.

Interest rates are established on the first day of each calendar month and apply to any regular ongoing contributions made to the guaranteed account in that month. For each reporting year in which a participant makes a contribution to a guaranteed account, a new account is established at the end of the contract year which applies for the remainder of the guaranteed term for that account. Inter-account transfers from guaranteed interest accounts may be subject to a market value adjustment, depending on the withdrawal amount and the reason for the withdrawal. A contract charge may be applied at contract termination, per the contract specifications. The investment in the contract is included in the financial statements at contract value which approximates fair value as reported to the Plan by Voya Retirement Insurance and Annuity Company.

3) Investments

The Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$2,735,256 and \$2,445,026 in 2024 and 2023, respectively.

4) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants become 100% vested in their account balance.

5) Related party transactions

The Plan invests in mutual funds, a money market account, and a guaranteed investment contract offered and managed by Voya Retirement Insurance and Annuity Company. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

6) Risks and uncertainties

The Plan invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7) Income tax status

The Plan has adopted a prototype plan document. The prototype plan received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the letter, including amendments made to comply with recent law changes. The Plan itself has not separately applied for tax-exempt status; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions for a period of three years from filing these returns; however, there are currently no audits for any tax periods in progress.

8) Information certified by the Plan’s trustee

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and the related net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended December 31, 2024 and 2023, was obtained by the plan administrator and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, a qualified institution.

9) Fair value measurement

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

9) Fair value measurement (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market account:* Valued at the daily closing price as reported by the fund.

*Guaranteed investment contract:* Valued at contract value, which approximates fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different measurement at the reporting date.

10) Investment contract with insurance company

The Plan invests in a group annuity contract with Voya Retirement Insurance and Annuity Company, which is a non-benefit responsive investment contract. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

10) Investment contract with insurance company (continued)

As described in Note 2, because the guaranteed investment contract is non-benefit responsive, fair value is a relative measurement attributable for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contracts at December 31, 2024 and 2023 was \$161,169 and \$211,152, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

11) SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. While most of the significant provisions became effective in 2024 and thereafter, there was no material impact to the Plan's 2024 and 2023 financial statements.

12) Subsequent events

The Plan has evaluated subsequent events through the date of the independent auditor's report, the date which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
