The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of HealthReach Community Health Centers 403(b) Retirement Plan (the Plan), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by HealthReach Community Health Centers (the Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

The Plan covers substantially all employees of the Organization. Employees become eligible to make salary deferrals on the first day of employment. Employees become eligible to receive a discretionary employer contribution upon completion of 1,000 hours of service and are eligible to receive discretionary employer matching contributions upon making elective deferrals.

Contributions

Plan participants are permitted to make elective deferrals on a pre-tax or Roth basis up to 100% of their total compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The maximum amount that a participant may contribute is limited by provisions of the Internal Revenue Code (the Code).

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, frequently known as rollover contributions.

The Plan features an automatic enrollment provision. All employees who become eligible during the plan year are automatically enrolled in the Plan and 4% of eligible compensation is deferred, unless the participant specifically elects another amount or opts out of the Plan.

The Organization made a discretionary match of 50% of salary deferrals up to 4% of compensation for the year ended December 31, 2024.

The Plan allows for employer discretionary contributions. There was no employer discretionary contribution for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution or withdrawal and allocations of the Organization's contribution and Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Upon enrollment in the Plan, participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a group annuity contract and various mutual funds.

Vesting

Participants are immediately vested in their elected deferral contributions and actual earnings thereon. Employees are fully vested in employer contributions after completing one year of service, which is defined as any calendar year in which they work 1,000 hours.

Forfeitures

Participants who terminate their employment prior to becoming 100% vested forfeit their nonvested account balances. These benefits plus interest accumulated thereon are left in the Plan to either offset the employer's contributions or pay administrative expenses. During 2024, net forfeitures of \$12,720 were utilized to pay administrative expenses. The remaining balance of forfeited nonvested accounts was \$5,334 and \$17,845 as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable terms range from one to five years or up to fifteen years for the purchase of a primary residence. The notes receivable are secured by the balance in the participant's account and bear an interest rate of prime plus 1% at the date the loan is issued.

Payments of Benefits

Upon termination of employment, including death or disability, a participant may elect to receive a lump sum amount or installments equal to the value of the participant's vested account balance. Participants may also take an in-service withdrawal upon reaching age 59-1/2 in the case of employee contributed funds, or 62 for all other funds or exhibiting financial hardship. If a participant's vested account balance is between \$1,000 and \$5,000 and no distribution is requested, the Plan Administrator will initiate a rollover of the vested account balance to an IRA of their selection. For participants with a vested account balance of \$1,000 or less, the full vested benefit will be distributed as a lump sum.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the group annuity contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions.

Administrative Expenses

Administrative expenses are paid by the Plan to the extent they are not paid by the Organization.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

Management has considered transactions or events occurring through October 14, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Investment Contract with Insurance Organization

The Plan has a benefit-responsive investment contract with Lincoln National Life Insurance Company (Lincoln National). Lincoln National maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The group annuity contract is fully benefit-responsive. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by Lincoln National, represents contributions made under the contract, plus earnings (losses), less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

4. Income Tax Status

The Plan has been designed to qualify under Code Section 403(b). The Plan utilizes a volume submitter plan document from Lincoln Retirement Services Organization LLC and has obtained a favorable tax opinion letter dated March 31, 2017, from the Internal Revenue Service that states the form of the Plan is acceptable under Code Section 403(b). The Plan has been amended since receiving the opinion letter. However, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

5. Information Prepared and Certified by the Trustee

The investments and notes receivable from participants, related transactions including net appreciation in fair value of investments, and interest and dividend income amounts were obtained by management and were agreed to or derived from information certified by Lincoln Financial Group Trust Company, Inc. (Lincoln) as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits
- Statement of Changes in Net Assets Available for Benefits
- Schedule H, Line 4i – Schedule of Assets (Held at End of Year)

6. Parties-in-Interest

The Organization provides certain accounting and administrative services for which no fees are charged. The employees that provide these services are also participants of the Plan.

Lincoln manages the investment contract and certain investment funds. Lincoln is a third-party administrator and an affiliate of the custodians of those investments and, therefore, these transactions qualify as party-in-interest transactions. Direct fees paid by the Plan for administrative fees were \$43,247 and investment management services were \$16,883 for the year ended December 31, 2024.

7. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions.

8. Risks and Uncertainties

The Plan invests in various investment options. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Fair Value Measurement

U.S. GAAP establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments consist entirely of mutual funds that are measured using Level 1 inputs of quoted market prices as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All of the Plan's investments, at fair value, are held in mutual funds and are Level 1 investments with fair values of \$17,286,886 and \$16,852,451 as of December 31, 2024 and 2023, respectively.
