NOTE 1 – DESCRIPTION OF PLAN

The following description of the A&D Mortgage LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General and Eligibility

The Plan, which was created on January 1, 2016, is classified as a 401(k) plan, covering employees upon their respective hire date, and who are age 21 or older. The primary purpose of the Plan is to reward eligible employees of A&D Mortgage LLC (the “Company”) for long and loyal service by providing them with financial benefits upon retirement.

Contributions

Eligible employees can contribute up to the maximum percentage allowable, subject to certain limitations. The total maximum allowable contribution per participant to the Plan directly from the participant was \$23,000 for 2024 and \$22,500 for 2023, not including additional catch-up contributions allowed for participants over the age of 50, which was \$7,500 for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested balances, whichever is less, by executing a note in accordance with the Plan’s provisions. The loans are secured by the balance in the participant’s account. A participant may have only one loan outstanding at any time.

Vesting

Participants are always 100% vested in their own contributions, including rollover contributions. Contributions are vested in accordance with the following schedule.

A participant will also be 100% vested under any of the following circumstances:

- Death before retirement date.
- Disability before retirement date.
- Attainment of normal retirement age.
- Termination of the Plan.

Participants who terminate for reasons other than death, disability, or retirement are entitled only to their vested balances. Forfeited amounts are used to pay administrative expenses and any remaining amounts are used to reduce any future Company contributions. During the year ended December 31, 2024 there were no forfeitures.

Payment of Benefits

Participants may receive an amount equal to the value of their vested interest upon termination of employment, death, disability or retirement in lump sums. Partial or installment payments are only permitted to satisfy required minimum distribution rules.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and the Custodian.

Interest income is recognized when earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on the investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of December 31, 2024 and 2023, the Plan had notes receivable from participants with principal balances totaling \$76,510 and \$10,501, respectively, which are included in the accompanying Statements of Net Assets Available for Benefits.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain expenses to maintain the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the Plan. Investment related expenses are included in net appreciation of fair value of investments. For the year ended December 31, 2024, administrative fees was \$5,140.

Uncertain Tax Positions

U.S. GAAP requires the Plan to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan's management has determined it does not have any positions at December 31, 2024, that it would be unable to substantiate.

Risk and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk, liquidity risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants account balances and the amounts reported in the financial statements.

Plan Administration

The Company is the Plan Administrator, and as such, controls and manages the operations of the Plan. The Plan's investment assets are maintained by VOYA Retirement Insurance and Annuity Company (the "Custodian") as of and for the year ended December 31, 2024. The Custodian invests cash received, interest and dividend income, and makes distributions to participants (subject to the direction of the participants). Levy and Associates provides third-party administrative services the Plan. The Plan allows certain administrative expenses to be paid from Plan investment assets.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

NOTE 3 – INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, VOYA Retirement Insurance and Annuity Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related net appreciation in value of investments and interest reflected in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

NOTE 4 – PARTY-IN-INTEREST TRANSACTIONS

VOYA Retirement Insurance and Annuity Company is the custodian of the Plan and qualifies as a party-in-interest per Department of Labor guidelines.

NOTE 5 – FAIR VALUE MEASUREMENTS

The Plan’s investments are reported at fair value in the accompanying statement of net assets available for benefits.

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

ASC 820 establishes a three-level valuation hierarchy for measurement and disclosure of fair value. The valuation hierarchy is based upon the transparency of inputs used to measure fair value. The three levels are as follows:

Level 1 – asset value is based on actual quoted prices in active markets for identical securities (mark-to-market).

Level 2 – other significant observable inputs are used to arrive at fair value (including yield, quality, coupon rate, maturity, issue type, quoted prices for similar securities, prepayment speeds, trading characteristics, etc.).

Level 3 – significant unobservable inputs (including management’s own assumptions in determining the fair value of investments).

Mutual Funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

Pooled Separate Account: Valued at the daily closing price reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

NOTE 6 – FIDELITY BOND

The Plan has complied with the fidelity bonding requirement of ERISA.

NOTE 7 – TAX STATUS

On March 31, 2014, the IRS stated that the volume submitter profit-sharing plan with CODA adopted by the Plan, as the designed, qualifies under the Section 401(a) of the Internal Revenue Code (IRC) and therefore, the Plan and its related trust are tax-exempt. Accordingly, the Plan is required to operate in accordance with the IRC to maintain its qualification. The Plan has not received a determination letter, however, the Plan Administrator and the Plan’s tax counsel believe that the Plan is being operated in compliance with the applicable requirements of the IRC. Further, as of the date of this report the Plan has not completed required testing of its employees’ compensation on an annual basis in accordance with the IRC in order to maintain its qualified status. The Plan Administrator has indicated that it will take the necessary steps to bring the Plan’s operations into compliance with the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

The Plan is subject to routing audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrators believe it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 – PLAN TERMINATION

Although it has not expressed an intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contribution to anytime and to determine the Plan subject to the provisions of the visa. In the event of plan termination, participants will become 100% vest in the employer contribution portion of their accounts.

NOTE 9 – EXCESS CONTRIBUTIONS

For the years ended December 31, 2024 and 2023, the Plan had \$49,197 and \$7,545, respectively, for contributions in excess of amounts allowed by the IRS. The amount is included as deductions from net assets on the statement of changes in net assets available for benefits.
