**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Sazerac Company, Inc. 401(k) Plan for Union Employees (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan, sponsored by Sazerac Company, Inc. and its subsidiaries collectively (the “Company” or “Employer”), is a defined contribution plan covering substantially all full time employees of the Company who are members of either International Brotherhood of Firemen and Oilers (F&O), United Food and Commercial Workers International Union (UFCWI), or International Association of Machinists (IAM), have completed the 90-day probation period, and are eighteen years of age or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan’s Investment Committee is responsible for oversight of the Plan, and determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Company’s executive team.

Contributions: Each year, participants may contribute up to 100% of pretax annual compensation as defined in the Plan, subject to IRS limitations. Employees are automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. There is an automatic annual increase that stops at 15%, unless the participant opts out. The Plan permits after-tax contributions and participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company will match the employee contribution based on the collective bargaining agreement covering the employee. Union employees at Barton Brands of Maryland (BBMD) receive an employer match of 50% of the first 8% of contributions. Union employees at Buffalo Trace Distillery (BTD) receive an employer match of 50% of the first 9% of contributions. Union employees at The Glenmore Distillery (TGD) receive an employer match of 75% of the first 12% of contributions. Union employees at Barton Brands of Kentucky (BBKY) receive an employer match of 50% of the first 12% of contributions. Union employees at BTD who belong to the IAM union receive an employer match of 100% of the first 1% and 50% of the next 5% of contributions. Union employees at BTD who belong to the F&O union receive 50% of the first 9% of contributions. The Company may, at its discretion, make additional profit sharing contributions to the Plan. No profit sharing contribution was authorized for 2024.

The Plan also allows for transfers or rollovers from other qualified plans or retirement accounts. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts: Each participant’s account is credited with the participant’s contribution, employer contributions, allocations of Plan earnings or losses, and forfeitures of Company discretionary profit sharing contributions, if any, and is charged with his or her withdrawals and an allocation of any administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately 100% vested in their elective and rollover contributions plus actual earnings thereon. Participants become 100% vested upon retirement, disability, or death. Employer matching contributions and profit sharing contributions are fully vested dependent on the Participant’s union membership. Employer matching contributions for participants at BBMD, BTD and TGD are 100% vested immediately. Employer matching contributions for participants at BBKY vest 20% annually over a five-year period.

Payment of Benefits: On termination of service due to death, disability, or due to other reasons, a participant will receive the value of his or her account as a lump-sum distribution, as long as the value of the participant's account is not greater than \$5,000. If the value of the participant's account is greater than \$5,000, a distribution may be received as soon as practicable following termination, or the distribution may be deferred to any time following termination of employment. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS) and a participant must exhaust all available distributions prior to requesting a hardship withdrawal.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. These notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the interest and dividends reported by the Plan.

Forfeitures: Participant forfeitures of employer profit sharing contributions are reallocated to the remaining participants, based upon their relative account balances. Forfeitures of employer matching contributions are used to offset future employer matching contributions or administrative expenses of the Plan. There was a total of \$313,156 and \$3 of forfeitures used to offset employer matching contributions in 2024 and 2023, respectively. The remaining balances of forfeitures available to offset future matching contributions and administrative expenses as of December 31, 2024 and 2023, were \$26,096 and \$218,428, respectively.

**NOTE 2 – BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The accompanying financial statements of the Plan are prepared using the accrual basis of accounting.

Risks and Uncertainties: The Plan invests in various securities and investment contracts. The underlying investments are exposed to various risks, such as interest rate, liquidity, market and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of certain investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Investment Valuation and Income Recognition: The Plan's investments, other than fully-benefit responsive investment contracts, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company (the trustee of the Plan).

**NOTE 4 – INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan holds a fully benefit-responsive investment contract that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the Plan's fully benefit-responsive investment contract is presented below:

Traditional Guaranteed Investment Contract: The Plan holds a fully benefit-responsive investment contract with The Prudential Retirement Insurance and Annuity Company (“PRIAC” or “Issuer”). PRIAC maintains the contributions in its general account. The Issuer guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than 1.5%. PRIAC’s general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan’s investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract include the Plan’s loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

The Plan’s ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party Issuer’s ability to meet its financial obligations. The Issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

In the event of early termination of the contract by the Plan or the failure by the Plan Sponsor to accept the guaranteed rates, PRIAC will liquidate the contract pursuant to procedures specified in the contract agreement.

**NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan, at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will receive retirement benefits provided for under the Plan as if they had retired at the date of termination.

**NOTE 6 – INCOME TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated April 4, 2011, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Transamerica Retirement Solutions (“Transamerica”) is the record-keeper of the Plan. State Street Bank and Trust Company (“State Street”) is the trustee of the Plan. Resources Investment Advisors LLC (RIA) is the consultant of the Plan. UBS Financial Services, Inc. (UBS) is the investment advisor of the Plan. Transamerica, State Street, RIA and UBS are considered parties-in-interest based on the relationship to the Plan and the Plan’s payment of trustee fees, recordkeeping fees and investment management fees are party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.
