Opinion

We have audited the financial statements of The New York Hotel Trades Council and Hotel Association of New York City, Inc. Notes to Financial Statements

(1) Description of the Plan

The following description provides only general information about The New York Hotel Trades Council and Hotel Association of New York City, Inc. Employee Benefit Funds Staff Retirement Plan and Trust (the "Plan"). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a single employer defined contribution plan covering all eligible full-time non-union employees who are not subject to the jurisdiction of a collective bargaining agreement after completion of one twelve-month eligibility period working with The New York Hotel Trades Council and Hotel Association of New York City Health Center, Inc. (the "Employer"). The Plan and related trust were established on January 1, 1991. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - Each year, participants may contribute up to 50% of pre-tax annual compensation, as defined in the plan agreement. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investments of their contributions into various investment options offered by the Plan.

In addition, employer contributions are made to the Plan on behalf of each participant. For employees other than dentists and physicians, contributions will range from 7% to 10% of compensation. For dentists and physicians, employer contributions to the Plan will range from 2% to 7.5%. Contributions of 10% of a participant's compensation will be paid for any participant who serves as a direct report to the Chief Executive Officer.

Contributions are subject to certain limitations. Contributions in excess of Internal Revenue Service ("IRS") limits are refunded to participants.

Investment Elections - The participants' contributions and the Employer matching contributions are allocated to the various investment options offered by the Plan as the participant directs.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of: (a) the Employer's contribution, and (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants who are members of the employer's administrative staff (supervisory capacity) will be 100% vested at all times. Non-supervising physicians and dentists and all other members of the operations staff shall be 100% vested upon two years of service. A participant's contribution account which is not vested at the time of his termination of employment shall be forfeited and the participant will not be entitled to receive these benefits from the Plan.

Notes Receivable from Participants - Participants may borrow from the Plan a minimum amount of \$1,000 (inclusive of current loans) up to a maximum amount equal to the lesser of 50% of a participant's vested account balance or \$50,000. Loan repayment terms may not exceed five years unless the loan is for the purchase of the participant's principal residence, in which case the term is then determined by the Board of Trustees. The loans are secured by the balance in each participant's account and bear interest at the bank's prevailing interest rates. Principal and interest is paid ratably through monthly payroll deductions.

(1) Description of the Plan (Continued)

Forfeitures - Forfeitures are used to reduce Employer contributions to the Plan.

Payment of Benefits - Upon termination of service, the Plan provides for various methods of distribution benefits whether prior to retirement, at retirement or upon death of the participant. The participant's benefit payment must commence no later than the 60th day after the close of the Plan year in which the latest of the following events occurs:

- He or she attains the normal retirement age of 65,
- Upon his or her total and permanent disability or death,
- Upon his or her termination of employment, subject to vesting requirement, or
- Upon his or her request after reaching age 59 ½.

A participant may elect to receive his or her interest in the Plan in one of the following ways:

- A single lump sum payment,
- Installments over a fixed period that does not exceed a number of years equal to the life expectancy of the participant (as of the date payments start), as determined under the Single Life Table in Treasury Reg. Section 1.401(a)(9)-9.
- A direct rollover.

If the total value of the vested portion of a participant's contribution account is \$5,000 or less, distribution of such account will be in one lump sum cash payment.

Hardship Withdrawals - Prior to termination of employment, a participant may withdraw, subject to the Plan's notice requirements, all or a portion of the value of his or her participant account and the vested value of his or her contribution account. The participant must demonstrate financial hardship subject to the Plan's provisions. Withdrawals to which a participant is entitled are the amounts that can be provided by the contributions and income thereon (including net realized and unrealized investment gains and losses) allocated to each participant's account, less allocated expenses.

(2) Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(2) Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive contracts held by the Plan are recorded at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Plan management determines the Plan's valuation policies utilizing information principally provided by the Plan's custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Certain costs incurred by the Plan for investment management services and transaction fees are included in net appreciation in fair value of investments and through direct payments.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions payable for the years ended December 31, 2024 and 2023.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain administrative expenses of maintaining the Plan are paid by the Employer. Expenses associated with administering participants' accounts are paid from Plan assets. Any remaining expenses are shared among all participant accounts. Certain investment expenses to Empower Retirement, a party in interest, are included in net appreciation in fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(3) Fair Value Measurements (Continued)

Transfers Between Levels - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

(4) Guaranteed Investment Contract with Insurance Company

The Plan entered into a benefit-responsive investment contract with Great-West Life and Annuity Insurance Company of New York ("Great-West") totaling \$ 15,950,678 and \$ 15,638,096 at December 31, 2024 and 2023, respectively. Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the Plan and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract does not have a defined maturity specified in the contract.

The guaranteed investment contract is fully benefit-responsive and contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statement of Net Assets Available for Benefits at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, and reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

(5) Related Party and Party-In-Interest Transactions

Certain plan investments are shares of mutual funds managed by Empower Retirement ("Empower"). Empower is the custodian for the Plan and, therefore, these transactions qualify as party in interest transactions. Custodial and advisory fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments rather than a direct payment. Administrative fees paid directly to Empower were \$33,859 and \$31,461 for the years ended December 31, 2024 and 2023, respectively. The Plan Sponsor pays directly any other fees related to the Plan's operations.

(6) Tax Status

The Internal Revenue Service ("IRS") has informed the Plan by a letter dated January 7, 2011, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Plan Termination

Although it has not expressed any intent to do so, the Board of Trustees have the right under the Plan agreement, subject to the provisions of ERISA, to terminate, amend or modify the Plan at any time. In the event of plan termination, all participants will become 100 percent vested in their total account balance under the Plan.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.


