As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

Notes to Financial Statements Year Ended December 31, 2024

1. Description of Plan

The following brief description of Signature Science, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering substantially all employees of Signature Science, LLC (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Reliance Trust Company is the trustee (the “Trustee”), Standard Insurance Company is a custodian (the “Custodian”) for certain assets, and Standard Retirement Services, Inc. acts as the Plan’s recordkeeper (the “Recordkeeper”). The Plan is administered internally by employees of the Company.

Eligibility - Employees are immediately eligible to participate in the Plan. Participants are eligible to receive an employer contribution following the completion of one year of service, as defined. To be eligible for a discretionary profit-sharing contribution, a participant must also be employed on December 31, unless the participant terminates due to death, disability or retirement. Certain employee classes are excluded from participation in the Plan, as defined.

Contributions - Participants have the option to contribute pre-tax and Roth contributions, up to the annual limit established by the Internal Revenue Code (“IRC”). A participant’s pre-tax and Roth contributions are separately accounted for, as are the gains and losses attributable to each. Participants who have reached fifty years of age before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans or individual retirement accounts.

The Company contributes employer safe harbor nonelective contributions equal to 3% of each participant’s eligible compensation. The Company may also make a discretionary employer profit-sharing or matching contribution, neither of which were elected during the year ended December 31, 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts - Each participant’s account is credited with the participant’s contributions, the Company’s contributions and an allocation of Plan earnings, and may be charged with an allocation of Plan expenses, as applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum of \$50,000 reduced by the highest outstanding note receivable balance during the prior twelve-month period or 50% of their vested account balance, whichever is less. Two notes receivable can be initiated in a calendar year. Participant notes receivable are secured by the vested balance in the participant's account and bear interest at a reasonable interest rate as determined by the 401(k) Plan Management Committee. Notes receivable repayments are deducted through after-tax payroll deductions over a period not to exceed five years, unless the note receivable is for the purchase of a participant's primary residence, in which case the repayment period may not exceed fifteen years.

Vesting - Participants are immediately vested in their voluntary and employer safe harbor nonelective contributions plus actual earnings thereon. A participant eligible for a discretionary employer profit-sharing or matching contribution, if any is made, is 100% vested in that contribution.

Payment of Benefits - Benefits are generally payable upon age 59.5, disability, death, retirement or termination of employment. Benefits equal to the participant's vested account balance may be paid to a participant or beneficiary by lump sum, installments, partial withdrawals or rollover into a qualified plan, subject to regulatory requirements. Required minimum distributions are made to applicable participants in the absence of adequate distribution elections. Generally, if no longer employed by the Company, participants must either take a lump sum distribution or begin systematic, actuarially determined withdrawals by April 1 of the year following the year in which the participant turns 73 years of age. The Plan administrator may, without the participants' consent, transfer separated participants' account balances that are less than \$7,000 (an increase from \$5,000 effective January 1, 2024) into an individual retirement account. In-service distributions of rollover contributions may be taken at any time. In-service hardship distributions are permitted if certain criteria are met.

Current Legislation - The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date, and any SECURE 2.0 amendments must be adopted by the Plan no later than December 31, 2026, although it may operate under the new provisions as required or elected prior to amending the Plan document. The Company is currently evaluating the impact of the remaining required and voluntary provisions of SECURE 2.0 on the Plan and its participants.

2. Significant Accounting Policies

Basis of Accounting - The Plan's financial statements are reported on the accrual basis of accounting.

Accounting Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Plan Management Committee determines the Plan's valuation policies utilizing information provided by the investment advisor, Trustee and Custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the Plan year.

Contributions - Contributions from participants are recorded in the year in which the participant contributions are withheld from compensation.

Notes Receivable from Participants - Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Benefits Paid to Participants - Benefits are recorded when paid.

Expenses and Revenue Sharing - The Company may pay certain administrative and operating costs of the Plan at no obligation to the Plan. Fees related to the administration of notes receivable from participants and distributions, and certain other fees paid to service providers, are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses, such as management fees and operating expenses, are deducted from earnings recorded to net appreciation in fair value of investments.

The Plan has revenue sharing arrangements whereby certain investment managers return a portion of the investment fees to the Recordkeeper. These amounts are used by the Recordkeeper to offset the Plan's administrative expenses or to allocate to participant accounts, as defined, with any excess amounts held in an unallocated account to be used in future years. There was no unallocated account balance as of December 31, 2024 and 2023.

Risks and Uncertainties - Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of investment securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Plan Termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the employer contribution portion of their accounts.

Subsequent Events - The Company evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued, and no events have occurred through that date that would impact the financial statements.

3. Information Certified by the Trustee and Custodian

Certain information disclosed in the accompanying financial statements, notes and supplemental schedule related to the Plan's investments held as of December 31, 2024 and 2023, and the related net investment gain during the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee and Custodian, which are qualified institutions. Notes receivable from participants as of December 31, 2024 and 2023, and the related interest income on notes receivable from participants during the year ended December 31, 2024, were not certified.

4. Fair Value Measurements

The Plan follows a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. The mutual funds are registered with the Securities and Exchange Commission and are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Group Annuity Contract

The Plan invests in a traditional, fully benefit-responsive investment contract with the Custodian (or “Issuer”), The Standard Stable Asset Fund A (the “Fund”), where the Issuer maintains the contributions in a general account. The Fund is included in the financial statements at contract value, which totaled \$2,723,351 and \$2,033,494 as of December 31, 2024 and 2023, respectively. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, transfers, and administrative expenses. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The contract’s crediting interest rate is based on an agreed-upon formula with the Issuer, as defined, but cannot be less than 1.00%. The terms of the contract prohibit a transfer or an assignment of rights under the contract, as defined, and provide for most distributions at contract value, frequent resetting of contractual interest rates based upon market conditions, and no defined maturities. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. The Plan’s ability to receive amounts due is dependent on the Issuer’s ability to meet its financial obligations, which may be affected by future economic or regulatory developments. There are no reserves against contract value for credit risk of the Issuer or otherwise.

Certain events may limit the ability of the Plan to transact at contract value with the Issuer. Such events include the following: i) certain amendments to the Plan documents (including complete or partial plan termination or merger with another plan); ii) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions; iii) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. These events could limit the ability of the Plan to transact at contract value to a market value adjustment, although the Company may elect an alternative payment option that allows for installment payments at contract value over a period not to exceed five years. The Plan administrator believes that the occurrence of any such event that might limit the ability of the Plan to transact at contract value with the Issuer and that would also limit the ability of the Plan to transact at contract value with the participants is not probable.

The Plan or the Custodian can terminate the contract by providing written notice to the other party thirty days prior to the termination date. If the contract was terminated, interest would not be less than the minimum interest rate established in the investment contract.

6. Tax Status

The Company has adopted a pre-approved plan document from the Recordkeeper that received an Internal Revenue Service (“IRS”) opinion letter dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-Interest and Related Party Transactions

The Plan holds an investment contract with the Custodian. The Plan pays direct and indirect fees to an affiliate of the Custodian and the Recordkeeper for investment management services and certain contract administration services, respectively. Certain investment managers return a portion of the investment fees to the Recordkeeper, which are used to offset administrative expenses or to allocate to participant accounts, as defined. Transactions such as these, including notes receivable from participants, qualify as exempt party-in-interest transactions. The Company pays directly certain other fees related to the Plan’s operations.
