Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the PHB Die Casting Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

1. Description of the Plan

The PHB Die Casting Inc. 401(k) Plan (the Plan) is a defined contribution plan covering all full-time employees of PHB, Inc. who are covered by a collective bargaining agreement. The Plan was formed on March 25, 1990 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

Participant Contributions

An eligible participant can make contributions up to 100% of their total compensation, subject to certain Internal Revenue Service (IRS) limitations. The Plan provides for rollovers from other plans.

Plan Sponsor Contributions

The Plan Sponsor may make a discretionary (profit-sharing) contribution to the Plan equal to 1% of each eligible participant's wages. Additionally, the Plan Sponsor provides a non-discretionary \$0.50 matching contribution for each dollar of participant deferrals up to the first 4% deferred.

For the Plan years ended December 31, 2024 and 2023, the discretionary (profit-sharing) contribution totaled approximately \$71,700 and \$69,400, respectively. The total of the non-discretionary contributions for 2024 and 2023 were approximately \$112,300 and \$107,900, respectively.

Investment of Participant Contributions

Participant contributions may be invested in any security or form of property considered prudent for a retirement plan. Each participant has the opportunity to self-direct all contributions among funds controlled by the Trustee.

Vesting

Participants are immediately vested in their contributions and the Plan Sponsor's non-discretionary matching contributions, plus earnings thereon. Vesting in the Plan Sponsor's non-discretionary (profit-sharing) contributions plus earnings thereon are at 10% for the first year and 20% each year thereafter, until fully vested after six years. In the event of death or disability, the full balance of the participant's account becomes immediately vested.

Payment of Benefits

Upon retirement, disability or death, the entire balance of the participant's account is payable in a lump sum or in installments payable over a period of time. Unless directed otherwise, upon termination, any participant's account with a vested balance under \$1,000 will be paid out in a lump-sum payment and any participant's accounts with a vested balance greater than \$1,000 and less than \$5,000 will be rolled over automatically by the Plan into a new IRA. Benefits are recorded when paid.

Withdrawals

Hardship withdrawals are not permitted. The vested balance of participant account balances are payable upon termination of service. Any amounts rolled into the Plan are available for withdrawal at any time.

1. Description of the Plan (continued)

Notes Receivable from Participants

The Plan provides for loans to participants. The loans are subject to certain limitations and conditions, as specified in the Plan Loan Policy.

Plan Termination

While there are no present intentions to terminate the Plan, the Plan Sponsor has the right under the Plan to discontinue the Plan at any time. Should such a termination occur, each participant would be fully vested in their interest in the Plan, and the value of each participant's account will be paid as directed by the Plan Sponsor.

Forfeited Accounts

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. These forfeited amounts are used to pay administrative expenses of the Plan and any remaining forfeitures are allocated to eligible participants. There were no forfeitures used to pay administrative expenses or reallocated to participants during the year ended December 31, 2024. During the year ended December 31, 2023, forfeitures totaling \$16,526 were used to pay administrative expenses or reallocated to participants. The unallocated forfeiture balance totaled \$9,937 and \$1,179 at December 31, 2024 and 2023, respectively.

Administrative Fees

Certain transaction fees are charged by the trustee directly to Plan participant accounts. Presently, legal services, which are not material, are provided at the expense of the Plan Sponsor while all other services are provided at the expense of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements and accounting records of the Plan are maintained on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP), which recognizes additions to and deductions from net assets when the contributions are withheld, income is earned, and liabilities are incurred.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

The Plan's investments are held and invested by Empower Trust Company, LLC, the trustee of the Plan. Investment values are based upon the latest quoted prices as provided by the trustee. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Investments are valued daily.

Investment Valuation and Income Recognition (continued)

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in common/collective trust funds and the stable value trust fund are reported at Net Asset Value (“NAV”). The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different from the reported NAV. See Note 4 for discussion of fair value and NAV measurements.

Use of Estimates

The preparation of the financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect amounts reported in the financial statements and related disclosures. Actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

3. Tax Status

The Plan, established as a non-standardized pre-approved plan, is designed to comply with the applicable requirements under Section 401(k) of the Internal Revenue Code and is, therefore, not subject to tax under present income tax law. The Plan has been amended since receiving its original determination. The Plan Administrator is not aware of any course of action or series of events that might adversely affect the Plan’s qualified status.

During 2024, the Plan Sponsor failed to remit withholdings for one payroll date with contributions totaling \$9,699 to the Plan in a timely manner. The Plan Sponsor made corrective contributions to the participants’ accounts, including lost earnings on the late remittances totaling \$771 in December 2024. This matter was deemed to be “self-corrected” under the IRS SCP; therefore, the Plan Sponsor believes that no formal corrective notification to the IRS or the DOL was required. The Plan’s Administrator believes the necessary steps were taken to properly correct the error in order to maintain the Plan’s qualified status and operate in compliance with the IRC.

The Financial Accounting Standards Board (FASB) issued guidance on accounting for uncertainty in income taxes. During the years ended December 31, 2024 and 2023, management evaluated the Plan’s tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes it is no longer subject to income tax examinations for years ended prior to December 31, 2021.

4. Fair Value Measurements

Investments are recorded at their estimated fair value, in accordance with the provisions of the FASB Accounting Standards Codification (ASC) topic on *Fair Value Measurements and Disclosures*. The topic establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

4. Fair Value Measurements (continued)

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the topic are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and money market fund – registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable annuities: Values for Variable Annuity investment options are calculated daily by the annuity provider according to the methods described in the annuity contract. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation: dividing the net assets by the number of units outstanding. Any discrepancies between the two-unit values are resolved to ensure the recordkeeping system reflects the accurate value for the day.

Stable value trust fund: The Putnam Stable Value Fund (The Fund) is a collective trust fund that is valued at the NAV of the units of the collective trust fund held by the Plan at the year-end times the respective unit value. The NAV, as provided by the trustee, is used as practical expedient to estimate fair value. The NAV of the collective trust fund is based upon significant observable inputs, although it is not based upon quoted market prices in an active market. The collective trust fund's investment objective is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital.

4. Fair Value Measurements (continued)

To achieve its investment objective, the collective trust fund invests in assets (typically contracts issued by insurance companies and banks, synthetic investment contracts and short term investments) and enters into “wrapper” contracts issued by third-parties and invests in cash equivalents represented by shares in a money market fund.

Common and collective trust funds: The Great Gray Trust American Funds Target Date Funds, Putnam Large Cap Value Trust Fund and the Putnam Small Cap Growth Trust Fund are common and collective trust funds (CCTFs) valued at the NAV of various series of similar investments, generally obtained directly from the fund house or other investment provider. If available, an attempt is made to receive share prices from more than one source, and before the share price is entered into the recordkeeping system, a systematic comparison is performed and any difference in quoted share prices for the same fund is resolved by contacting the investment provider directly to ensure the correct share price is recorded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. 5. Information Prepared and Certified by the Trustee

For the years ended December 31, 2024 and 2023, the Plan Administrator elected the method of compliance permitted under ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, all investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, net realized and unrealized appreciation in fair value of investments, interest and dividend income, and administrative expenses for the years ended December 31, 2024 and 2023, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the trustee, Empower Trust Company, LLC.

6. Related Party Transactions

Certain Plan investments are shares of funds held and managed by Empower Trust Company, LLC. This entity represents the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are based on investment performance. These fees are not prohibited; payments are for reasonable compensation for the operation of the Plan.

7. Transfers To Other Plan

The Plan Sponsor also sponsors a non-union plan, the PHB, Inc. Employees Profit Sharing Plan. For the Plan year ended December 31, 2024, participants with balances totaling \$84,120 were transferred to the PHB, Inc. Employees Profit Sharing Plan from the Plan. For the Plan year ended December 31, 2023, there were no transfers.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
