## **INDEPENDENT AUDITORS' REPORT**

To the Retirement Plan Committee, Participants, and Beneficiaries of the Southeastern Orthopaedic Specialists, P.A. Employees' 401(k) Profit Sharing Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements***

We have performed an audit of the financial statements of the Southeastern Orthopaedic Specialists, P.A. Employees' 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Southeastern Orthopaedic Specialists, P.A. Employees' 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### **[1] General:**

The Plan is a defined contribution plan covering all employees of Southeastern Orthopaedic Specialists, P.A. (the "Company"), except leased employees. Employees are eligible to participate in the Plan and receive matching contributions immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The trustee of the Plan is Lincoln Financial Group Trust Company (the "Trustee") and the third-party administrator is Lincoln Retirement Services Company, LLC.

Effective October 4, 2025, the Plan Sponsor was acquired by EmergeOrtho, P.A.

#### **[2] Contributions:**

Participants may contribute up to 100% of annual compensation, as defined by the Plan, on a pre-tax or Roth basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also permits the conversion of pretax contributions to Roth contributions. In no event may participant pre-tax and Roth contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

During 2024, the Company's matching contribution was 50% of the first 6% of participant contributions. In addition, the Company may elect to make an employer's additional contribution, in an amount to be determined annually by the Company. As of December 31, 2024 and 2023, the employer's additional contribution totaled \$785,042 and \$726,597 and is shown as an employer's contribution receivable on the statements of net assets available for benefits. Participants must (a) be 21 years of age, (b) have completed 12 consecutive months of service, as defined, (c) have completed 1,000 hours of service during the Plan year, and (d) be employed on the last day of the Plan year to be eligible to receive the employer's additional contribution. Participants direct the investment of participant and employer contributions into various investment options offered by the Plan. The Plan also offers several target date model portfolios that are categorized in terms of risk tolerance as conservative, moderate, or aggressive.

#### **[3] Participant accounts:**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and employer's additional contribution, (b) Plan earnings, and (c) forfeiture distributions, and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**[4] Vesting:**

Participants are immediately vested in their contributions and the Company's matching contributions, plus actual earnings thereon. Vesting in the employer's additional contribution portion of their accounts, plus actual earnings thereon, is as follows:

0 – 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

**[5] Payment of benefits:**

The Plan permits withdrawals when a participant terminates employment, reaches retirement age, or becomes disabled or deceased. In-service withdrawals are also permitted at age 59 ½ and for certain financial hardships. Participants are eligible for an early retirement option if they obtain the later of age 55 or six years of service. A participant or designated beneficiary may elect to receive a lump-sum payment equal to the value of their vested account or periodic installments.

**[6] Forfeitures:**

Forfeited nonvested accounts are first used to pay Plan expenses and then can be applied to reduce future Company matching contributions. Any remaining forfeitures are allocated to participants who are eligible to receive the employer's additional contribution. During the year ended December 31, 2024, forfeitures of \$50,577 were used to reduce Company matching contributions. Forfeited nonvested accounts available at December 31, 2024 and 2023 were \$1,185 and \$42,012, respectively.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**[1] Basis of accounting:**

The financial statements of the Plan are prepared on the accrual method of accounting.

**[2] Subsequent events:**

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

**[3] Investment valuation and income recognition:**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

**[3] Investment valuation and income recognition: (continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**[4] Payment of benefits:**

Benefits are recorded when paid.

**[5] Plan expenses:**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions to participants are charged directly to the participant's account and are included in administrative expenses. Administrative fees incurred in connection with the self-directed accounts that are paid by the Plan are included in administrative expenses. Investment related expenses are included in net appreciation in value of investments.

**[6] Use of estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**[7] Reclassification:**

Certain amounts in the 2023 financial statements and disclosures have been reclassified to conform to the presentation in the 2024 financial statements.

**NOTE C - INVESTMENT CERTIFICATION**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Lincoln Financial Group Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes of net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

As of December 31, 2023, cash totaling \$1,344 was not certified by the Trustee.

### NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2* Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for significant investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Mutual funds** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Self-directed brokerage accounts** - Consists of investments in interest-bearing cash, common stock, preferred stock, and limited partnerships. The common stock is valued at the closing price reported on the active market on which the individual securities are traded. The preferred stock is valued at the closing price reported on the market on which the individual securities are traded, and the limited partnerships are valued based on the applicable ending capital balance indicated on the corresponding K-1s.

**Stable value collective trust fund** - A stable value fund that is composed primarily of fully benefit-responsive investment contracts and that is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 24 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)**

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Changes in Fair Value Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

### **NOTE E - TAX STATUS**

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Lincoln Retirement Services Company LLC. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"), and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain investments are managed by Lincoln Financial Group Trust Company. Lincoln Financial Group Trust Company is the Plan trustee and, therefore, transactions related to these investments qualify as party-in-interest transactions.

### **NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

**NOTE H - MUTUAL FUND FEES**

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

**NOTE I - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company contributions.
