Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hancock, Daniel & Johnson, P.C. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Notes to Financial Statements

Note 1—Description of Plan

The following description of the Hancock, Daniel & Johnson, P.C. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of Hancock, Daniel & Johnson, P.C. (the Company) have completed three months of credited service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year participants may contribute a portion of their compensation, not to exceed the amount allowed under current law. Participant salary deferrals may be traditional 401(k) or Roth 401(k) deferrals. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover amounts representing distributions from other qualified defined contribution plans. The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate or elect to contribute another amount. Automatically enrolled participants have their initial deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company makes a safe-harbor contribution of 3 percent of compensation for each eligible participant. The Company may also make an additional discretionary contribution. An additional contribution of \$434,387 was made for the year ended December 31, 2024. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Administrative expenses: Although not required to do so, the Company paid certain administrative expenses of the Plan. Expenses that are paid by the Company are excluded from these financial statements.

Participant accounts: Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's safe-harbor contribution, (b) the Company's discretionary contribution, if any, and (c) plan earnings. Each participant's account is also charged with an allocation of administrative expenses, where applicable. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and the Company's safe-harbor contributions plus earnings thereon. Vesting in the Company's discretionary profit-sharing contribution portion of their accounts is based on years of service, as defined. A participant is 100% vested after six years of credited service.

Forfeitures: Forfeited non-vested accounts are used to reduce employer contributions or Plan expenses. Forfeitures were used to reduce employer contributions or Plan expenses for the year ended December 31, 2024. During 2024, forfeitures of \$405 were used to reduce employer contributions. As of December 31, 2024 and 2023 forfeited non-vested accounts totaled \$11,979 and \$37, respectively.

Hardship distributions: Hardship distributions are permitted from a participant's pre-tax elective deferrals, employer safe harbor contributions, employer profit sharing contributions, and transfer accounts. A participant must exhaust all other assets available, including after-tax contributions. Deferral contributions should be suspended for six months after the receipt of the hardship withdrawal.

Involuntary distributions: In the rare event a former participant does not provide written distribution instructions to the plan administrator, the plan administrator may elect to pay distributions of vested accounts of less than \$5,000 in a direct rollover to an individual retirement plan designated by the plan administrator.

Payment of benefits: A participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or in shares of stock in their self-directed brokerage account in accordance with the Plan's provisions. Amounts contributed on a pre-tax basis may be withdrawn upon a demonstration of financial hardship. In service distributions of rollover and voluntary after-tax contributions are available at any time, without restriction.

Note 2—Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at fair value. In accordance with US GAAP, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Related party and party in interest transactions: Certain plan investments are managed by Principal Life Insurance Company and Securian Financial Services, Inc. These investments have expenses that compensate Principal Life Insurance Company, Securian Financial Services, Inc. or their affiliates. The Plan paid \$2,798 of expenses to parties in interest for the year ended December 31, 2024.

Note 2—Summary of Significant Accounting Policies (continued)

Plan termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 3—Summary of Fair Market Value Measurements

Fair value measurements: In accordance with US GAAP, a fair value hierarchy for inputs is used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan or trustee. Unobservable inputs reflect the Plan's assumptions about the inputs market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels based on the inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets and liabilities in inactive markets.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. The funds are required to publish their daily net asset value (NAV). The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Valued at the closing price on which the individual securities are traded.

Pooled separate accounts: Valued at the NAV of units held in a separate account at the insurance company custodian. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the custodian which are open-end mutual funds that are registered with the SEC and publish their NAV daily, less an expense factor related to the underlying contract with the insurance company. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Internal Revenue Service (IRS) has determined and informed the Company by the letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

The plan administrator has analyzed the tax position taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
