We have audited the financial statements of Provident Savings Bank, F.S.B. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), for the year ended December 31, 2024, and we will issue our report thereon dated October 15, 2025. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated July 23, 2025. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Provident Savings Bank, F.S.B. Employee Stock Ownership Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing accounting policies were not changed during 2024. We noted no transactions entered into by the plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Management's estimate of the investments is based on fair value as described in Notes 2 and 4. We evaluated the key factors and assumptions used to develop the fair value estimates in determining that it is reasonable in relation to the financial statements taken as a whole.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements was:

The disclosure of Fair Value Measurements in Notes 2 and 4 to the financial statements. Although valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole.

Reportable Findings

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified the following reportable findings:

Distribution Overpayment: It was noted during our audit procedures that there were three employees who received duplicate distributions. This was due to an error made in the transition of third party administrators in the prior year. The company has subsequently made the Plan whole for the overpayment. We recommend procedures be put in place to ensure duplicate payments are not issued.

Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 15, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our

professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

It was noted that for some of the distributions selected for testing the share price used in the record-keeping for the stock distributions did not agree to the value of the shares for the day the shares were issued. We recommend that procedures be put in place to ensure that stock distributions are recorded at the proper share price.

Other Matters

With respect to the ERISA-required supplemental schedules accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the ERISA-required supplemental schedules to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

This information is intended solely for the use of the Plan Committee and management of the Provident Savings Bank, F.S.B. Employee Stock Ownership Plan and is not intended to be, and should not be, used by anyone other than these specified parties.

INDEPENDENT AUDITORS' REPORT

To the Trustees of the

Opinion

We have audited the accompanying financial statements of the Provident Savings Bank, F.S.B. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Provident Savings Bank, F.S.B. Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in its net assets available for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Provident Savings Bank, F.S.B. Employee Stock Ownership Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Provident Savings Bank, F.S.B. Employee Stock Ownership Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. NOTE 1 - DESCRIPTION AND BASIS OF PRESENTATION

The following description of the Provident Savings Bank, F.S.B. Employee Stock Ownership Plan (Plan) provides only general information. The Plan has been amended and restated effective January 1, 2022. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Provident Savings Bank, F.S.B (the Bank) established the Provident Saving Bank, F.S.B. Employee Stock Ownership Plan (the Plan), which commenced on June 27, 1996; upon completion of the initial public offering of common stock of the Bank's parent, Provident Financial Holding, Inc. (the Company). The Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with Sections 401(a), 4975(e)(7), and the regulations thereunder of the Internal Revenue Code 1986, as amended (the Code); subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by an Administrative Committee; comprising up to three persons appointed by the Bank's Board of Directors.

The Plan is unleveraged, and the Bank may discretionally contribute funds to the Plan for the purchase of Provident Financial Holdings, Inc., common shares to be allocated to the ESOP participants.

Eligibility

Employees of the Company are eligible to participate in the Plan on January 1 or July 1 of the plan year immediately following the completion of one year of service, as defined in the Plan; provided that they worked at least 1,000 hours during such plan year and are at least 21 years of age. Participants who have performed at least 1,000 hours of service and are employed on December 31 of the plan year, or who retired on or after attaining normal retirement age, died, or incurred a disability during such plan year are eligible for an allocation of employer contributions for the year.

Contributions

The Company may, at its discretion, make contributions to the Plan not to exceed the maximum amount deductible from the Company's income for federal tax purposes.

Payment of Benefits

The Plan provides for the distribution of the participant's account upon normal retirement, disability, death, or termination of employment. Distributions will commence during the year in which their normal retirement, disability, death or termination occurred. Distributions shall be made in the form of common shares of Provident Financial Holdings, Inc. plus cash for any fractional shares as a lump sum or in equal installments over a period not to exceed five years. If a participant's vested account balance does not exceed the cashout threshold, \$5,000 for the Plan year ending December 31, 2024, the plan administrator shall distribute the vested portion of his account balance as soon as administratively feasible without consent.

Administrative Expenses

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses for the Plan.

Voting Rights

Participants may direct the voting of shares of Provident Financial Holdings, Inc. common stock allocated to their accounts on any matter on which shareholders are allowed to vote. Allocated shares for which no voting instructions are received will be voted by the Trustee in the same proportion as shares for which the Trustee has received voting instructions.

Participant Accounts

Two accounts are maintained for each participant. The Company Stock Account (CSA) is credited annually with the participants' allocable shares of Company stock (including fractional shares) acquired by the Plan and the non-vested balances of terminated employees. The Other Investment Account (OIA) is credited annually with the participants' allocation of employer contributions and any income or expenses of the Plan. Employer contributions are allocated in proportion to the participants' compensation. Income and expenses are allocated in proportion to the participants' beginning balances in the OIA. In addition, a terminated participants' OIA may also be credited with other investments obtained from the conversion of employer stock.

Vesting

The vesting computation period is defined as a consecutive 12 month period used to measure Years of Vesting Service and Breaks in Service, and a participant is credited with one year when they complete 1,000 hours of service. As part of the amendment and restatement effective January 1, 2022, the vesting computation period for the plan was changed to be based on the Plan year. Prior to the 2022 Plan year, the vesting computation period was based on the "Employment Year", which is one year that begins on the participant's date of hire. Per DOL regulations, if the amendment to change vesting computation periods begins before the last day of the preceding vesting computation period, and an employee is credited with 1,000 hours of service in both the vesting computation period before the amendment and the first vesting computation period under the amended plan, they are credited with 2 years of service. As such, certain participants meeting these requirements received 2 years of vesting service for the 2022 Plan year.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to their account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution.

Forfeitures

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participants during the year ended December 31, 2024 totaled \$24,226. There were no forfeited non-vested accounts to be allocated to participant accounts in future years as of December 31, 2024 and 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that may affect the reporting amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from such estimates.

Investment Valuation and Income Recognition

The Plan's investment in Provident Financial Holdings, Inc. common stock and cash are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Cash and Cash Equivalents

The Plan considers highly liquid investments with an original maturity of three months or less to be cash and cash equivalents.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 - ADMINISTRATION OF PLAN ASSETS

The Plan's assets, which consist principally of Provident Financial Holdings, Inc. common stock, are held by the Employee Stock Ownership Trust.

Company contributions are managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers of the Bank. No such officer receives compensation from the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Common Stock: Investments in publicly-traded securities are valued at quoted market prices on the last business day of the Plan year.

Interest Bearing Cash: Fair value is based upon the carrying value given the short term nature of the highly liquid investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Bank believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. The Plan invests in Company common stock. This is a related party transaction for which a statutory exemption exists. The Bank paid certain administrative expenses of the Plan. These transactions qualify as party in interest transactions for which a statutory exemption exists.

NOTE 7 - PLAN TERMINATION

The Bank reserves the right to terminate the Plan at any time, subject to plan provisions. If the Plan is terminated, all participants will automatically vest 100% in their allocated shares. Upon termination of the Plan, the Bank may either liquidate the Trust or continue to pay benefits as they mature. If the Trust is liquidated, the net assets (after payment of expenses) will be allocated to participants in proportion to their account balances.

NOTE 8 - TAX STATUS

The Internal Revenue Service has determined and informed the Bank by a letter dated September 22, 2014 that the Plan and Trust established under the Plan is tax-exempt, under the appropriate section of the Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken a significant uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 15, 2024, the date the financial statements were available to be issued, and concluded that there were no events that require recording or disclosure in the financial statements as of December 31, 2024.
