### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Islands Restaurants 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Islands Restaurants 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan covers substantially all employees of Islands Restaurants, LLC (Company), and its affiliate CFBC, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Islands Restaurants, LLC is the Plan's Sponsor and serves as the Plan Administrator. The Plan Administrator is responsible for oversight of the Plan as well as determining and reviewing the appropriateness of the Plan's investment offerings, and investment performance.

The Plan is a defined contribution plan under the provision of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan became effective on July 1, 1996 and was restated effective January 1, 2022. In September 2023, the Company entered into an agreement with July Business Services (July) to provide Plan recordkeeping and administrative services. Charles Schwab Bank serves as Trustee of the Plan's assets.

**Eligibility**

Generally, an employee is eligible to participate in the Plan, for purposes of making voluntary salary deferral contributions, upon attaining age 21 and completing 3 months of service. Plan entry dates are January 1, April 1, July 1 or October 1 following the date eligibility requirements are met. An employee is eligible to participate in matching contributions upon completion of one year of service. A year of service is defined as the first twelve consecutive months of employment in which the employee has been credited with 1,000 or more hours of service. The entry date for matching contributions is the first day of the payroll period coinciding with or next following the date requirements are met.

**Participant Contributions**

Participants may contribute up to 75% of their annual compensation into a pre-tax deferral account and/or an after-tax Roth account up to the maximum allowed by the Internal Revenue Service (IRS) limitation. Participants may also contribute amounts representing distributions (rollovers) from other qualified plans.

**Employer Contributions**

The Company provided a discretionary matching contribution of 100% of the first 3% of employee contributions.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company contributions, (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

The Plan allows participants to borrow against their vested account balances. Loans may not be made for less than \$1,000 and may not exceed the lesser of \$50,000 or 50% of a participant's vested account balance. The interest rate for loans is based on the prime rate plus 1% as of the date the loan is processed. Principal and interest are paid ratably through payroll deductions not to exceed five years unless the note proceeds were used for the purchase of a principal residence. A participant may only have one outstanding loan at any time.

**Investments**

Participants direct the investment of all assets attributable to their account. Each participant designates the percentage of any one or more of their accounts that is to be invested in each of several authorized investment funds designated by the Plan Administrator.

**Payment of Benefits**

On termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive a lump-sum amount or paid as a direct rollover to an individual retirement account (IRA) or to another employer's tax qualified plan. Active participants may withdraw any part of their account in a single sum in the event of undue financial hardship or attainment of age 59 1/2. If a terminated participant's account is \$5,000 or less, the Plan may distribute the account balance to an IRA without prior approval of the participant.

**Vesting**

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution is based on years of continuous service. A participant is vested in the Company's matching contribution based on the following schedule:

**Forfeited Accounts**

Generally, a participant's unvested portion of the Company matching contribution is forfeited upon termination of employment. Forfeitures are maintained in a separate account and can be used to reduce matching contributions or pay Plan expenses.

The balance in the forfeiture account was \$1,992 and \$7,577 as of December 31, 2024 and 2023, respectively. During the year December 31, 2024, \$11,378 of forfeitures were used to pay Plan expenses.

**Administrative Expenses**

Administrative expenses of the Plan are deducted from participant accounts or non-vested forfeiture accounts and are included in these financial statements. Fees related to the administration of loans and distributions are deducted from the borrowing participant's account and are included in administrative expenses. All other administrative expenses are paid directly by the Company; therefore, are excluded from these financial statements.

Certain investment management fees and other charges paid to the investment providers are offset against fund performance in the net appreciation section of the Statement of Changes in Net Assets Available for Benefits and are not, therefore, separately reflected as investment expenses. The Plan utilizes a reimbursement spending account to collect third party investment management fees from participant accounts and periodically makes payments to investment advisors.

**Plan Termination Provision**

Although the Company has not expressed any intent to do so, it has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants become fully vested in their account balances.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting which is in accordance with accounting principles generally accepted in the United States of America (GAAP). Employee and employer contributions are recognized in the period that contributions are due.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that may affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are stated at fair value which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policy utilizing

information provided by the Trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Benefits to Participants**

Benefits are recorded when paid.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan payments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as deemed distribution based on the terms of the Plan documents.

### **NOTE 3 - FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described as follows:

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily closing price and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* The Plan invests in a stable value fund structured as a synthetic guaranteed investment contract (GIC) through a collective trust. The fund is designed to preserve principal and provide stable returns by investing in high-quality fixed income securities and utilizing wrap contracts issued by third-party financial institutions. These wrap contracts provide assurance that participant-initiated withdrawals will be made at contract value. The Plan is required to give 12 months irrevocable written notice of intent to redeem all or a portion of its participation. The underlying assets of the fund are owned by the Plan and valued at net asset value (NAV) per unit of the bank collective trust and is structured like mutual funds. The fair value of the fund is determined at the end of each day that markets are open, and the daily value is used for both buying and selling shares of the collective trusts. Since NAV is a readily determinable value, it is included in the fair value hierarchy.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Charles Schwab Bank, the Trustee of the Plan; therefore, these transactions are considered to be exempt party-in-interest transactions. Administrative expenses paid by the Plan to Charles Schwab Bank and other service providers are considered to be exempt party-in-interest transactions.

**NOTE 6 - TAX STATUS**

The IRS has informed the Plan sponsor, by a letter dated June 30, 2020 for the prototype plan adopted by the Plan, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investments securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

**NOTE 8 - CORRECTIVE DISTRIBUTION PAYABLE**

At December 31, 2024 and 2023, a liability of \$27,427 and \$30,213, respectively, was recorded for amounts refundable to participants for contributions that exceeded limits imposed by IRS nondiscrimination requirements.
