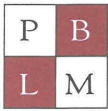

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Turenne & Associates, LLC and Affiliates 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Note A - Description of the Plan

The following description of the Turenne & Associates, LLC and Affiliates 401(k) Plan (the “Plan”) provides only general information. For a more complete description of the Plan’s provisions, refer to the agreement governing the Plan (the Plan document).

General

The Plan is established to provide retirement benefits to eligible employees of Turenne & Associates, LLC (the “Employer”) and the following affiliated companies: Capitol Hill Healthcare, Inc., McGuffey Healthcare Center, Turenne Pharmedco, Turenne Pharmedco TN and Westside Terrace, LLC. The Plan document provides for allocation provisions and the disposition of forfeitures. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Eligibility

Employees are eligible to participate in the Plan after completing six months of service and attainment of age 21. Plan entry is January 1 or July 1 following satisfaction of age and service requirements. The Plan is referred to as a “qualified automatic contribution arrangement 401(k) plan” also know as a “QACA”. This safe harbor plan includes an automatic salary deferral feature. The employer will automatically withhold a portion of the participant’s compensation from each payroll period and contribute that amount to the Plan as a salary deferral. The automatic deferral provisions apply to all participants, except those who had a salary deferral agreement in effect on the automatic deferral provisions effective date.

Contributions

Contributions to the Plan may consist of employee elective deferral contributions, safe harbor matching contributions, employer matching contributions, employer profit-sharing contributions and rollover contributions. The employee elective deferral contributions for each plan year cannot be less than 1% of compensation or more than the limits provided by the Internal Revenue Code. If a participant was age 50 or over, an additional “catch-up” contribution can be made. Safe harbor employer matching contributions are made at 100% of the salary deferrals that do not exceed 1% of the participant’s compensation plus 50% of the salary deferrals between 1% and 6% of the participant’s compensation. At the Employer’s discretion, a matching contribution and a profit-sharing contribution can be made. No discretionary matching or profit-sharing contributions were made for 2024.

Participant Accounts

Voya (2024) and Nationwide Financial (2023) hold Plan assets and execute investment transactions as directed. Participants direct their investments among a selection of mutual funds and guaranteed investment accounts. Participant accounts are credited with the participant's contributions, allocations of the Employer's contributions, Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their employee contributions and rollover contributions. Safe harbor employer contributions are 100% vested after two years of service, plus actual earnings thereon. Employer matching and profit-sharing contributions become fully vested upon normal retirement, disability, death or upon the completion of three years of credited service.

Forfeitures

When certain terminations of participants in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents forfeitures. Forfeitures are used to reduce employer matching contributions for the plan year following that in which the forfeitures occurred. Forfeited accounts totaled \$127,212 and \$84,262 as of December 31, 2024 and 2023, respectively.

Benefits

The benefit to which a plan participant is entitled is the benefit that can be provided by the contributions and income thereon (including net realized and unrealized investment gains and losses) allocated proportionately to the participant's individual account. Upon retirement, disability, attainment of age 59 ½, death or termination of employment, participants may elect to receive the accumulated value of their account in a lump sum distribution or periodic installments.

Note B - Summary of Significant Accounting Policies**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis and have been prepared in conformity with accounting principles generally accepted in the United States of America.

Financial Statement Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Accordingly, actual results could differ from those estimates.

Investments and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are recorded at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements. The investments in the Voya Fixed Account and the Nationwide Indexed Fixed Account are reported at contract value. See Note E for discussion of investments reported at contract value.

The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains (losses) and the unrealized appreciation (depreciation) on those investments. Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date.

Contributions

Participant contributions are accrued as additions in the year in which they are deducted from the participants' salaries. Employer contributions are accrued as additions in the plan year for which the Employer's board of directors approve such contributions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

Administrative fees may include Plan administration fees, investment management fees and/or transaction-based fees. Some administration fees are paid by the Company and are not charged to the Plan. Fees of \$120,389 were paid by participants in 2024 and are reflected in the statement of changes in net assets available for benefits. Investment management fees on mutual funds are typically reflected as a reduction in the respective fund's net asset value and are paid by the participants.

Evaluation of Subsequent Events

The Plan Sponsor has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued and concluded no events or transactions occurred during that period requiring recognition or disclosure.

Note C - Information Prepared and Certified by the Custodian (Unaudited)

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by Voya and Nationwide Financial Services. As permitted by 29 CFR 2520.103-8 of Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the auditors not to perform, and they did not perform, any auditing procedures with respect to this information except for comparing the information with the related information included in the financial statements and supplemental schedule.

Note D - Fair Value Measurements

FASB ASC Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis and recognized in the accompanying statement of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy.

Mutual Funds - Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with the other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table presents the fair value measurements of assets recognized in the accompanying statement of net assets available for benefits measured at fair value on a recurring basis and the level within the fair value hierarchy in which the fair value measurements are reported:

Note E - Fully Benefit-Responsive Investment Contract

The Plan holds investments in the Voya Fixed Account in 2024 and the Nationwide Indexed Fixed Contract in 2023. These accounts are guaranteed insurance contracts that guarantee a return of principal plus interest as stated in the contract. Per GAAP, investments held by an investment company are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of net assets attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the underlying defined contribution plan. Generally, the term “fully benefit-responsive” describes the contract’s guarantee that (1) the crediting rate provided under the contract will not fall below zero and (2) participant-initiated withdrawals from the fund will be covered at contract value. The Fixed Accounts are fully benefit responsive and are reported at contract value in the statement of net assets available for benefits.

The Indexed Fixed contract is a guaranteed return contract with a quarterly interest rate guarantee that is based upon the three or five-year Treasury Note yield. The interest earned in this contract can change quarterly if the yield on the three or five-year Treasury Note index changes. The fixed crediting rate is reset quarterly by Nationwide. The net rate, crediting rate and average yield earned on the contract are the same. The Indexed Fixed contract does not have a maturity date. The provisions do not provide for a distribution at book value at some specified future date. The Indexed Fixed contract continues in force until all assets have been distributed, or no further payments are due.

Certain events could limit the ability of the Plan to transact at contract value with the issuer. No events are probable of occurring that might limit the ability of the Plan to transact at contract value and that would also limit the ability of the Plan to transact at contract value with participants.

Note F - Related Party and Party in Interest Transactions

The Company’s Chief Financial Officer is a participant and acts as the Plan administrator. Also, two of the Company’s officers, who are shareholders, have elected to participate by making elective salary reductions and receive employer safe harbor matching contributions; these

officers are also Plan Trustees. Also, certain investments are guaranteed interest accounts and mutual funds managed by Nationwide Financial, the service provider as defined by the Plan. Therefore, these transactions qualify as party in interest.

Note G - Plan Termination

Although it has not expressed any intent to do so, the Employer retains the right to amend or terminate the Plan at any time subject to the provisions of ERISA. No amendment may permit any Plan assets to revert to the Employer or be used for any purpose other than to provide benefits to participants and their beneficiaries, reduce a participant's accrued benefit, or eliminate an optional form of benefit payment. Upon termination of the Plan, all participant accounts will become fully vested.

Note H - Income Tax Status

The Plan adopted a prototype non-standardized 401(k) plan approved by the Internal Revenue Service (IRS). The Plan administrator believes the Plan is designed and operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan follows accounting standards relating to uncertainty of income tax positions. The Plan administrator assessed whether there were any uncertain tax positions that may give rise to income tax liabilities and determined that there were no such matters requiring recognition in the accompanying financial statements. The Plan files information returns under U.S. federal jurisdiction. With few exceptions, the Plan is no longer subject to U.S. federal tax examinations for years before 2022.

Note I - Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the values of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
