We have performed an audit of the financial statements of Museum of Discovery and Science Inc 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

## **Note 1. Plan Description**

The following description of Museum of Discovery and Science Inc 401(k) Plan (the “Plan”), as amended, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

### ***General***

The Plan, which was created on January 1, 2022, is a safe harbor 401(k) plan for employees of the Museum of Discovery and Science Inc. (the “Company” or “Plan Sponsor”) who adopt participation in the Plan. Employees are eligible to participate in the Plan after reaching the age of 18 and have completed at least three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Management is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### ***Contributions***

Each year, participants may elect to contribute up to 90% of eligible earnings, as defined by the Plan, through a salary reduction agreement. The Plan provides for an automatic enrollment feature, whereby eligible employees who do not specifically opt out of the Plan will be automatically enrolled in the Plan at a deferral rate of 5% of eligible compensation. The Company makes a safe harbor matching contribution equal to 100% of participant’s salary deferral for the first 3% of their compensation plus 50% of the participant's salary deferrals on the next 2% of the participant's compensation. The Company made contributions of approximately \$184,000 for the year ended December 31, 2024. The Company may also make discretionary profit sharing contributions to the Plan. No profit sharing contributions were made during the year ended December 31, 2024. Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Participants direct the investment of their accounts into various investment options offered by the Plan. Investment account options available include a common/collective trust and registered investment companies.

### ***Participant Accounts***

Under the Plan, a separate account is maintained for each participant. Each participant’s account is credited with the participant’s contributions, employer contributions, and allocations of Plan earnings, and charged with an allocation of administrative expenses, if any. Participant contributions and employer matching contributions are allocated, at the participant’s election, to investment funds held with Reliance Trust Company (the “Plan Custodian”). Participants may change their investment options at any time with certain exceptions. Plan earnings are allocated based on the actual earnings of the respective participants’ investments.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance not to exceed \$50,000 by executing a note in accordance with the Plan’s provisions. The notes are collateralized by the balance in the participant’s account and bear interest at rates ranging from 9.75% - 10.50%. The loan interest rate, determined monthly, is set at 2% above the prime rate, as defined. A participant may have a maximum of two loans outstanding at any time, and the loans must be generally repaid within five years from the date of the loan. Principal and interest are paid ratably through payroll deductions.

***Vesting***

Participants are immediately vested in their own contributions, rollover, and employer contribution accounts, plus actual earnings thereon.

***Payment of Benefits***

Distribution of benefits may be made in a lump-sum cash payment. As of December 31, 2024, there were no amounts allocated to the accounts of individuals who have elected to withdraw from the Plan but have not been paid.

**Note 2. Summary of Significant Accounting Policies**

The following is a summary of significant accounting policies followed in the preparation of these financial statements, which have been prepared in accordance with accounting principles generally accepted in the United States of America.

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value and are invested in common/ collective trust funds and registered investment company fund vehicles. Investments held in registered investment companies are valued at the daily closing price, as reported by the fund. The registered investment company funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment company funds held by the Plan are deemed to be actively traded and are considered Level 1 investments within the fair value hierarchy (see Note 4).

The Invesco Stable Asset Fund (the "Invesco Fund") is held in a common/collective trust. The underlying investments in the Invesco Fund are securities for which market quotations are readily available, are valued based on the last trade from the primary exchange. For listed securities for which no sales were reported, the closing bid price may be used. For all other securities, the Fund Trustee may use the indicator of fair value provided by an external pricing vendor in connection with determining the fair value of such security. The Invesco Fund is considered a Level 2 investment within the fair value hierarchy (see Note 4).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses are calculated on a historical moving average cost basis.

In accordance with the Plan's policy of stating marketable securities at fair value, realized and unrealized gains and losses are included in the statement of changes in net assets available for benefits as net appreciation in fair value of investments.

***Notes Receivable from Participants***

Notes receivable from participants are recorded at their unpaid principal balance, plus accrued but unpaid interest. Interest income is recorded on the accrual basis.

***Contributions***

Contributions to the Plan are recorded in the period in which they become obligations of the Plan Sponsor.

***Payment of Benefits***

Benefit payments to participants are recorded when paid.

***Administration Expenses***

The Plan's administrative expenses are shared by the Plan and the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, revenues, and expenses, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Subsequent Events***

The Plan Sponsor has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued.

**Note 3. Plan Certification**

The Plan Custodian holds the Plan's investments and executes all investment transactions. All investment and participant loan information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants at December 31, 2024, net appreciation in fair value of investments, and interest and dividends for the year then ended was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Plan Custodian.

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Custodian has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024.
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

**Note 4. Fair Value Measurements**

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritize the inputs of valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The three levels of the fair value hierarchy are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### **Note 5. Exempt Party-In-Interest Transactions**

Certain plan investments are funds managed by the Plan Custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. During 2024, administrative, advisory services, and other custodian costs associated with investment accounts of approximately \$7,400 were charged directly to the Plan. The Company also absorbs significant costs related to various administrative and investment advisory services on behalf of the Plan.

### **Note 6. Risks and Uncertainties**

The Plan's investments are not insured and are subject to credit and market risks. Financial information relating to those investments is included in these financial statements based on information provided by the Plan Custodian.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 7. Income Tax Status**

The original Plan is a prototype plan prepared and maintained by a third party. The prototype plan obtained its latest determination letter on December 31, 2018, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### **Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and the Plan assets shall be distributed in proportion to participants' respective account balances as of the date of termination.
