### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Jensen Precast 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1: Description of Plan**

The following brief description of the Jensen Precast 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

**General**

The Plan is a participant directed defined contribution plan established effective December 1, 1987, for eligible employees of Jensen Enterprises, Inc. dba Jensen Precast (the Company). This Plan is available to all eligible employees of the Company who are not included in a collective bargaining unit. Employees must be 20 years of age to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees meeting the eligibility requirements are automatically enrolled in the Plan. Participants who are automatically enrolled defer 3% of their earnings as contributions to the Plan. The automatic deferral amount will increase each Plan Year by 1% up to 100%. Automatically enrolled employees may opt out of the automatic enrollment if they choose to not participate in the Plan or if they want to contribute a different percentage of their earnings or change the way their contributions are being allocated within the Plan.

**Contributions**

The Plan provides that participants may contribute up to 100% of their eligible compensation, subject to Internal Revenue Code (IRC) limitations, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may make a matching contribution at the discretion of the Plan trustee. The participant must work at least 1,000 hours of service and be employed as of the last day of the Plan year to receive Company matching contributions.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, and allocations of the Company's contributions, net earnings from investments and changes in investment values, and administrative expenses. Allocations are based on participant earnings and account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Contributions by the Company that are forfeited by participants due to termination are used by the Company to fund future Company matching contributions.

**Vesting**

Participants are always fully vested in their own contributions and vest in Company contributions 20 percent each year of credited service. After five years of service, participants are fully vested in Company contributions.

**Forfeitures**

Forfeitures can be used to pay for Plan expenses or reduce employer contributions when available. At December 31, 2024 and 2023, forfeitures available to pay plan expenses were \$67,450 and \$54,965, respectively. During the year ended December 31, 2024, \$35,052 in forfeitures were used.

**Payment of Benefits**

Participants may make withdrawals from the Plan upon reaching age 59½ or in certain cases of financial hardship. Additionally, participant balances are normally distributed to the participant or his or her beneficiary at the time of retirement, disability, or death. Upon termination of service, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms are limited to 5 years, except for loans used to finance the purchase of a principal residence. Loans bear interest at rates determined by the Company, and remain fixed throughout the life of the loans. Principal and interest are paid ratably through payroll deductions. The loans are secured by the balance in the participant's account.

**Administrative Expenses**

The Company, as Plan sponsor, pays certain administrative expenses on behalf of the Plan. Participant's accounts are adjusted for fees pertaining to loan or termination processing, and are charged for expenses incurred by the custodian in the performance of their duties.

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition**

Investments are stated at fair value as certified by the Plan's custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Use of Estimates**

In preparing the financial statements in accordance with accounting principles generally accepted in the United States of America, management makes estimates and assumptions which affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Subsequent Events**

In preparing the accompanying financial statements, management has considered events that have occurred after December 31, 2024, through October 2, 2025, the date these financial statements were available for issuance. Except as disclosed in Note 10, as of such date, management was not aware of any subsequent events requiring additional disclosure.

**Note 3: Information Certified by the Custodians**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the custodian of the Plan).

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1) Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2) Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3) Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage account:* Valued at the combined daily closing prices of the underlying assets of the account. The account is made up of stocks, ETFs, fixed income products, and mutual funds which are traded on the open market and are deemed to be actively traded.

**Note 5: Guaranteed Interest Contract With Insurance Company**

The Plan entered into a fully benefit-responsive guaranteed interest contract with Massachusetts Mutual Life Insurance Company (MassMutual). MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest contract. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The guaranteed interest contracts are included in the financial statements at fair value, which is equal to contract value.

**Note 6:**      **Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right to suspend its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, all participants shall become fully vested and non-forfeitable, and the Plan administrator will distribute to the participants all assets remaining in the Plan as of the date of such termination, less any expenses chargeable to the Plan.

**Note 7:**      **Tax Status**

On June 30, 2020, the IRS stated that the non-standardized pre-approved plan adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8:**      **Party-In-Interest Transactions**

Certain Plan investments include shares of registered investment company funds that are currently managed by Empower Trust Company, LLC. As Empower Trust Company, LLC is the custodian of the Plan, transactions with this entity qualify as exempt party-in-interest transactions.

**Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 10: Excess Contributions Payable**

The Plan failed the discrimination testing for the years ended December 31, 2024 and 2023. Excess contributions amounting to \$69,622 and \$39,724 are recorded as liabilities on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, respectively, and as a reduction of participant contributions for each year respectively. The Plan distributed these excess contributions during 2025 and 2024, respectively.

The financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP), which differ from the reporting requirements of the Department of Labor's Form 5500. Specifically, excess participant contributions, including related earnings, identified during the plan year and subsequently refunded to participants, are not reported as contributions in the financial statements under US GAAP. Instead, these amounts are recorded as a liability and reduce participant contributions for the year.
