Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Innovative Livestock Services, Inc. Employees Savings Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF THE PLAN

The following description of the Innovative Livestock Services, Inc. Employees Savings Trust (Plan) provides only general information. Participants should refer to the Plan Document or Summary Plan Description (SPD) for a more complete description of the Plan's provisions. The Retirement Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investments offerings and monitors investment performance.

General - The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), covering all employees, except union and leased employees, of Innovative Livestock Services, Inc. (Company) and its subsidiaries Ag Systems, Inc., Alfalfa Pellets, LLC, Barton County Feeders, Inc., Beef Marketing Group Cooperative, Inc., Dillwyn Feedyard, GK Environmental Services, Great Bend Feeding, Inc., ILS Farm Partnership, Knight Feedlot, Inc., Mull Farms and Feeding, Nebraska ILS Feeders, and Ward Feed Yard. Employees become eligible to participate in the Plan upon completion of six months of service and are at least 20 years old. Eligible employees can become participants in the Plan as of the first day of the month subsequent to when eligibility requirements are met.

Contributions - The Plan provides that active participants may make salary deferral contributions on a pre-tax, after-tax or a combination thereof to the Plan, up to the maximum amount allowed by law (\$23,000 for 2024), as adjusted for applicable percentages of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as adjusted by the Internal Revenue Service (IRS) (\$7,500 for 2024). Employee rollover contributions are also permitted. The Company makes a 3% safe harbor non-elective contribution to all eligible employees. The Company may also contribute a discretionary profit-sharing amount or give a discretionary match for an amount up to a maximum of 4% of compensation.

The Plan utilizes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contribution invested in a designated balance fund until changed by the participant.

Participant Accounts - Each participant's account is credited with the participant's salary deferral contribution and an allocation of the Company's contributions, Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions plus earnings thereon. Participants become vested in the Company's safe harbor contributions and discretionary contributions at a rate of 20% per year and are fully vested after five years or upon death or total and permanent disability.

Payment of Benefits - Upon termination of service due to death, disability or retirement, a participant may receive the value of the vested interest in his or her account as a single lump-sum payment, installments over a period of not more than his or her life expectancy or partial withdrawals. Participants with vested balances of \$5,000 or less may be automatically paid out upon termination.

Forfeited Accounts - At December 31, 2024 and 2023, forfeitures of non-vested accounts totaled \$0. These amounts are to be used to reduce future employer contributions in the following year. In 2024, the Company used forfeitures in the amount of \$19,382 to offset employer contributions.

Normal Retirement Age - Normal retirement age is 59½.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and the Use of Estimates - The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect: (1) the reported amounts of assets and liabilities, (2) disclosures such as contingencies, and (3) the reported amounts of revenues and expenses included in such financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition - Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's retirement committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors. The purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Contributions - Contributions from Plan participants and the Company matching contributions are recorded in the year in which the participant contributions are withheld from compensation.

Benefit Payments - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of the Plan may be paid directly by the Company and are therefore excluded from these financial statements. Some investment related expenses may be included in net change in fair value of investments.

Subsequent Events - These financial statements considered subsequent events through October 15, 2025, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY AMERICAN UNITED LIFE INSURANCE COMPANY (UNAUDITED)

4. INVESTMENTS AND FAIR VALUE MEASUREMENTS

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The following describes three levels of inputs that may be used to measure fair value:

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Separate Accounts - The plan invest in separate accounts maintained by AUL. Each separate account invests in underlying mutual funds and the value of the plans interest in the separate account is based on the fair value of the underlying investments. Fair value is determined by AUL based on the net asset value of the underlying mutual fund units as of the reporting date.

Self-Directed Brokerage Accounts - Accounts primarily consist of mutual funds and common stocks that are valued on a basis of readily determinable marketable values per quoted prices in an active market.

5. INVESTMENT AT CONTRACT VALUE

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with AUL totaling \$1,638,837 and \$1,533,198 at December 31, 2024 and 2023, respectively. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant

withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan assets are managed by AUL (party-in-interest) and therefore, these transactions qualify as party-in-interest transactions. Total fees incurred and paid directly by the Plan for investment management and other services were \$116,611. The various funds' operating expense ratios ranged from 0.05% to 0.74% as of December 31, 2024.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of termination of the Plan, the interests of the participants in the Plan shall be fully vested at the time of termination and AUL shall liquidate all assets of the Plan and continue to administer the Plan in accordance with its provisions until all obligations have been satisfied.

8. TAX STATUS

The Plan adopted a Non-Standardized Pre-Approved Profit-Sharing Plan (pre-approved plan). The Plan has obtained a copy of a favorable determination letter for the pre-approved plan dated June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections

of the Internal Revenue Code (IRC). The Plan is relying on this determination letter. Although the Plan may have been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management evaluated the Plan's tax positions and concluded that it had taken no uncertain tax positions that require recognition or disclosure in the financial statements. No provision or liability for income taxes has been included in the financial statements.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. PROHIBITED TRANSACTIONS

For the period ended December 31, 2024 and 2023, contributions of \$25,765 and \$82, respectively, were not deposited within the required timeframe, as stated and interpreted by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. The employer has corrected the 2023 deposits in 2024 and will correct the 2024 contributions and pay the applicable lost earnings in 2025.
