We have performed audits of the accompanying financial statements of Heritage Millworks, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). NOTE 1 - DESCRIPTION OF PLAN

The following description of the Heritage Millworks, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document, which is available from plan management, for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The plan administrator is responsible for oversight of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility: Employees generally become eligible to participate in the Plan after reaching the age of 18 and having completed six months of consecutive service for all types of contributions other than employer profit sharing contributions which require one year of consecutive service. Service requirements are 1,000 hours for employer profit sharing contributions and 500 hours for all other contribution types. Entry dates are monthly on the first day of each month after meeting eligibility requirements.

Contributions: Each year, participants may contribute up to 92% of their pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Employer matching contributions are 100% of the first 4% of employee contributions. The Employer may also make an annual discretionary match and/or profit-sharing contribution. No discretionary contributions were made in 2024 and 2023. Contributions are subject to certain IRS limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and employer matching contributions, as well as allocations of the employer profit-sharing contributions and plan earnings. Participant accounts are charged with an allocation of investment expenses that are paid by the Plan. Allocations are based on account balances or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the employer matching contributions and discretionary profit-sharing contributions and earnings on those contributions are based on years of service. Employer matching and profit-sharing contributions have a graduated vesting of 25% after one year of service, and 50% after two years of service, 75% after three years of service and 100% after four years of service.

Payment of Benefits: On termination of service due to death, disability, retirement, termination of employment, or attaining normal retirement age, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. The Plan specifically restricts the timing and method of benefit payments based upon the participant's age, length of service, account value, and reason for termination.

Notes Receivable from Participants: Participants may borrow between \$1,000 and \$50,000, not to exceed 50% of their vested account balance. Notes are repayable over a maximum period of five years unless the loan is used for the purchase of a principal residence, in which case a maximum ten-year repayment is permitted. Participants may only have one outstanding note at any given time. Notes bear interest on the unpaid principal at a rate commensurate with local prevailing rates as determined by the plan administrator.

NOTE 1 - DESCRIPTION OF PLAN - continued

Forfeitures - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1 and \$1, respectively. Forfeited accounts will be used to reduce future employer contributions, pay Plan expenses, or any other permissible method. A total of \$1,048 and \$335 in forfeitures were used to offset employer contributions in 2024 and 2023, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation (depreciation) of the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Participants' contributions are recorded by the Plan as of the date such participants' elected contributions are withheld by the Company.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. There were no notes receivable as of December 31, 2024 and 2023.

Operating Expenses

Substantially all administrative expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Date of Management's Review

Subsequent events were evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - UNAUDITED INFORMATION CERTIFIED BY TRUSTEE

All investment information disclosed in the accompanying financial statements and supplementary information, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and investment income for the years ended December 31, 2024 and 2023 was obtained or derived from information provided to plan management and certified as complete and accurate by Mid Atlantic Trust Company, the custodian of the Plan. This information has not been audited by independent accountants.

NOTE 4 – FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan may be paid directly by the Company. Mid Atlantic Trust Company is the Plan’s trustee and record keeper and, therefore, these transactions and the Plan’s payment of trustee fees, record keeping fees, and any investment management fees to Mid Atlantic Trust Company and its affiliates qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions. No officer or employee receives compensation from the Plan.

NOTE 6 - INCOME TAX STATUS OF THE PLAN

The Plan uses a prototype plan document sponsored by Paychex, Inc. who received an opinion letter from the Internal Revenue Service (IRS), dated August 31, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan has analyzed its tax positions taken and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is generally subject to income tax examinations for three years after filing.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan provides for various participant-directed investment options, which are exposed to various risks, such as interest rate, credit risks and market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Heritage Millworks, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document, which is available from plan management, for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The plan administrator is responsible for oversight of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility: Employees generally become eligible to participate in the Plan after reaching the age of 18 and having completed six months of consecutive service for all types of contributions other than employer profit sharing contributions which require one year of consecutive service. Service requirements are 1,000 hours for employer profit sharing contributions and 500 hours for all other contribution types. Entry dates are monthly on the first day of each month after meeting eligibility requirements.

Contributions: Each year, participants may contribute up to 92% of their pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Employer matching contributions are 100% of the first 4% of employee contributions. The Employer may also make an annual discretionary match and/or profit-sharing contribution. No discretionary contributions were made in 2024 and 2023. Contributions are subject to certain IRS limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and employer matching contributions, as well as allocations of the employer profit-sharing contributions and plan earnings. Participant accounts are charged with an allocation of investment expenses that are paid by the Plan. Allocations are based on account balances or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the employer matching contributions and discretionary profit-sharing contributions and earnings on those contributions are based on years of service. Employer matching and profit-sharing contributions have a graduated vesting of 25% after one year of service, and 50% after two years of service, 75% after three years of service and 100% after four years of service.

Payment of Benefits: On termination of service due to death, disability, retirement, termination of employment, or attaining normal retirement age, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. The Plan specifically restricts the timing and method of benefit payments based upon the participant's age, length of service, account value, and reason for termination.

Notes Receivable from Participants: Participants may borrow between \$1,000 and \$50,000, not to exceed 50% of their vested account balance. Notes are repayable over a maximum period of five years unless the loan is used for the purchase of a principal residence, in which case a maximum ten-year repayment is permitted. Participants may only have one outstanding note at any given time. Notes bear interest on the unpaid principal at a rate commensurate with local prevailing rates as determined by the plan administrator.

NOTE 1 - DESCRIPTION OF PLAN - continued

Forfeitures - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1 and \$1, respectively. Forfeited accounts will be used to reduce future employer contributions, pay Plan expenses, or any other permissible method. A total of \$1,048 and \$335 in forfeitures were used to offset employer contributions in 2024 and 2023, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation (depreciation) of the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Participants' contributions are recorded by the Plan as of the date such participants' elected contributions are withheld by the Company.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. There were no notes receivable as of December 31, 2024 and 2023.

Operating Expenses

Substantially all administrative expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Date of Management's Review

Subsequent events were evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - UNAUDITED INFORMATION CERTIFIED BY TRUSTEE

All investment information disclosed in the accompanying financial statements and supplementary information, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and investment income for the years ended December 31, 2024 and 2023 was obtained or derived from information provided to plan management and certified as complete and accurate by Mid Atlantic Trust Company, the custodian of the Plan. This information has not been audited by independent accountants.

NOTE 4 – FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan may be paid directly by the Company. Mid Atlantic Trust Company is the Plan’s trustee and record keeper and, therefore, these transactions and the Plan’s payment of trustee fees, record keeping fees, and any investment management fees to Mid Atlantic Trust Company and its affiliates qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions. No officer or employee receives compensation from the Plan.

NOTE 6 - INCOME TAX STATUS OF THE PLAN

The Plan uses a prototype plan document sponsored by Paychex, Inc. who received an opinion letter from the Internal Revenue Service (IRS), dated August 31, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan has analyzed its tax positions taken and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is generally subject to income tax examinations for three years after filing.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan provides for various participant-directed investment options, which are exposed to various risks, such as interest rate, credit risks and market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.
