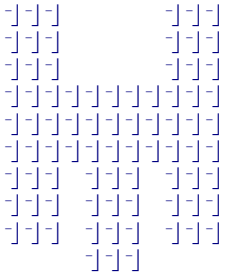

INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of
Palm Beach Orthopaedic Institute, P.A. 401(k) Plan
Palm Beach Gardens, Florida

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Palm Beach Orthopaedic Institute, P.A. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets held for investment purposes as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. **Description of Plan**

The following description of Palm Beach Orthopaedic Institute, P.A. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- a) *General* – The Plan is a defined contribution plan covering all employees of Palm Beach Orthopaedic Institute, P.A. (the "Company" and "Plan Sponsor"), except employees covered under a collective bargaining agreement, non-resident aliens, and leased employees, who have attained 21 years of age and provided at least one year of service to the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was formed on January 1, 1993, and most recently restated effective July 31, 2022 as required by the Internal Revenue Service's (IRS) restatement cycle.
- b) *Plan Administration* – The Plan is administered by employees of the Company. As of December 31, 2024, the Plan's trustee and custodian is Fidelity Management Trust Company (Fidelity Trust). Fidelity Workplace Services is the third-party administrator and provides management and recordkeeping to the Plan.

As of December 31, 2023, the Plan's trustee and custodian was John Hancock Trust Company (John Hancock). John Hancock Retirement Plan Services LLC provided recordkeeping services to the Plan, as well as a platform of investment alternatives. N.A. Falcon & Associates, Inc. was the third-party administrator.

- c) *Contributions* – Each year participants may contribute up to 100% of pretax annual compensation, as defined in the Plan and as subject to limitations defined by the Internal Revenue Code. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified plans. The Company may annually elect to make matching and/or profit-sharing contributions. In order to be eligible for the matching contributions, the participant must have been employed for at least one year and still be employed on the last day of the year. In order to be eligible for the profit-sharing contributions, the participant must have completed at least 500 hours of service, or still be employed on the last day of the year. For the year ended December 31, 2024, the Company did not make any matching contributions, but did make a profit-sharing contribution of \$1,088,159.
- d) *Participant Accounts* – Each participant's account is credited with the participant's contribution, the employer's contribution, Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan.
- e) *Vesting* – Participants are immediately vested in their salary deferral contributions and rollovers, plus actual earnings thereon. Vesting in the Company's contributions is based on years of credited service. A participant becomes 100% vested in such contributions after 6 years of credited service or immediately upon death or disability.
- f) *Administrative Expenses* – Individual participants pay loan and investment fees. Other fees and administrative costs associated with Plan operations and compliance are paid first from forfeitures and then from Plan Assets.

1. **Description of Plan, continued**

- g) *Investment Options* – Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options offered in the Fidelity Trust program and determined by the Plan Administrator. Participants may change their investment options via phone or internet access to Fidelity Trust at any time.
- h) *Participant Notes Receivable* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their individual vested account balance. Participants may have no more than one loan outstanding at any one time. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loans fund. Loan terms range from 1-5 years. Loans made for the purchase of a primary residence may extend beyond 5 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the loan administrator at the time the loan is taken (currently Prime Rate plus 2%). The interest rate on participant loans receivable as of December 31, 2024 and 2023 range from 5.25% to 10.50%. Principal and interest is paid ratably through bi-weekly payroll deductions. Participant loans are reported at their unpaid principal balances plus any accrued interest. The loan balances are secured by the participants' investment accounts, therefore, no allowance for uncollectible loans was deemed necessary. For purposes of presentation on the schedule of assets held for investment purposes, the participant notes receivable are presented as part of the investments in the Form 5500 and are referred to as participant loans.
- i) *Payments of Benefits* – Upon retirement, disability, death, or termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions are permitted for employees attaining age 59 ½. Hardship distributions are also permitted from all accounts that are fully vested.
- j) *Forfeited Accounts* – Forfeitures on non-vested accounts may be used to pay plan expenses or to reduce future employer contributions. During the year ended December 31, 2024, \$75,323 was forfeited by employees, \$40,000 was used to reduce profit-sharing contributions, and \$35,980 was applied to administrative fees. There was \$58,321 and \$55,912 of forfeited non-vested accounts as of December 31, 2024 and 2023, respectively.

2. **Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

- a) *Basis of Accounting* – The accompanying financial statements are prepared on the accrual basis of accounting.
- b) *Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. **Summary of Significant Accounting Policies, continued**

- c) *Valuation of Investments and Income Recognition* – Investments in registered investment companies (i.e., mutual funds) are valued at fair value as determined from quoted market prices, if available, of a national securities exchange on the last business day of the year. Investment options that do not have readily available market quotations are valued according to quotations from the trustees. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.
- d) *Payment of Benefits* – Benefits are recorded when paid.
- e) *Plan Risk and Uncertainties* – The Plan and the Plan assets are sensitive to economic pressures prevalent in the investment market. The pressures primarily stem from interest rates, market and credit risk and their effect on bond rates, mortgage rates, the value of real estate, stock prices, and the overall stability of the market. Additionally, the financial position of the Plan Sponsor, Palm Beach Orthopaedic Institute, P.A., may have a significant impact on the Plan. Specifically, these include the ability of the Plan Sponsor to continue to make contributions to the Plan and/or the stability of the Plan Sponsor's operations. Other external factors which may affect the Plan, and the Plan assets, include legislation or regulations established by the Internal Revenue Service, ERISA, and/or Department of Labor (DOL).

3. **Fair Value Measurements**

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

3. Fair Value Measurements, continued

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following descriptions provide the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024:

- a) *Interest-bearing cash* – Valued at quoted market price of a national security exchange on the last business day of the year, of units held by the Plan at year end.
- b) *Common collective trusts* – Valued at the net asset value (NAV), as quoted by the investment manager, of shares held by the plan at year-end. In this instance the NAV is used as practical expedient to estimate fair value.
- c) *Mutual funds* – Valued at quoted market price of a national security exchange on the last business day of the year, of units held by the Plan at year end.

4. Information Certified by the Plan's Trustees

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Trust and John Hancock Trust, the trustees, have certified as of December 31, 2024 and 2023, respectively, that the data included in the accompanying financial statements and supplemental schedule is complete and accurate. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Tax Status

The Plan is utilizing a Non-Standardized Pre-Approved Profit Sharing Plan document (Profit Sharing Plan), provided by Fidelity Trust. The Plan reflects the implementation of the recent legislative changes in the regulations governing qualified tax-deferred arrangements via the IRS's Cycle 3 restatement. The restated Profit Sharing Plan received an opinion letter from the Internal Revenue Service dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although the Company intends the Plan to be permanent and continuing, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and accrued benefits, to the extent funded or required to be funded, must be distributed to the participants.

7. Subsequent Events

The Plan's management has evaluated subsequent events through October 15, 2025, the date on which the financial statements were available to be issued, and determined no additional disclosures were required to be presented in these financial statements.
