Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of Safe-Harbor 403(b) Thrift Plan for Employees of Park DuValle Community Health Center, Inc. (the "Plan") have been prepared on the accrual basis of accounting using accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Related Party Transactions

Certain Plan investments are shares of mutual funds managed by Mutual of America Life Insurance Company (the "Custodian"). Mutual of America Life Insurance Company is the asset custodian of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions.

Several employees of Park DuValle Community Health Center, Inc. (the "Plan Sponsor") provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Plan Sponsor for the services of the employees of the Plan.

Certain expenses and costs of administering the Plan were paid by the Plan Sponsor, and accordingly are not reflected in the Plan's financial statements. Certain investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from these estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the plan document.

Subsequent Events

In preparing its financial statements, the Plan has evaluated events subsequent to the balance sheet date through October 15, 2025, which is the date the financial statements were available to be issued.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Park DuValle Community Health Center, Inc. (the "Plan Sponsor"). for the benefit of its employees. An employee must be eighteen years of age to contribute to the Plan, with entry daily. Employees must attain age twenty-one and complete three months of service, with entry quarterly, to be eligible to receive employer safe harbor matching contributions.

Contributions

Participants may voluntarily make pre-tax or after-tax salary deferral contributions up to 100% of their eligible compensation. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). For 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500. Participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year.

The Plan Sponsor makes safe harbor matching contributions to eligible participants in an amount equal to 100% of the participant's elective deferral to a maximum of 5% of the participant's compensation.

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Rollover Contributions

Participants may roll over their taxable portion of funds previously held for their account in another qualified employee benefit plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with allocations of (a) the participant's contribution, (b) the Plan Sponsor's contribution, and (c) allocation of Plan earnings. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested at the time of participation in the Plan in their voluntary contributions, rollover contributions, and employer safe harbor matching contributions, plus actual earnings thereon. Vesting in the employer discretionary matching contributions is based on years of continuous service. A participant is 20% vested after two years, 40% vested after three years, 60% vested after four years, 80% vested after five years, and 100% vested after six years of service.

Payment of Benefits

Upon a participant's retirement, death, disability, termination of employment, or termination of the Plan, the participant may receive benefits in accordance with the Plan's provisions and existing laws and regulations.

In-service distributions are permitted for those participants who have reached the age of 59 1/2. Participant rollover contributions may be withdrawn in whole or in part at any time.

Upon termination of the Plan, assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

Notes Receivable from Participants

Under certain circumstances, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates, which are commensurate with local prevailing rates as determined by the plan administrator from time to time. Principal and interest is paid ratably through monthly payroll deductions.

Forfeited Accounts

Forfeitures may be used to pay plan administrative fees and reduce future employer contributions. The balance in the forfeiture account was \$-0- at December 31, 2024 and 2023. Forfeitures used to reduce employer contributions were \$-0- in 2024.

NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts: Valued based on the fair value of the underlying investments, which is represented by the net asset value ("NAV") of shares of the underlying fund as published by the trustee.

Interest accumulation account: Valued based on the principal contributed and interest credited to the account. There are no deferred sales charges, load assessments, or interest rate adjustments. Accordingly, the fair value of the investment is estimated at the amount of its historical cost.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
