## NOTES TO FINANCIAL STATEMENTS

---

### NOTE 1: DESCRIPTION OF PLAN

The following description of The Contractors Plan Trust Health Reimbursement Arrangement (the "Plan") provides only general information. The Plan is sponsored by Bright Horizons Children's Centers, LLC (the "Company"), ERISA Smart, Inc. is the Plan's Trustee. The Contractors Plan Trust II (the "Trust") acts as the conduit for payment of claims, premiums, and other Plan expenses. ERISA Smart, Inc. serve as Trustee of the Trust and Fringe Benefits Group, Inc. serves as the Third-Party Administrator. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General:** The Plan was established on May 1, 2014, for the benefit of eligible employees of the Company and its affiliates performing work on prevailing wage service contracts subject to the McNamara-O'Hara Service Contract Act of 1965 ("SCA"), as amended. The Plan is a health reimbursement arrangement ("HRA"). The HRA allows eligible participants to be reimbursed tax free for qualified medical expenses. Amounts remaining at the end of the year can be carried over to the next year. The employer is not permitted to refund any part of the balance to the employee; the account cannot be used for anything other than reimbursements for qualified medical expenses. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility:** To be eligible, SCA Employees must be full-time employees working 30 or more hours per week, as further described in the Plan Document.

**Contributions:** The Plan is funded by Company contributions in excess of the amounts needed to pay the participants group benefit insurance premiums.

**Participant Accounts:** Each participant's account is credited with the Company's contributions and is charged with payments for claims and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are fully vested in all contributions.

**103-12 Investment Entity (IE):** The Plan has invested in The Contractors Plan Trust II 103-12 Investment Entity ("103-12 IE"). The purpose of this vehicle is to pool investment transactions for the participating employers. The Trust funds benefits under health reimbursement arrangements. The Plan deposits funds in the 103-12 IE and owns an undivided interest in the net assets of the 103-12 IE. The investment in the Trust represents the allocated net portion of the Trust that is attributable to the Plan and includes all of the Plan's investments. The Plan's share of the net assets of the Trust is based on the underlying participant account values including the effects of contributions, benefit payment, and administrative expenses. See Note 5.

**Payment of Benefits:** Claim payments are recorded when paid by the third-party claim's processor.

### NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, investments are recorded at fair value, contributions are recorded when received and benefits are recorded when paid. The modified cash basis of accounting is an acceptable alternative method of reporting under regulations issued by the Department of Labor (“DOL”). The financial statements and supplemental schedule have been prepared to satisfy the reporting and disclosure requirements of ERISA.

**Use of Estimates:** The preparation of financial statements in conformity with the modified cash basis requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value of the Plan's interest in the Trust is based on the beginning of year value of the Plan's interest in the Trust plus actual contributions less actual distributions and allocated administrative expenses.

The Plan's management determines the Plan's valuation policies utilizing information provided by the trustees, and other parties involved with the Plan. See Note 5 for discussion of fair value measurements.

**Payment of Benefits:** Benefit payments to participants are recorded when paid.

**Risks and Uncertainties:** The Plan's investment in its 103-12 IE maintains a cash balance at a quality financial institution. Accounts at the institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At certain times, the investment entities cash balance is in excess of the insurance limit.

**Uncertain Tax Positions:** The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Administrative Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company, such as professional fees, are excluded from these financial statements.

### NOTE 3: PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for the participants.

### NOTE 4: TAX STATUS

The Trust is a taxable trust. As a result, the Plan is subject to income taxes. Although the Trust is subject to income taxes, it had no taxable income for the years ended December 31, 2024 and 2023. In addition, the Plan and trust are required to operate in conformity with the Internal Revenue Code ("IRC") to maintain the tax status of the Trust. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC.

### NOTE 5: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB"), Accounting Standards Codification ("ASC") 820, "*Fair Value Measurement and Disclosures*", provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 – inputs other than quoted market prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs that are unobservable for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### NOTE 5: FAIR VALUE MEASUREMENTS (CONTINUED)

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at December 31, 2024 and 2023.

*103-12 Investment Entity:* The investment is valued on the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The net asset value ("NAV") is based on the market value of the underlying investment. The NAV is not a publicly quoted price in an active market. The 103-12 IE holds only cash, therefore, there is no investment income.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
