We have performed audits of the financial statements of Sun Automation Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### Note 1. Plan Description

The following description of Sun Automation Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Sun Automation Inc. (the Plan Sponsor). The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Sponsor's Board of Directors. The Plan Sponsor is responsible for oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may contribute up to 60% annual pretax or after tax compensation, as defined in the Plan. Participants are also permitted to contribute Roth after-tax deferrals to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at 2% unless they affirmatively elect not to participate in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan Sponsor may make matching contributions at its discretion. For the year ended December 31, 2024, the Plan Sponsor matched 100% of a participant's contributions, up to 3% of their eligible compensation. The Plan allows for discretionary nonelective employer contributions. Discretionary nonelective employer contributions are allocated to all eligible participants as a uniform percentage of included compensation. The Plan Sponsor did not make any discretionary nonelective contributions for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Code (IRC) limitations.

**Investment options:** Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator in 1% increments. Participants may change their investment options daily.

**Participant accounts:** Each participant's account is credited with the participant's contributions and the Plan Sponsor's matching contributions and an allocation of the Plan Sponsor's discretionary contribution, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in their contributions plus actual earnings thereon. Participants are vested in the Plan Sponsor's contributions plus actual earnings thereon based on years of service in accordance with the following schedule:

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000, up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years, except for loans used to purchase a participant's primary residence. The loans are secured by the balance in the participant's account and bear interest at a reasonable interest rate, as determined by the Plan Administrator, based on the prevailing interest rates charged by persons in the business of lending money for loans, which would be made under similar circumstances. The interest rate is fixed throughout the duration of a loan. Interest rates were 4.25% to 9.50% for loans outstanding as of December 31, 2024, and the loans mature through 2029. Principal and interest payments are made through regular payroll deductions.

**Payment of benefits:** The Plan permits withdrawals when a participant terminates employment, reaches retirement age, or becomes disabled or deceased. If the total benefit is greater than \$5,000, the participant must consent to the distribution before it is made, and may choose to receive monthly installments or defer receiving payments until age 73, in accordance with current regulations. By deferring payments, the account will continue to be invested the way the participant chooses, and will be adjusted for any gains or losses which occur. If the total benefit is \$1,000 or less, the entire amount will be paid out in a lump sum, unless the participant elects otherwise. Any distribution greater than \$1,000 but less than \$5,000, that is made to a participant without the participant's consent before the participant's normal retirement age will be rolled over to an IRA designated by the Plan Administrator. In-service withdrawals are also permitted for certain financial hardships (as defined by the Plan) or when a participant attains age 59½.

**Forfeitures:** Forfeitures are used to reduce future employer contributions or pay plan expenses. Forfeited nonvested accounts totaled \$113 and \$12 at December 31, 2024 and 2023, respectively. During 2024, \$14,974 of forfeitures were used to reduce employer matching contributions and none were used to pay plan expenses.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

#### Note 2. Summary of Significant Accounting Policies (Continued)

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions:** Contributions from the Plan participants and Plan Sponsor matching contributions are recorded in the year the underlying compensation is earned. Employer nonelective contributions, if any, are recognized upon authorization and in the year the underlying compensation is recognized under the Plan. All participant and employer contributions are participant-directed. Participant contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction in contributions.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor, and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan, and are shown net of income from revenue sharing arrangements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent events:** The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

The trustee also certified to the completeness and accuracy of \$1,135,664 of net appreciation in fair value of investments, \$510,968 of interest and dividends and \$12,534 of interest income on notes receivable from participants related to the aforementioned assets for the year ended December 31, 2024.

#### **Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered investment companies (mutual funds):** Valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV), and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common/collective trust:** Valued at the NAV of shares in each account held by the Plan at year-end. The NAV is not a public-quoted price in an active market. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value.

\* Withdrawals made to accommodate distribution to participants, whether in-service or following termination of employment, may be made on any business day. Withdrawals made to accommodate a participant-directed exchange to another investment option may be made on any business day, provided that the exchange is not directed into a competing fund (money market funds or certain other types of fixed income funds). Transferred amounts must be held in a noncompeting investment option for 90 days before subsequent transfers to a competing fund can occur. Withdrawals directed by the Plan Sponsor must be preceded by 12 months written notice to the trustee, provided however, that the trustee may in its discretion complete any such plan-level withdrawals before the expiration of such 12-month period.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

#### **Note 5. Related-Party and Party-in-Interest Transactions**

Fidelity Management Trust Company is the trustee of the Plan; therefore, transactions with the trustee qualify as party-in-interest transactions. The Plan Sponsor also paid certain administrative expenses of the Plan. Income received from the trustee related to a revenue sharing arrangement totaled \$22,292 for the year ended December 31, 2024, and is reported as a reduction of administrative expenses paid by the Plan.

#### **Note 6. Plan Termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

#### **Note 7. Tax Status**

The Plan has adopted a non-standardized form of a pre-approved plan. The pre-approved plan provider, FMR LLC, received on June 30, 2020, an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 9. Nonexempt Transactions**

During 2024, the Plan Sponsor inadvertently failed to deposit \$36,906 of participant contributions and loan repayments within the required time frame as stated by the Department of Labor regulations. The Plan Sponsor intends to deposit lost interest to correct this failure in 2025.
