NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the TalentBridge Companies 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide retirement benefits for the employees of TalentBridge, Inc. and affiliated companies (collectively, the Company). The Plan was established on April 1, 1990. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company is the sponsor and administrator of the Plan. Fidelity Management Trust Company (FMTC) is the custodian, trustee, recordkeeper and third-party administrator of the Plan.

Eligibility

Employees who are 21 years of age are eligible to participate in the Plan and receive employer safe-harbor matching contributions. Participants who complete 1,000 hours of service and are employed by the Company on the last day of the Plan year are eligible to receive employer discretionary profit-sharing contributions.

Eligible employees may enter the Plan on the first day of the month following the satisfaction of the aforementioned eligibility conditions. Ineligible employees include those covered by a collective bargaining agreement, unless the agreement requires the employees to be included under the Plan, nonresident aliens, leased employees.

For the period January 1, 2023 through June 30, 2024, seasonal and contingent employees were ineligible to participate. Seasonal employees, however, became eligible to participate in the Plan after completing 1,000 hours of service and the attainment of 21 years of age and entered the Plan on the first day of the month following the satisfaction of these requirements.

Effective July 1, 2024, seasonal and contingent employees became eligible to participate in the Plan.

Contributions

Participants may elect to contribute up to 100% of their pretax annual compensation, as defined in the Plan document, up to the maximum amount allowable in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan also allows for Roth elective deferrals, catch-up contributions, and rollover contributions from other qualified retirement plans.

The Company makes a safe harbor employer matching contribution equal to 100% of the participant's salary deferrals that do not exceed 3% of the participant's eligible compensation plus 50% of the participant's salary deferrals between 3% and 5% of the participant's eligible compensation. The Company may make employer discretionary profit-sharing contributions to the Plan at the option of the Company. There were no employer discretionary profit-sharing contributions made in 2024 or 2023.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

Participants direct the investment of their contributions and Company matching and discretionary profit-sharing contributions into the various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, the Company's contributions and actual earnings thereon. Allocations of earnings and administrative expenses are based on participant earnings or account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their voluntary contributions, safe harbor employer matching contributions, and rollover contributions, plus actual earnings thereon. Participants become 20% vested upon completion of two years of service and become 100% upon the completion of three years of service in the Company's employer discretionary profit-sharing contributions, plus actual earnings thereon.

Prior to January 1, 2017, the Company provided for employer discretionary matching contributions. Participants with a balance in the employer discretionary matching contributions become 20% vested upon completion of two years of service and continue to vest at a rate of 20% for each successive year of service until 100% vested after six years of service.

Participants are considered to have completed one year of service for all vesting purposes upon completion of 1,000 hours of service at any time during the plan year.

Forfeitures

Forfeitures of non-vested account balances are used to offset Plan expenses or reduce employer contributions. For the years ended December 31, 2024 and 2023, there were \$13 and \$316 in forfeitures, and earnings thereon, of non-vested account balances, respectively. The Company applied \$706 and \$131 to reduce employer contributions or to offset Plan expenses during the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, forfeited non-vested account balances available to offset future Plan expenses or employer contributions totaled \$15 and \$708, respectively.

Notes Receivable from Participants

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance reduced by the highest outstanding loan balance during the prior twelve-month period, whichever is less. Participants may have no more than two outstanding loans at any given time. Principal and interest are paid ratably through payroll deductions for a period not to exceed five years, except in the case of a loan taken for the purpose of purchasing a primary residence. Notes receivable from participants bear interest at a fixed rate equal to the prime rate in effect when the loan is originated plus 1%.

Benefits Payments

The Plan provides for normal retirement benefits upon reaching age 65 and has provisions for in-service, disability, death and termination benefits for those participants who are eligible to receive such benefits. Participants can elect to receive a distribution of their vested account balances in the form of a qualified rollover or a lump-sum distribution. Participants whose vested account balance is \$7,000 or less at the time of termination are subject to the involuntary cash-out provisions of the Plan.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted under certain circumstances.

1. DESCRIPTION OF PLAN (Continued)

Administrative Expenses

Administrative expenses include investment management fees, operating expenses, transaction fees, and loan servicing expenses and are generally paid by the Plan.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, each participant's account will become fully vested.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair Value Measurement - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board *Accounting Standards Codification 820* (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Benefit Payments

Benefit payments are recorded when paid.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Money market fund and mutual funds: Valued at fair value based on quoted market prices in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

FMTC is the custodian of the Plan's assets, trustee, and recordkeeper of the Plan. As such, transactions between FMTC and the Plan qualify as party-in-interest transactions. In addition, transactions involving notes receivable from participants qualify as party-in-interest transactions.

6. TAX STATUS

The Plan adopted a pre-approved plan offered by FMR LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RECONCILIATION TO FORM 5500

Certain classifications may differ between the financial statements and Form 5500. Net assets available for benefits per Form 5500 agreed to the financial statements for the year ended December 31, 2024.
