Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ourisman Automotive 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Ourisman Automotive 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

1. Description of the Plan

The following description of the Ourisman Automotive 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan under Section 401 (k) of the Internal Revenue Code (IRC) adopted on January 1, 1969. The Plan covers substantially all employees of Ourisman Rockmont, Inc., and the following adopting employers: Ourisman Chrysler Dodge Jeep Ram of Bowie; Ourisman of Rockville; Ourisman of Laurel (VW); Ourisman Automotive of Laurel (Honda); Ourisman of Clarksville, Inc.; Ourisman Hyundai of Bowie; Ourisman Chevrolet of Bowie; Ourisman of Dundalk, Inc.; Ourisman Chevrolet Security Boulevard LLC; Ourisman Fairfax Boulevard, Inc. T/A Ourisman Kia of Fairfax; Ourisman Edgewood I, Inc. T/A Ourisman Toyota 40; Rising Sun, Inc.; Ourisman Imports of Baltimore County, Inc. T/A Ourisman Kia of Catonsville; Ourisman Performance Cars, LLC T/A Lotus Washington DC; and Ourisman Imports Newark, LLC T/A Ourisman Tri-State Subaru, Inc. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: The Plan covers all employees age 21 and older, except residents of Puerto Rico, who have completed 1 year of service. Part-time, seasonal, and temporary employees become eligible to participate in the Plan when they have completed at least 1,000 hours of service within the reporting period.

Contributions: Each year participants may contribute up to 75 percent of annual compensation, as defined in the Plan, as pre-tax contributions subject to the statutory annual limitations established by the Internal Revenue Code (IRC). The annual limit for elective deferrals for the year ended December 31, 2024 was \$23,000. Participants who have attained age 50 before the end of the plan year are eligible to make additional contributions to a 401(k) plan, in excess of the standard limits. Such additional contributions were limited to \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and Guaranteed Investment Contracts as investment options for participants.

The Plan includes an auto-enrollment provision whereby all eligible employees are auto-enrolled in the Plan, with a default deferral rate set at 2% of eligible compensation, unless they affirmatively elect not to participate in the Plan within the opt out period. Unless otherwise directed by the employees, contributions are automatically invested in the target date fund based on the participant's expected retirement age.

1. Description of the Plan (continued)

The Plan allows for discretionary matching contributions and profit-sharing contributions at the option of the Company's Board of Directors. The plan sponsor matches participants' contributions at a rate of 6.25% of the first 4% of their eligible compensation. A participant must be employed on the last day of the plan year in order to share in the employer match. During the year ended December 31, 2024, the Company made matching contributions to the Plan totaling \$56,576. The Company did not make any discretionary profit-sharing contributions to the Plan in 2024.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the Company's contribution, if any, Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. After two years of service, a participant becomes 20 percent vested in employer contributions in the Plan; the vesting percentage increases by 20 percent each year until the participant becomes fully vested in his or her account after six years of service.

Payment of benefits: Upon termination of service due to death, full and permanent disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of their account, a direct rollover into a qualified retirement plan, a distribution in the form of an annuity, or a combination of methods. The employer may authorize certain withdrawals from a participant's account in the event of a proven financial hardship. Hardship withdrawals are subject to specific statutory and regulatory requirements.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$20,888 and \$9,417, respectively. The Company uses forfeitures to reduce the employer matching contribution due under the Plan or pay Plan expenses. During the year ended December 31, 2024, no forfeitures of nonvested accounts were used to reduce employer contributions.

1. Summary of significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting standards generally accepted in the United States of America (U.S. GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts (FBRIC). Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to FBRIC because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates: The preparation of the financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value, except for FBRIC, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Contract value equals the accumulated cash contributions and interest credited to the Plan's contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Certain accounting and administrative functions of the Plan are performed by employees of the Company at no cost to the Plan. Administrative expenses paid by the Plan totaled \$23,872 for the year ended December 31, 2024.

Payment of benefits: Benefits are recorded when paid.

3. Risks and uncertainties

The Plan provides for various investment options which may include any combination of stocks, bonds, fixed income securities, mutual funds, common trust funds, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participant's account balances and amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

4. Fair value measurements

Accounting Standards Codification Topic 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

5. Fair value measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts: The fair value of the pooled separate accounts is based on net asset value (NAV). The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the NAV. Participant transactions (purchases and sales) may occur daily. The fund provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit. If the Plan initiates a full redemption, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully benefit-responsive investment contract

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Talcott Resolution Life Insurance Company (TRLIC) (formerly named Hartford Life Insurance Company (Hartford)). As a result of an acquisition, Mass Mutual assumed Hartford's obligations under the guaranteed investment contracts and provided all administrative services necessary to support the contracts issued by Hartford via an investment in a Fixed Account investment option.

Following an acquisition of Mass Mutual by Empower, group insurance contracts written or assumed by MassMutual were reinsured by Great-West Life & Annuity Insurance Company (GWLA), which was later rebranded as Empower Annuity Insurance Company of America (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuers but may not be less than 3%. Such interest rates are reviewed annually.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,090,088 and \$984,035, respectively.

Certain events limit the Plan's ability to transact at contract value with Empower. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan),

(b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

7. Related party transactions and party-in-interest transactions

Certain Plan investments are Empower accounts managed by Empower. Empower is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$4,252 for the year ended December 31, 2024. Fees paid by the Plan for plan administration and recordkeeper services, transactions considered as party-in-interest transactions, amounted to \$19,620 for the year ended December 31, 2024.

8. Tax status

The Plan has adopted a prototype defined contribution plan sponsored by Retirement Planners & Administrators, Inc. The prototype Plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype defined contribution plan, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has evaluated the Plan's tax positions and has concluded that there are no uncertain positions taken or expected to be taken that would require adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is generally no longer subject to income tax examinations by federal, state, or local tax authorities for years prior to 2021.

9. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will be distributed in accordance with the Plan agreement.

10. Nonexempt Prohibited Transactions - Late remittances

During the years ended December 31, 2024 and 2023, the Company failed to remit to the Plan custodian participant contributions totaling \$7,641 and \$7,714, respectively, within the period prescribed by Department of Labor regulations. These contributions are considered nonexempt party-in-interest transactions. The third-party administrator calculated lost earnings on the 2023 delinquent remittances and the Company contributed the lost earnings to the affected participants' accounts in August 2024. For the 2024 late remittances, the Plan recordkeeper will calculate lost earnings on the delinquent remittances and the Company is in the process of making corrections to the affected participants' accounts.

11. Operational defects and errors

It was discovered that a Plan provision was not properly applied in the operation of the Plan. The definition of compensation as per the plan document was not properly applied when calculating contribution amounts. It appears that the errors occurred as a result of incorrect payroll system settings which improperly excluded certain payroll codes from plan compensation and certain manual payroll checks being excluded.

12. Subsequent events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 15, 2025, the date the financial statements were available to be issued. On July 2, 2025 there was an amendment to the Plan allowing Roth contributions with an effective date of January 1, 2026.
