### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The Concrete Company 401(k) Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1: Description of Plan

The following brief description of The Concrete Company 401(k) Plan, (the “Plan”), is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a prototype defined contribution profit sharing plan sponsored by The Concrete Company and its wholly owned subsidiaries (collectively, the “Plan Sponsor”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was originally adopted on January 1, 1990, and effective January 1, 2023, the Plan was amended to include Foley Materials Company, Fall Line Quarry, LLC, Columbus Quarry, LLC, TCC Investments, and Greenbriar Sand, LLC as eligible employers in the Plan.

The Administrative Committee, designated by the Plan Sponsor, has responsibility for the administration of the Plan. Empower Trust Company (“Empower”), as trustee and a qualified institution, has responsibility for the management, operation, and administration of the Plan’s Trust Fund. Empower also serves as the Plan’s recordkeeper and custodian. Fees are charged to the Plan Sponsor for recordkeeping and administrative services.

Eligibility – Employees of the Plan Sponsor are automatically enrolled in the Plan after two months of service.

Contributions – Participants may elect to contribute 1% to 100% of their aggregate compensation (up to the maximum limits provided under the Internal Revenue Code (“IRC”)) on a pretax and/or after-tax basis. Participants may also contribute amounts representing distributions from other qualified defined benefit or contributory plans. The employer makes a matching contribution equal to 50% of the participant’s contribution up to 8% of the participant’s compensation. Additional discretionary amounts may be contributed at the option of the Plan Sponsor’s Board of Directors. There were no discretionary employer contributions for 2024 or 2023.

Participant Accounts – Each participant’s account is adjusted for the participant’s contributions and distributions, the Plan Sponsor’s matching contributions, and pro-rata allocations of Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their contributions and any earnings or losses thereon. Vesting in the employer’s matching contributions, discretionary contributions, forfeitures and any earnings or losses thereon is as follows:

Three years or more	100%

Unallocated accounts – Unallocated accounts consist of advance deposits made by the Plan Sponsor and forfeitures, which represent the non-vested portion of a participant’s account balance that is forfeited upon termination. They are used to pay Plan expenses and reduce the Plan Sponsor’s contributions in accordance with Plan specifications. These accounts had a balance of approximately \$19,000 and \$11,000 at December 31, 2024 and 2023, respectively. Amounts used to pay Plan administrative expenses totaled approximately \$7,000 and \$34,000 while amounts used to reduce the Plan Sponsor’s contributions totaled approximately \$24,000 and \$38,000 for the years ended December 31, 2024 and 2023, respectively.

Investment Options – A participant may direct employee and employer contributions in any of the investment options established by the Administrative Committee. Participants may change their investment options daily.

Payment of Benefits – Upon a participant’s termination of employment, retirement or death, such participant may elect to receive either a lump-sum distribution in an amount equal to the value of the participant’s vested interest in his or her account, rollover a portion or all of the distribution into an eligible retirement plan, or receive monthly or annual installments over a specified period of time as defined in the Plan agreement. Vested account balances less than \$5,000 are subject to automatic distribution in accordance with the Plan document. Participants may also receive distributions of benefits from their account if certain requirements are met in order to take a hardship distribution. The Plan also allows for in-service withdrawals of a participant’s vested interest upon reaching the age of 59 ½.

Plan Termination – Although there is no present intention to terminate the Plan, the Plan Sponsor may terminate the Plan at any time, subject to the provisions of ERISA. In the event of termination, the participants will become fully vested in their accounts and the trustee shall dispose of the Plan assets by distribution to participants and beneficiaries.

NOTE 2: Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared using the accrual basis of accounting.

Valuation of Investments – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between participants at a measurement date. See Note 3 for a description of the valuation methodologies used to determine each investment’s respective fair value.

Net appreciation or depreciation of the fair value of investments consists of the unrealized appreciation or depreciation of investments held during the year, as well as the realized gain or loss on sale of investments which represents the difference between net sales proceeds and cost or previous fair value of the investments sold.

Purchases and sales of securities are recorded on a trade–date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex–dividend date.

Tax Status – The Plan received a favorable determination letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the IRC and are exempt from federal and state income taxes.

Accounting principles generally accepted in the United States of America (“GAAP”) requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS or state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions within the standard statute of limitation periods; however, there are currently no audits for any tax periods in progress.

Benefit Payments – Benefits are recorded when paid.

Plan Expenses – Significant costs of administering the Plan are absorbed by the Plan Sponsor and are not reflected in these financial statements. These costs include legal, administrative, accounting, and trustee fees. Certain investment management fees and administrative expenses are incurred and paid by the Plan as disclosed in Note 1. Other investment–related expenses are included in net appreciation of the fair value of investments.

Reclassification – Certain items in the 2023 financial statements have been reclassified in order to be in conformity with the 2024 statement presentation.

Use of Estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events – The Plan’s Administrative Committee has evaluated all subsequent events that may qualify for disclosure through October 15, 2025, which is the date the financial statements were available to be issued. There were no transactions that are required to be disclosed under professional guidance.

NOTE 3: Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy according to GAAP are described below:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at net asset value ("NAV") of shares held by the Plan at year end. All mutual funds are classified as Level 1 within the fair value hierarchy.

*Collective investment trusts:* Collective investment trusts held by the Plan are valued using the NAV per share as a practical expedient.

*Stable value funds:* The Galliard Stable Return Fund C and Wells Fargo Stable Fund C (collectively, the "Stable Value Funds") are stable value funds valued using the NAV per share as a practical expedient.

NOTE 5: Party-in-Interest Transactions

Certain Plan investments are managed by Empower, the custodian. These transactions qualified as party-in-interest transactions. Certain fees incurred by the Plan for these services are included in net appreciation (depreciation) in fair value of investments rather than a direct payment.

Empower provided certain administrative services to the Plan pursuant to their Administrative Services Agreements (“ASA”). Each custodian received revenue from mutual fund service providers for services they provided to the funds. This revenue is used to offset certain amounts owed to the custodian for their administrative services to the Plan.

If the revenue received by the custodian from mutual fund service providers exceeds the amount owed under the ASA, the custodian remits the excess to the Plan’s trust on a monthly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or Plan Sponsor may make a payment to the custodian for administrative expenses not covered by revenue sharing as disclosed in Note 1.

NOTE 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of these investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 7: Transfer of Assets

During the year ended December 31, 2023, a minority interest in Foley Products Company, LLC, (“FPC”), was acquired by an unrelated party. In connection with the acquisition, FPC adopted the Foley Products 401(k) Plan (“FPC Plan”). Subsequently, the Plan transferred assets of \$8,511,155 consisting of FPC employee account balances to the FPC Plan.
