Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Helget Gas Products, Inc. Employees 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 - Description of Plan

The following brief description of the Helget Gas Products, Inc. Employees 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Helget Gas Products, Inc. (the Employer), as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Management of the Employer is responsible for oversight of the Plan, as well as determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Eligibility

Employees are eligible to make salary deferral contributions and receive discretionary Employer matching contributions and discretionary profit-sharing contributions upon attaining age 20½ and completing sixty days of service. In addition, if an employee is not employed as of the last day of the Plan year, they must have completed 500 hours of service to be eligible for the discretionary profit-sharing contributions for the Plan year.

Entry Date

Employees may enter the Plan on the first day of month coinciding with or following the date they satisfy the Plan's eligibility requirements.

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan document. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Effective January 1, 2024, the Plan was amended to allow Roth contributions and in-Plan Roth rollover contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Employer may make discretionary matching contributions equal to a percentage of the participants' contributions. For the year ended December 31, 2024, the Employer contributed 25% of the participant's contributions up to 4% of eligible compensation. The Employer may also make discretionary profit-sharing contributions. There was no discretionary profit-sharing contribution for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Employer discretionary matching contributions, as well as allocations of the discretionary profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investment Options

Upon enrollment to the Plan, a participant may direct deferrals and Employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

Vesting

Participants are fully vested in their contributions (including rollovers), plus actual earnings thereon. A participant becomes vested with regard to the discretionary Employer matching and non-elective profit-sharing contribution portion of their accounts based on the following vesting schedule:

Forfeitures

Forfeitures are retained in the Plan and are used to reduce future Employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,833 and \$7,867, respectively. In 2024, Employer contributions were reduced by \$6,198 from forfeited nonvested accounts.

Notes Receivable from Participants

Participants may borrow from their fund accounts, a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account. The interest rate is set at 1% above the prime rate. Principal and interest is paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the note were used to acquire the participant's residence.

Payment of Benefits

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or annual installments as defined in the Plan document upon retirement, termination of service, death or disability. If the participant's account is less than \$7,000, the Plan can automatically cash out the account and roll the participant's account balance into a qualified Individual Retirement Account. In-service withdrawals are permitted if the participant has reached age 59½. Hardship withdrawals for qualifying expenses are permitted by the Plan.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer determines the Plan's valuation policies utilizing information provided by the custodian.

The fair value of pooled separate accounts is determined by the net asset value (NAV) of the funds' underlying investments held at year end adjusted for any dividends or distribution received by John Hancock Life Insurance Company, the custodian, and the daily equivalent of any fee charged by the custodian pursuant to the contracts. The NAV, as provided by John Hancock Life Insurance Company, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There have been no changes in the methodology used at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Contributions

Participant contributions and the related Employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

The Plan's expenses are paid by either the Plan or the Employer, as provided by the Plan document. Expenses that are paid directly by the Employer are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan Sponsor has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued.

- (a) These funds provide a diversified exposure to stocks, bonds, and cash for those investors who have a specific date or investment strategy in mind for retirement or another goal. The target date portfolios aim to provide investors with an optimal level of return and risk, based solely on the target date. Over time, fund managers adjust the allocation among asset classes to more conservative mixes as the target date approaches. The lifestyle portfolios aim to provide investors with aggressive, growth, balanced, and conservative strategy goals.
- (b) This category seeks capital appreciation by investing primarily in large capitalization companies. Although it invests primarily in U.S. securities, investments in foreign companies may be made.
- (c) This category seeks long-term capital appreciation by investing primarily in mid-sized companies or smaller. Although it invests primarily in U.S. securities, investments in foreign companies may be made.
- (d) The funds in this category primarily invest in specific sectors such as healthcare or real estate.
- (e) This category seeks long-term capital appreciation by investing in foreign market securities. These funds invest primarily in the common stock of companies in both developed and developing foreign markets.
- (f) This category seeks capital appreciation by investing primarily in small capitalization companies. These funds generally invest in companies with growth characteristics or those believed to be undervalued.
- (g) This class typically invests in a strategic mix of global fixed income sectors to seek high income and diversification.

Note 4 - Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the custodian of the Plan).

Note 5 - Tax Status

The Plan uses a pre-approved plan document sponsored by Benefit Plans Inc., which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Party-in-Interest Transactions

Certain Plan investments consist of pooled separate accounts managed by John Hancock Life Insurance Company, the custodian as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 - Delinquent Participant Contributions

During 2024 and 2023, the Company failed to remit to the Plan's trustee certain employee contributions totaling \$151,933 and \$89,107, respectively, within the period prescribed by DOL regulations. Delays in remitting contributions to the trustee were due to administrative errors or delays, and the Company has or will make contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delay.

Note 9 - Plan Amendments

The Plan has not yet been formally amended to reflect SECURE Act 2.0 changes. However, the Plan is required to operate in accordance with certain provisions, based on the effective date of each new provision, as well as any optional provisions elected by the Plan. Effective for distributions made after December 31, 2023, the Plan has elected to apply a threshold of \$7,000 for involuntary cash-out distributions, increased the required minimum distribution age, increased catch up limits, and added additional qualifying types of financial hardships and financial hardship self-certification.
