Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule of assets held at end of year as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - PLAN DESCRIPTION

The following description of Keystone Anesthesia Consultants, Ltd. Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution profit sharing and 401(k) plan established to provide supplemental retirement benefits for employees of Keystone Anesthesia Consultants, Ltd., Keystone Pain Consultants & Interventional Spine Specialists, P.C., and Tri State Anesthesia Billing, Inc. (collectively referred to as the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

Employees become eligible to participate in the Plan on the first day of the month following ninety days of service, provided that they are an eligible employee on that date. If they do not meet the requirement as specified, they will also be eligible for the Plan on the later of the date that they complete three consecutive qualifying periods of service, attain the age of 21, or complete one year of service.

Contributions

Participants may elect to defer up to 100% of their compensation on a pre-tax basis. The Plan provides for a safe harbor nonelective contribution equal to 3% of the participant’s compensation for any plan year. In addition, participants who receive qualified distributions from another qualified plan may be able to rollover such distributions into the Plan. Rollover contributions for 2024 were \$16,337. Federal law also limits the amount of deferrals during any calendar year (\$23,000 in 2024). However, if a participant is age 50 or over, they may defer an additional amount of up to \$7,500. The Internal Revenue Code may further restrict 401(k) contribution elections by participants considered to be highly compensated. Effective January 1, 2024, the Plan was amended and restated to allow Roth deferrals of compensation.

Discretionary profit-sharing contribution

At the Company’s discretion, they may elect to contribute additional amounts out of earnings to eligible plan participants. Eligible employees share in the allocation of the discretionary profit-sharing contribution at the discretion of the Company’s board of directors, subject to certain non-discrimination provisions as defined in the Plan document. The Company made discretionary profit-sharing contributions totaling \$672,612 during the year ended December 31, 2024.

NOTES TO FINANCIAL STATEMENTS

(continued)

NOTE 1 - PLAN DESCRIPTION (continued)

Participant accounts and vesting

Each participant's account is credited with the participant's contributions, the Company's contributions, and earnings (losses) and reduced by the participant's withdrawals and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Allocations to individual participant accounts are based upon unit values at specified valuation dates. All participants are immediately fully vested in all salary deferral, employer safe-harbor nonelective, and employer profit sharing contributions.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000, up to the lesser of 50% of their vested balance or \$50,000 minus the highest outstanding balance of loans in the past 12 months. Loans are repaid by regular payroll reductions over a maximum of five years, or longer for the purchase of a principal residence. Outstanding loans that are not repaid when a participant withdraws from the Plan are classified as benefit payments in the statement of changes in assets available for benefits. There were \$16,673 and \$21,081 of participant loans outstanding under the Plan as of December 31, 2024 and 2023, respectively. Interest rates on outstanding loans ranged from 5.25% to 10.50% as of December 31, 2024 and 2023.

Under the Plan's policy, the balance of notes in default (as defined) is reported to the participant as taxable income and is subject to personal income taxes and penalties. Such notes remain outstanding and continue to accrue interest even though they have been reported to a participant on Form 1099 (a "deemed distribution"). Notes will not be charged against the participant's vested account balance until approval is received to offset the note due to the participant's termination of service, retirement, death, disability, attainment age of 59-1/2, or reaching the earliest date that distribution is permitted under the Plan.

Distribution of benefits

Upon termination of service, disability, attainment of age 59 ½, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. Distributions of a participant's account balance, limited to the elective deferral balance, may be authorized at any time by the plan administrator under certain hardship conditions. In certain limited circumstances, a participant may elect to have their distribution paid through a life annuity or qualified joint and survivor annuity. Participant accounts with a balance of less than \$1,000 upon a distributable event will be distributed as soon as administratively practical.

NOTES TO FINANCIAL STATEMENTS

(continued)

NOTE 1 - PLAN DESCRIPTION (continued)

Investment options

Participants are allowed to invest in a variety of investment choices including mutual funds and a common collective trust offered by the Plan's custodian. Participants may also elect to have a portion of their account invested in a self-directed brokerage account. Participants may change their allocations on a daily basis.

Administrative expenses

Expenses incurred by the Plan Sponsor and custodian for their services and costs in administering the Plan are paid by the Plan Sponsor or the Plan, as permitted by the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting consistent with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities as of the date of the financial statements and the reported amounts of changes in assets during the reporting period. Actual results could differ from those estimates.

Investments

The Plan provides participants with the opportunity to direct both participant and employer contributions into separate investment funds. Investing activity within the Plan's mutual funds and common collective trust investment options managed by the Plan's custodian is discretionary, and the individual investment managers have the authority to make investment decisions. The Plan also offers a self-directed investment option, whereby participants are entitled to invest a portion of their accounts in other investments outside of the Plan's standard offerings, subject to standard ERISA regulations.

At December 31, 2024 and 2023, investments in the mutual fund and common collective trust investments are reported at their fair values as reported by Capital Bank and Trust Company. As of December 31, 2024 and 2023, investments in the self-directed investment option consist of stocks and mutual funds and are valued at fair value as reported by the investment manager.

NOTES TO FINANCIAL STATEMENTS

(continued)

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment transactions are accounted for on the trade date (date the order to buy or sell is executed). Interest and dividend income is recorded as earned. All gains and losses (realized and unrealized) on investments recorded at fair value, bought and sold as well as held during the year are included in net appreciation (depreciation) in fair value of investments reported within the statements of changes in assets available for benefits.

The Plan provides various investment options offered through the custodian of the Plan. The underlying investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of assets available for benefits and participants' individual account balances.

Contributions

Employee contributions are recorded when withheld from the participant's compensation. Employer match contributions are recorded at the same time. Discretionary profit-sharing contributions are recorded when approved by the Company's board of directors.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of benefits

Benefit payments are recorded when paid.

Subsequent events

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through October 15, 2025, the date on which the financial statements were available to be issued.

NOTE 3 - CERTIFICATION

All information related to mutual funds, the common collective trust, notes receivables from participants, and related transactions and income is disclosed in the accompanying financial statements and supplemental schedule of assets held at end of year, and is certified as complete and accurate by the Capital Bank and Trust Company, the custodian of the Plan, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

NOTE 4 - INVESTMENTS

Investments measured and reported at fair value are classified and disclosed in one of the following categories based on the extent of market observability:

Level I – Quoted prices are available in active markets for identical investments as of the reporting date. The type of investments reported as Level I include mutual funds and the self-directed brokerage account.

Level II – Pricing inputs are other than quoted market prices included in Level I, however, are observable either directly or indirectly for the investment. The Plan does not carry any of these investments.

Level III – Pricing inputs are unobservable for the investment and includes situations where there is little, if any, market activity for the investment. The inputs into the determination of fair value require significant management judgment or estimation. The Plan does not carry any of these investments.

(a) The Federated Hermes Capital Preservation Fund is a common collective trust that invests in stable value products, including traditional guaranteed investment contracts, synthetic guaranteed investment contracts, and money market instruments. The primary investment objective of the Fund is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments. The Plan has no unfunded commitments with respect to this investment.

The Plan's investments through the self-directed brokerage account are various mutual funds and public equities. These investments are traded in active markets, and their fair values are determined by observable pricing data for identical investments.

NOTE 5 - TERMINATION

Although not expressing any intention to do so, the Company reserves the right to terminate the Plan at any time. In the event of termination of the Plan, the interest of participants affected by the termination and their beneficiaries under the Plan shall be non-forfeitable.

NOTE 6 - INCOME TAX STATUS

The Plan has adopted a Pre-Approved Profit Sharing Plan With CODA (“Pre-Approved Plan”) through the Company’s legal counsel. The sponsor of the Pre-Approved Plan has received an opinion letter dated June 30, 2020 from the IRS as to the Pre-Approved Plan’s qualified status. Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

In accordance with U.S. GAAP, Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

NOTE 7 - RELATED PARTY TRANSACTIONS

Certain plan investments are managed by the custodian, Capital Bank and Trust. Transactions within those accounts qualify as party-in-interest transactions. The Plan also holds notes receivable from participants which qualify as party-in-interest transactions. The Plan also incurs expenses from the Plan custodian and Plan third-party administrator which qualify as party-in-interest transactions.
