**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Young Innovations, Inc. 401(k) Program (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution retirement plan covering eligible employees of Young Innovations, Inc. and its participating subsidiaries (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions: Employees may contribute up to 100% of their eligible earnings, as defined in the Plan, to the Plan through payroll deductions. Participants’ contributions are invested in investment funds as directed by the participants. Employees are automatically enrolled at a 6% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. The automatic enrollment feature includes annual increases of 1% until 10% deferral is attained.

The Company may contribute a discretionary matching contribution to each eligible participant. The Company elected to make matching contributions equal to 33.3% of the first 9% of elective deferrals that a participant contributed to the Plan. In addition, each year the Company may make a discretionary profit-sharing contribution to the Plan on behalf of the participants. For the year ended December 31, 2024, the Company did not elect to make a profit-sharing contribution.

Contributions are subject to certain limitations as provided in the Plan document and through income tax regulations.

Vesting: Participants are vested immediately in their contributions and rollovers, plus actual earnings thereon. Vesting in the Company’s contribution portion of each participant’s account, plus earnings thereon, is based on years of continuous service. A participant’s account vests one-third each year following the first year of service and is 100% vested after four years of credited service.

Notes Receivables from Participants: Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of the lesser amount of 50% of their vested account balance or \$50,000, less the highest outstanding loan balance during the previous 12 months. The loans are secured by the balance in the participant’s account and bear interest at a rate determined by the plan administrator based on prevailing market conditions. Principal and interest are paid ratably through payroll deductions and cannot exceed five years unless the loan is for the purchase of a participant’s primary residence.

Forfeited Accounts: The Plan allows for the use of the non-vested portion of the Company contribution upon five consecutive one-year breaks in service from the Company or the distribution of the entire vested portion of the participant’s account. Forfeited non-vested accounts are used to reduce the employer matching contributions. During the year ended 2024, \$83,785 was used to reduce employer contributions, and \$23,896 was outstanding as of December 31, 2024.

Payment of Benefits: Upon termination of service, a participant (or their beneficiary upon the death of the participant) is eligible to receive an amount equal to the value of the participant’s vested interest in his or her account in a lump-sum payment. In certain circumstances, participants may make hardship withdrawals as defined in the Plan. In-service withdrawals of vested accounts are permitted after the attainment of age 59-1/2.

Hardship Withdrawals: Subject to the approval of the plan administrator, participants may withdraw their employee pre-tax contributions to satisfy immediate and heavy financial need, as determined by the Plan agreement.

**NOTE 1 – DESCRIPTION OF PLAN** (Continued)

Participant Accounts: Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions, Company contributions and an allocation of the Plan's earnings, and is decreased by withdrawals and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Upon enrollment in the Plan, participants may invest their accounts in any of several investment options available under the Plan. Participants can change their elections any business day, either through an automated voice response system or via the Internet.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distribution processing fees are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures and actual results could differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date in the Plan's principal or most advantageous market for the asset or liability. See Note 4 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Delinquent participant loans are reclassified as distributions based on the terms of the Plan agreement.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit risks and global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the new term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code. Therefore, the plan administrator believes that the Plan was qualified and that the related trust was tax-exempt as of the financial statement dates.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes that it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become 100% vested in their employer contributions and earnings thereon.

**NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan's investments include shares of mutual funds managed by Fidelity Management Trust Company (Fidelity), the trustee of the Plan. Therefore, these investments qualify as party-in-interest transactions. Fees paid to the trustee or of the trustee also qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.
