Opinion

Note 1. Description of the Plan

The following description of the Rathje Companies 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined contribution plan covering all full-time non-union employees of Rathje Enterprises, Inc., Kelly General Construction Company of Decatur, Kelly Construction of Indiana, Inc., Bodine Electric of Danville, Inc. and START, LLC (Companies) who have the earlier of three consecutive months or one year of service and are age 18 or older for the salary deferral and have at least one year of service and are age 20 or older for the Companies' match and profit-sharing. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Milliman, Inc. and Matrix Trust Company are the Plan's recordkeeper and trustee, respectively.

Contributions

The Plan permits eligible employees through a salary deferral election to make annual contributions of up to 100% of eligible compensation. Employee rollover contributions are also permitted. The Companies may make matching contributions of 50% of employees' salary deferral amounts on the first 3.5% of employees' compensation. The Companies' profit-sharing contributions are discretionary as determined by the Companies' Board of Directors. Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available currently include various mutual funds, a money market fund, and a common collective trust fund. Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Companies' contribution, Plan earnings and is charged with elective administrative expenses, if any. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Companies' contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after 6 years of credited service. The nonvested balance is forfeited upon termination of service. Forfeitures are used to reduce the Companies' contributions.

Payment of Benefits

Upon termination of service, participants may elect to receive either a lump-sum amount, installments equal to the value of their account or a rollover to a qualified account. At December 31, 2024 and 2023, no Plan assets were allocated to accounts of terminated or retired participants who have elected to withdraw from the Plan but have not yet been paid.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$33,479 and \$25,158, respectively. These accounts will be used to reduce future Companies' contributions. During the years ended 2024 and 2023, the Companies' contributions were reduced by \$25,158 and \$21,353, respectively, from forfeited nonvested accounts.

Subsequent Events

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds and the money market fund are valued at the net asset value (NAV) of shares held by the plan at year-end. The Plan holds interests in common collective trust funds, which invest in investments that pursue multiple strategies to exceed the performance of certain industrial averages. The net asset value of the fund is determined as of the end of each day or month utilizing the values of the underlying assets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends and capital gain distributions are recorded on the ex-dividend and ex-capital gain date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from the Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. Employer profit sharing contributions are recorded in the year in which compensation is earned.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Companies or the Plan, at the Companies' discretion.

Note 3. Disclosures about Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

Recurring Measurements

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The following table summarizes the common collective trust fund for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for the common collective trust fund; the redemption notice period is applicable only to the Plan.

Revisions

An immaterial revision has been made to the 2023 financial statements, Note 3, to correct and present certain investments totaling \$27,232,394 as common collective trust funds instead of mutual funds. This revision did not have a significant impact on the financial statements.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan utilizes a separate investment manager and pays fees to the Plan trustee. Fees paid to the Plan trustee and investment manager totaled \$180,881 and \$164,769 for 2024 and 2023, respectively.

The Plan incurs expenses related to general administration and record keeping. The Companies pay these expenses and certain accounting and auditing fees relating to the Plan.

Note 5. Plan Termination

Although they have not expressed an intention to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 6. Tax Status

The Plan obtained its latest determination letter on March 20, 2014, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
