1. DESCRIPTION OF PLAN:

The following description of the 360 Patriot Enterprises, LLC Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a health and welfare plan covering eligible employees, as defined, of 360 Patriot Enterprises, LLC (the Employer or Company). The Plan and Trust were established April 1, 2024 to provide health and other benefits to eligible participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Administrator, along with various advisors, is responsible for oversight of the Plan.

Benefits

The Plan provides health benefits, including medical, critical illness, hospital indemnity, dental, and vision as well as life insurance, employee assistance program, and short and long-term disability benefits, which are covered through various contracts with insurance companies.

Eligibility

Employees are eligible to participate in the Plan on the first day of the month following one month of continuous employment.

Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Plan management takes contributions to the Plan on their behalf. The participants' coverage will end at midnight of the last day of the month in which eligibility ceases. The Plan also provides continuation of benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions

The Company makes contributions for participating employees covered under the Plan. For employees covered under contracts issued by federal, state, municipal or other contracting authorities which require the payment of specified fringe dollar amounts, the Company contributes to the Plan based upon an hourly funding formula. Employer contributions are recognized as income in the month the employees worked. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis. In addition to deductibles and copayments, participants may contribute specified amounts to extend coverage to their eligible dependents.

Retirement plan contributions

Participants can opt out of some Plan benefits and have their contribution allocated to 360 Patriot 401(k) Plan. After subtracting premiums and fees incurred by the Plan, the Plan forwards the excess contributions to the Company's retirement plan. The retirement plan payable represents excess contributions received that have not been forwarded to the Company's retirement plan by the end of the year.

2. SUMMARY OF ACCOUNTING POLICIES:

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Concentration of credit risk

The Plan maintains its demand deposits in commercial bank accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts. The Plan management does not believe the Plan is exposed to any significant credit risk on cash.

Contributions receivable

Employer contributions due but not paid at year-end are recorded as contributions receivable. There is no allowance for uncollectible accounts at December 31, 2024.

Payment of benefits

Benefits are recorded when paid.

Insurance premiums payable

Insurance premiums payable are based upon the actual premiums due at December 31, 2024 but not paid by the Plan after year-end.

Expenses

The Plan pays administrative expenses that consist of administrative fees, accounting fees, and other miscellaneous expenses. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses. Certain other expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements.

Subsequent events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

3. INCOME TAXES:

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes, and is currently subject to income tax on its net investment income. The Trustee believes that the Trust does not have any net taxable income for the tax year ended December 31, 2024.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. PLAN TERMINATION:

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan’s participants.

5. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:

As noted in Note 1, the Plan has several arrangements with service providers. These transactions are party in interest transactions under ERISA.

6. RISKS AND UNCERTAINTIES:

Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
